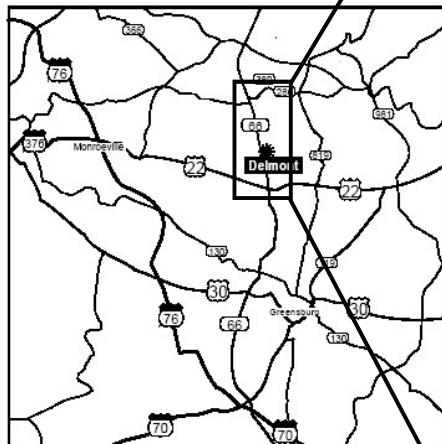
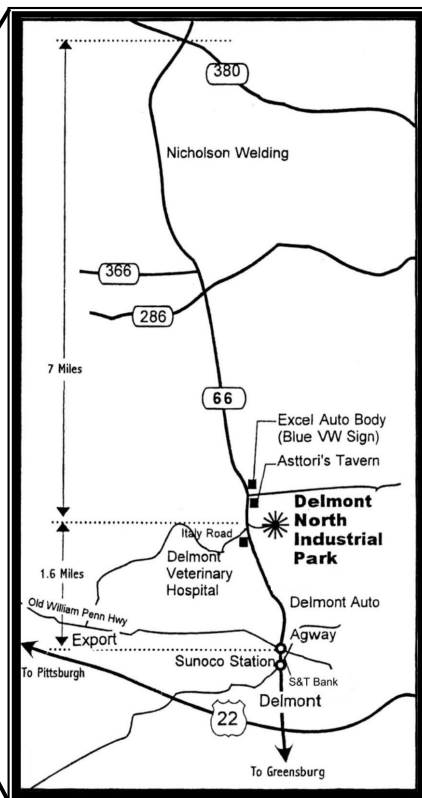


# Directions to Show Site

## From the West

Take PA Turnpike to Exit 57 (Monroeville.) After tollbooth take far right exit ramp toward Murrysville. Follow Route 22 East through Murrysville to intersection with Route 66 (10.4 miles.) Take Route 66 North ramp to Delmont.

## \*\*\*From the intersection of Rt. 22 and Rt. 66:

Continue north on Route 66 (2.9 miles) through two traffic lights, past Delmont Auto Sales on the right and Valero Century RV Sales on the left. Just after you pass the Delmont Veterinary Hospital on the left, turn RIGHT into driveway for the Delmont North Industrial Park. Continue to the buildings at the top of the hill.

## From the South or East

Take the PA Turnpike or Interstate 70 to the New Stanton interchange. Follow PA Toll Road 66 North to intersection with Route 22 (13.8 miles). Pass under Route 22 and follow directions from \*\*\*above.

## From the North

Take Route 66 South. From the Route 380 intersection, continue 7 miles South. Past the blue VW sign for Excel Auto Body, turn left into Delmont North Industrial Park. Continue to the buildings at the top of the hill.

## Notice to Exhibitors

### AKC Temperament Test (ATT) Information

All breeds of dogs who are at least **1 year of age** are eligible to take the ATT and must either be AKC or FSS registered or listed with Canine Partners or have a Purebred Alternative Listing number. Dogs that are spayed or neutered may participate. Dogs must be able to perform whole categories of the test (such as hearing auditory stimuli and seeing visual stimuli), in order to be eligible to earn an ATT title. More information on the ATT test can be found at <https://www.akc.org/akctemptest/>

- The ATT is a noncompetitive pass-fail test.
- In a test, a dog must pass 3 test items in each of the six categories (total of 18 test items).
- All dogs who pass the ATT twice under two different approved ATT Evaluators may earn the AKC Temperament Test (ATT) Title.
- Breed Temperament Information: handlers will complete the form labeled, "Your Breed's Temperament." The form includes a space for the handlers of mixed breed dogs to write about the temperament of their individual dogs. Clubs are required have copies of the Breed Temperament Guide available on the registration table.
- Collars, Leashes: Dogs may wear slip collars that are on the dead ring, buckle collars, martingales and body harnesses in the ATT. They may not wear prong collars, head collars, ecollars, or harnesses that restrict the movement of the dog. Leashes should be 4ft. to 6ft. long and should be made of fabric or leather.
- Excusals: The evaluator should excuse dogs from the ring immediately if they show any signs of aggression or soil the ring (urinate or defecate). Handlers may be dismissed for excessively talking to the dog, refusal to follow the evaluator's instructions, or for making corrections. The evaluator may discontinue testing if he/she determines the dog is too fearful or under duress to complete the testing.
- The dog owner must submit the ATT title application, the two evaluator Score Sheets from each passing test, and the \$25 title processing fee to receive the ATT title added to their pedigree.

**Post-Dated Checks and Returned checks** do not constitute a valid entry fee. WCOTC will add a collection fee of \$25 to the amount of each returned check.

**No Refund for Duplicate Entries.** Every effort will be made to find duplicate entries; however, if the entry has been processed, no refund will be made.

**Declination of Entries.** No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Westmoreland County Obedience Training Club may decline any entries and may remove any dog because of disease, viciousness, or other cause, and no one shall have any claim against WCOTC or any official thereof.

**Entry Fees Shall Not be Refunded** in the event a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the show committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entries will be made.

**Errors on Entry Blanks.** Owners are responsible for errors in the filling out of entry forms. Corrections cannot be made after the closing date. Please be certain that you fill in the right class and have the correct jump height on your entries. No entry and no entry fee will be refunded in event of such errors, or for cancellation of entries after the published closing date. Please type or print carefully on entry forms to eliminate errors.

**Bitches in Season** will not be admitted to the Trial. Any exhibitor with an entered bitch in season on the Trial date will be refunded the entry fee
