Fees: An application fee of \$50 is required with the submission of this form. New vendors must pay with money order or cashier's check	<mark>κ.</mark> If your application is

<u>Public Health & Safety Requirements:</u> Masks may be required by both vendors and attendees. We may be required to limit the number of attendees permitted in the venue at one time. We may need to conduct temperature screenings of vendors, attendees & staff. Since we are unsure of these requirements at the time this document was created and posted, we will notify all approved vendors of said requirements as soon as we are aware of what they will be when the event takes place. By submitting an application, vendors and anyone working the event from your business, agree to abide by the requirements or give notice to producers that they wish to forfeit their application. Fees will be returned so long as notification is received in writing (mail or email) by producers no later than 30 days prior to the event's opening day.

<u>Business Hours:</u> Vendors are required to be open for business Friday and Saturday. VIP Hours of operation are Friday 1pm- 9pm, Saturday 10am – 8pm with a VIP opening evening buffet from 6pm – 9pm on Friday night, and Sunday from 10am – 5pm. Vendors are not permitted to begin take down until all patrons have left on Saturday night. Any vendor breaking down early forfeits all fees as well as all future privileges of vending at the event.

<u>The VIP Experience</u>: This is an event that takes place on Friday night of the event. Offered as a VIP experience for attendees and sponsors, the details are to be determined at a later date due to possible COVID-19 restrictions. Only certain spaces are available to be able to stay open for the VIP Experience, there is an extra charge for these "premium" spaces. All other vendor may be required to move their set up to accommodate tables for seating. Spaces will be assigned on a first-come, first-reserved basis. Vendor fees must be paid in full to be considered for these spaces.
