MONTHLY REPORT -June 2020

Supervisor Hall and Members of the Town Board,

I hereby submit the June 2020 Monthly report of activities for the Town of Cohocton Police Department.

1. The department numbers for last month are attached as addendums;
Calls for service Attachment 1
Yearly stats to date Attachment 2

2. The Police department has been actively participating in DWI enforcement sponsored by the Steuben County Sheriff's Office. To Date this agency has made 4 arrest and has been reimbursed approximately \$1600.00 for wages and expense. The Officers continue to be observant to find these types of violators.

3. One of the nightly duties of this Agency is to periodically check windmills. During one of the checks, this agency did locate a trespasser at a windmill on pine hill who was involved in drug activity. During the investigation the Suspect was wanted by State Police out of Canandaigua for a violent crime. Wayland PD was dispatched to the scene to assist for they were the closest Agency that was available. This individual was taken into custody and transported to Naples to turn over to State Police out of Canandaigua office.

4. During one of the DWI Arrest, the operator of the vehicle was being placed into custody by the Officer, when the suspect became very combative. The officer was in a physical confrontation with this person for approximately 20 minutes alongside the roadway attempting to put handcuffs on the individual. The officer was able to push his emergency assist button which alerted 911, in which they sent nearest back up which came from Bath. NYSP arrived on scene and assisted in gaining control of suspect. These Officers do a tremendous job for this agency to protect the residents and property.

5. As Always stay safe, the offer is always there for our Board members or Public to do a ride-a-long to experience what the job entails.

Consultations Held

This office has issued 20 Building Permits thus far this year.

This office has received 11 complaints thus far this year.

Appearance ticket has been issued for the property located at 4249 Wayland St. for not complying with notice to cut the weeds and the grass.

I have yet to hear back from the engineer that did the evaluation of the roof at the Town of Cohocton Offices, we are in hopes that there will be a cost effective solution to the problem with the building.

I will be bringing in 8 Beecher St. for not maintaining the exterior property areas including debris and weeds and grass not being maintained. This property has been an issue for many years with nothing done only when he receives violation notices.

This office is having some issues with building permits and potential building projects. This office will NO longer accept incomplete application or applications with proper documents missing such as drawing, insurances, and inspection list secured. No building project that requires a building permit will be able to start until that actual building permit secured by the applicant. Any and all building projects that start before permit issued will be issued a STOP WORK ORDER and the fee will be DOUBLED. This office has received a building permit from abundant solar project on Moore Rd. they completed a Village Permit, I have reached out to them in regards to their mistake and I am awaiting new application at this time. With attached fee that applies.

13 West Ave. still is a problem for some neighbors, I will be reaching out to the property owner in hopes he will do the right thing, if not I will issue him an appearance ticket as the owner of the location and the ongoing problems that exist there.
