

ARTICLE IX, Section 1 - ADMENDMENTS

The Bylaws may be amended at any International Association Legions of Honor Convention by a twothirds (2/3) vote of those present and entitled to vote and voting at such meeting. All amendments, changes, etc. will have been submitted in writing by a Legion of Honor Unit member – in good standing – (signed by the current Unit Commander and Adjutant) or by a current International Association Legions of Honor Officer (signed by the International Commander and International Adjutant) to the International Commander and International Adjutant at least three (3) months prior to the Annual Convention. All submitted proposed amendments will be published in the International Association Legions of Honor Newsletter as well as the International Association Legions of Honor website which will suffice as final notification to all International Association Legions of Honor Units. At his discretion the International Commander may direct the By-Laws Committee Chair to review and make changes as necessary to the By-laws to ensure they are in compliance with the Shriners International By-Laws and the functionality of the International Association Legions of Honor practices. The changes will be submitted for approval according to the instructions in Article IX, Section 1.

The Bylaws may be amended at any International Association Legions of Honor Convention by a twothirds (2/3) vote of those present and entitled to vote and voting at such meeting. All amendments, changes, etc. will have been submitted in writing by a member Legion of Honor Unit – in good standing – (signed by the current Commander and Adjutant) to the International Commander and International Adjutant at three (3) months prior to the International Association Legions of Honor Convention, and will have been submitted to all Member Units by the International Adjutant at least one (1) month prior to the Annual Convention. All proposed amendments submitted by Member Units will be published in the International Association Legions of Honor Newsletter and will suffice as final notification to all

Purpose: Change description of duties of 1st Lt. Commander, International Association Legions of Honor

Current By-Law Reads:

In the event of death, disability or absence from any meeting of the International Commander, the First International Lieutenant Commander will assume and perform the duties of a deceased or disabled International Commander as the "Acting Commander"; except that the planning for holding of the International Association Legions of Honor Annual Convention will become the primary responsibility and duty of the International Chief of Staff, coordinating all such plans with the "Acting International Commander". By the assumption or performance of such duties, the International Lieutenant will not vacate his Elective Office, but will perform such duties in addition to his regular duties and will not, thereby, become entitled to be known as "Past Commander". It will be the responsibility of the International Board of Directors to contract and make all arrangements for the ensuing Annual Convention (in case of the International Commanders demise) should the International Chief of Staff be unable to perform as directed.

Change to Read:

In the event of disability or absence from any meeting of the International Association Legions of Honor by the International Commander, the 1st International Lieutenant Commander will assume and perform the duties of said disabled or absence of International Commander as the "Acting Commander" until such time that the International Commander can resume his responsibilities or until the next scheduled Election/Installation. Should the time of absence extend to the Annual Convention, the "Acting Commander" will be allowed to be nominated and/or elected as International Commander for the upcoming year.

Change 3 - Change 1st LT Cmdr. duty Description - Continued

In the event of death or resignation of the International Commander, the 1st International Commander will automatically be promoted to the position of International Commander by a vote of the International Associations Legions of Honor Board of Directors. This vote will take place as soon as possible after said demise or resignation of the International Commander. With the assumption of such duties, the 1st International Lieutenant Commander will vacate his elective Office, and will immediately appoint a Past International Commander as his replacement to assume the duties of the 1st International Lieutenant Commander position for the ensuing year, provided that he has not been able to serve a full term, (12 months), as International Commander. In conjunction, the newly appointed International Commander. In conjunction, the newly appointed International Commander.

Should the resignation of the International Commander come at the end of his full term and such circumstances are that an Annual Convention cannot be held. The International Associations Legions of Honor Board of Directors, shall hold elections, as soon as possible, either by mail or electronically to advance the current International Lieutenant Commanders to their next higher position and the election of newly nominated Lieutenant Candidate(s).

It will be the primary responsibility of the International Chief of Staff of the outgoing International Commander for the planning and holding of the International Association Legions of Honor Annual Convention, coordinating such plans with the Incoming International Commander. Should the International Chief of Staff be unable to perform the duties as directed, It will be the responsibility of the International Association Legions of Honor Board of Directors to contract and make all arrangements for the ensuing Annual Convention (in case of the International Commanders demise) or should the International Chief of Staff be unable to perform the duties as directed.



Change 4 - Change Board of Directors Voting Process



Reference:

International Association Legions of Honor By-Laws Preamble: The Articles of Incorporation and Bylaws of Shriners International, an Iowa Corporation, and these Bylaws, to the extent they are not inconsistent with the Shriners International Bylaws, govern this Association.

Current By-Law Reads:

The Officers named in Article IV, Section 1, all past and current International Commanders will have a vote in all matters before the Board. The Board of Directors is the governing body of the International Association Legions of Honor when the membership is not in session and will meet at the Arlington Wreath Laying, the Annual Convention, upon the call of the International Commander when necessary and prudent and upon the request of five (5) members of the Board of Directors. The Board will meet for the purpose of, but not limited to, recommending policy to the International Commander and will approve a Budget for the ensuing year at the Arlington Meeting in November. Only members of the Board will be admitted to any meeting of the Board, except that the Board may invite others to attend. Members will be notified of any called meetings for the Board by the International Adjutant's Office at least thirty (30) days prior to the scheduled meeting.

Change to Read:

The Officers named in Article IV, Section 1, and the Junior Past International Commander, will have a vote in all matters before the Board. Past International Commanders (with the exception of the Junior Past International Commander), will serve as non-voting advisory members to the Board of Directors. A Past International Commander shall have a vote if he is holding a position of a vacated or unfilled position of an International Ueutenant Commander. The Board of Directors is the governing body of the International Association Legions of Honor when the membership is not in session and will meet at the Arlington Wreath Laying, the Annual Convention, upon the call of the Commander when necessary and prudent, and upon the request of six (6) members of the Board of Directors. The Board will meet for the purpose of, but not limited to, recommending policy to the International Commander and will approve a Budget for the ensuing year at the Arlington Meeting.

Only members of the Board will be admitted to any meeting of the Board, except that the Board may invite others to attend. Past International Commanders are entitled and encouraged to attend a Board of Directors Meeting in a non-voting advisory capacity. Members will be notified of any and all called meetings of the Board by the International Adjutant's Office at least thirty (30) days prior to the scheduled meeting.

Procedure: The list of candidates will be presented to the board by the 8th Lt Commander. If there is a discussion concerning and individual candidate, and that individual's nomination is rejected by a unanimous vote by the board, his name should be removed from the list. If the Lt Commander bring the nomination has a second candidate, that candidate should be presented and if the board approves, he can be added to the list. Once discussion is completed, the candidates on the list can be approved as a group. Other Awards or Emblems for presentation will be the responsibility of the 8th Lt Commander.

Change to Read:

Procedure: The list of candidates will be presented to the Board of Directors by the 8th Lt Commander. If there is a discussion concerning and individual candidate, and that individual's nomination is rejected by a majority vote by the Board, his name should be removed from the list. If the Lt Commander who presented the nomination has a second candidate, that candidate should be presented at that time ONLY and if the Board approves, he can be added to the list. Once discussion is completed, the candidates on the list can be approved as a group. Other Awards or Emblems for presentation will be the responsibility of the 8th International Lieutenant Commander.

The newly elected officers will be sworn in immediately at the conclusion of the election.


Change to Read:

The Officers of the International Association Legions of Honor will be elected and installed at the International Association Legions of Honor Annual Convention each year. If an Annual Convention cannot be held, the International Association Legions of Honor Commander will call a special electronic meeting, with at least a 45day notice to all Legion of Honor Units in good standing that have submitted their Annual dues and delegates for the current year. Units that have not submitted an Annual Report by deadline prescribed by Article VIII, Section 2 on March 1⁴, will forfeit their right to vote. Such Officers will perform the duties allotted to them until their successors are duly elected and installed. The newly elected officers will be sworn in immediately at the conclusion of the election.

Currently Reads

Article IV, Section 2, (C), Para: (4)

The International Adjutant will send a registered letter to the Commander or Adjutant of any Unit that should remain delinquent in their International Dues beyond March 1st informing the Commander or Adjutant that his Unit is suspended from active membership in the International Association Legions of Honor. The letter will further state that if said dues are paid and received by the International Adjutant within fourteen (14) days from the date of the notification, their Unit will be fully reinstated; otherwise, their Unit will remain suspended, and the Unit Commander will within seven (7) days return their International Charter. The letter will also be copied to the Potentate of said Temple. Should the Unit later wish to be reinstated, the fee for same will be \$100.00. Reinstatement of any Unit must be handled through their Division International Lieutenant Commander.

Change To Read

Article IV, Section 2, (C), Para: (4)

The International Adjutant will send a registered letter to the Commander or Adjutant of any Unit that should remain delinquent in their International Dues beyond March 1st informing the Commander or Adjutant that his Unit is suspended from active membership in the International Association Legions of Honor. The letter will further state that if said dues are paid and received by the International Adjutant within fourteen (14) days from the date of the notification, their Unit will be fully reinstated; otherwise, their Unit will remain suspended, and the Unit Commander will within seven (7) days return their International Charter. The letter will also be copied to the Potentate of said Temple.

ARTICLE VIII

Section 1. **DUES:** The Annual Dues for member units of this Association will be due and payable on 01 January of each year in the amount of two dollars (\$2.00 US) per unit member, based on membership totals as of 31 December of the preceding year, with a minimum payable of \$30.00 per unit. Associate member's dues will be \$30.00. The only exception to the aforementioned dues will be those holding Honorary Memberships within a unit. Honorary members do not pay dues. Said revenues will be placed in the IALOH general fund.

Section 2. SUSPENSION: Failure to pay the Annual Dues, by any Unit, by March 1st will cause such Unit or Units to be suspended from the International Association Legions of Honor. Any Unit failing to comply with this Section will surrender their Charter automatically to the International Adjutant on or before March 21st. To be reinstated, a Unit must pay a \$100.00 reinstatement fee. (Refer to ARTICLE IV, Section 2, (C), fourth paragraph).

Change 9 - Modify the Unit Reinstatement Process - Continued

Change to Read

ARTICLE VIII

Section 1. **DUES:** The Annual Dues for member units of this Association will be due and payable on 01 January of each year in the amount of two dollars (\$2.00 US) per unit member, based on membership totals as of 31 December of the preceding year, with a minimum payable of \$30.00 per unit. Associate member's dues will be \$30.00. The only exception to the aforementioned dues will be those holding Honorary Memberships within a unit. Honorary members do not pay dues. Said revenues will be placed in the IALOH general fund. Dues will be payable in US dollars made out to the "IALOH".

Section 2. SUSPENSION: Failure to pay the Annual Dues, by any Unit, by March 1st will cause such Unit or Units to be suspended from the International Association Legions of Honor. Any Unit failing to comply with this Section will surrender their Charter automatically to the International Adjutant on or before March 21st.

Section 3. **REINSTATMENT:** If a suspended Unit wants to be reinstated, the Unit must submit a Reinstatement Application with the following items:

- (A) Unit dues according to Article VIII Section 1 and a \$100.00 reinstatement fee.
- (B) Certification by the Unit Commander that all members meet the eligibility requirements according to Article II, Section 1, (A), of the International Association Legions of Honor Bylaws.
- (C) The application signed by the Unit's Illustrious Potentate authorizing the reinstatement.
- (D)A copy of the Unit's approved and signed Bylaws.
- (E) A list of Officers (with titles) and members with address, phone and email contact information, etc.
- (F) All documents, monies, etc. that are required will be forwarded to the Division International Lieutenant Commander responsible for the Unit. The Division International Lieutenant Commander will review the reinstatement documents and forward to the International Adjutant for processing. The reinstatement will not be authorized until all required documents and monies are received by the International Adjutant. The International Adjutant will reissue the Units Charter once all requirements are met.


ARTICLE IV, Section 1, (A), (3)

(1) Written approval, from the Potentate of his Temple and his Unit, along with his proof of military service (as required by Article II. Section 1) is in the possession of the International Commander and International Adjutant sixty(60) days prior to the first day of the International Association Legions of Honor Annual Convention. This provision, however, does not apply to current International Lieutenant Commanders seeking election to the next higher office and the International Adjutant and International Finance Officer who are seeking re-election.

Change to Read

(1) A Unit member will submit an International Officer Application, approved by his Temple Potentate and Unit Commander, along with his proof of military service (as required by Article II. Section 1) which must be in the possession of the International Commander and International Adjutant at least sixty (60) days prior to the first day of the International Association Legions of Honor Annual Convention. This provision, however, does not apply to current International Lieutenant Commanders seeking election to the next higher office and the International Adjutant and International Finance Officer who are seeking re-election. The member may attach their history, letters of endorsements and a picture to the application.

Section 3. ELIGIBILITY: Legion of Honor Units, fulfilling the following conditions, may make application for membership to the International Association Legions of Honor.

(A) Must have an active roster consisting of a Commander, Adjutant and Finance Officer or Commander and combined office of Adjutant/Finance Officer, each of whom has met the standards as set forth in Article II, Section 1, Subsection (A).

- (B) The application must be fully answered, and accompanied by all of the following:
 - (1) Dues for one year (payable in U.S. Dollars), (Refer to ARTICLE VIII, Section 1);
 - (2) A letter signed by the Illustrious Potentate giving his approval to the organization of the Unit in his Temple; Commander and copies of each member's papers of eligibility, ic, Form DD214 Honorable Discharge, etc. as described in Article II, Section 1, Subsection (A);
 - (3) A list of names and addresses of Officers and Members signed by the Commander;
 - (4) A copy of the Unit Bylaws;
 - (5) The application must be signed by two (2) Legion of Honor members in good standing with their Unit and the Unit in good standing with the International Association Legions of Honor;
 - (6) An Annual Report form, completely filled in, with all the Officer's names, addresses, (to include ZIP Code Number), telephone numbers, email address, etc.;
 - (7) All reports, papers, monies, etc. that are required will be forwarded to the International Adjutant by the International Officer responsible for Chartering the Unit. A Charter will not be issued to a new Unit until all of the required paper work and monies are received by the International Adjutant or the Chartering International Lieutenant Commander, who will forward same to the International Adjutant.

Change to Read

Section 3. **ELIGIBILITY:** Legion of Honor Units, fulfilling the following conditions, may make application for membership to the International Association Legions of Honor.

- (A) Must have an active roster consisting of a Commander, Adjutant and Finance Officer or Commander and combined office of Adjutant/Finance Officer, each of whom has met the standards as set forth in Article II, Section 1, Subsection (A).
- (B) The Membership Application must be fully answered, and accompanied by all of the following:
 - (1) Dues for one year (payable in U.S. Dollars), (Refer to ARTICLE VIII, Section 1).
 - (2) The application signed by the Units Illustrious Potentate giving his approval to the organization of the Unit in his Temple.
 - (3) Copies of each member's papers of eligibility, i.e., Form DD214 Honorable Discharge, etc. as described in Article II, Section 1, Subsection (A).
 - (4) A list of all the Officers (with their titles) and Unit members names, addresses, (to include ZIP Code Number), telephone numbers, email address, etc.
 - (5) A copy of the Unit's approved and signed Bylaws.
 - (6) The application signed by the Unit Commander and Adjutant and they must be in good standing with their Unit.
- (C) All documents, monies, etc. that are required will be forwarded to the International Officer responsible for Chartering the Unit who will in turn forward to the International Adjutant. A Charter will not be issued to a new Unit until all of the required paper work and monies are received by the International Adjutant.
