Rocky Ripple Town Council Updates/ Flood Protection Status

Memorandum of Understanding Signed with City and Butler for River Levee Repair

As noted on the town's website and in the Indianapolis Star, a Memorandum of Understanding (MOU) was signed by the RR Town Council, Butler University, and the City of Indianapolis to provide flood protection for Rocky Ripple. The MOU was signed by Rocky Ripple Town Council President Carla Gaff-Clark and Butler University Vice President Bruce Arick at the March RR Town Council meeting on 14-Mar-2017. The signed MOU can be viewed in its entirety on the town website (www.rockyripple.com).

The MOU provides that the City of Indianapolis will provide \$10 million in assistance over the next 4 years toward the upgrade of the levee. What exactly will be done will be decided upon by the Town Council after consultation with town residents. In addition, the MOU specifies that Butler University will financially contribute to the project if a FEMA certified levee is pursued.

Potential options for flood protection that need to be decided upon in order to move forward with the MOU agreement include construction of a FEMA certified 100-year flood wall, construction of a flood wall that is not certified, or improvements to the current levee without construction of a wall. The town council has also been working with the city to have renderings drawn up of what Rocky Ripple will look like, depending on the option pursued. You may have noticed a drone hovering along areas of the river to take photos on which the renderings will be based during the week of March 13th.



The town council is planning a dedicated meeting for residents and other interested parties to view the renderings and ask questions about the various options. This will be scheduled as soon as the renderings are available and is anticipated to occur yet in April or at the latest in early May.

An assessment survey for residents and home owners will be provided at the meeting and delivered to each residence for completion. The survey asks for the resident to provide his/her viewpoints on what should be done for flood protection. The Town Council will then work to ensure that a completed survey is obtained from each residence/home owner in Rocky Ripple. The completed surveys will be utilized by the Town Council to determine which option will be pursued for flood protection.

Notice of the meeting, when scheduled, will be made available in hard copy form to residents, as well as by email and social media.

As a reminder, it is the Town Council's position first and foremost that the biggest danger to our town is the deteriorated condition of the current levee along the river.

The recent independent analysis of the levee by a New Jersey Engineering Firm (AECOM) stated that "The existing Rocky Ripple levee is in a seriously deteriorated condition. The analysis indicates that the levee currently has a 5% or greater annual chance of overtopping (20 year level of protection) and the levee is likely to be exceeded more than once over the 50 year period of analysis."

Riverbank Stabilization Repairs Completed on Levee North of Town Hall

Rocky Ripple's most risky issue with regard to the river and flooding is if a breach happens to the current levee. During November 2016 a first step project was completed along eight properties on Ripple Road. This work was done on the town's portion of the levee. It helped stabilize the existing earthen levee by taking down dead, dying and hollow trees that could easily cause large root-balls to pull soil out of the levee if they fell during high waters or a wind storm. The second step of this project was completed in March, and included the removal of 7 additional trees along the levee.

Update on Pursuing of Additional Funding for Flood Protection

Members of the Town Council are continuing work with state legislators to secure additional funding for flood protection along the river. News is forthcoming from representatives Greg Porter and Ed Delaney on results from finalization of state budgeting.

Rocky Ripple Community Association Board Elections on May 16th; Secretary and Treasurer Offices to be Voted Upon

The Rocky Ripple Community Association (RRCA) annual elections will be held at the May Community Association meeting on Tuesday May 16th. RRCA terms of office for the association's board of directors are staggered three year terms. The offices that will be elected this year are Secretary and Treasurer.

Any member of the community can run for RRCA office. However, to vote for RRCA board member candidates, you must be a member of the community association. To be a member, you must have attended at least one community association meeting during the past year.

The May RRCA meeting is also the time when current association bylaws will be reviewed and changed, as voted upon by the officers. Suggested changes to the bylaws must be submitted in writing for review 30 days in advance of the meeting to the secretary of the association. Don't forget....RRCA is not the same as the Town Council

The community association should not be confused with the Rocky Ripple Town Council, which is comprised of Rocky Ripple's elected representatives.

The Rocky Ripple Community Association is a separate organization whose mission is to provide social, cultural, recreational, and educational services to the Town of Rocky Ripple and its residents, and in so doing strengthen the bonds of civic unity and provide for the common welfare of all residents.

The RRCA has been in existence since November 12, 1948 when the Ladies Auxiliary of the Rocky Ripple Volunteer Fire Department was formed. Through the next four decades, the Ladies Auxiliary raised money to fund the volunteer fire department as well as provide social events for the residents of Rocky Ripple.

With the dissolution of the Volunteer Fire Department in 1989, the Ladies Auxiliary adopted new bylaws on February 6, 1990 and renamed the organization the Rocky Ripple Community Association. In March of 1998, the Community Association incorporated and became a Not For Profit organization in order to apply for grants, increase revenues and thus be able to provide additional support to our community.
