2020-2021 BAY HILLS HOA BOARD ELECTION RESULTS

By-Laws require a quorum of 15% of paid owner members to transact Annual Meeting business. 88 owner dues payments (83 with ballots) came in postmarked on or before October 26, 2020. For the vote-by-mail quorum, 15% of paid owner members was 13. 79 ballots were valid (with votes indicated and name). 4 ballots had no name. 4 valid ballots with names had votes for some nominees but not others. 75 valid ballots approved the full slate, which was 85% of paid owner members by deadline. 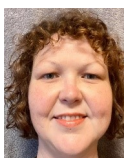

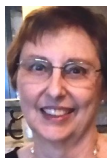

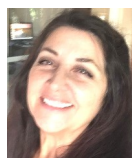
