Please read this form carefully as it contains important competition rules.

Regulation: Section One

1. We agree to be represented by the person whose name appears on this application and signed in the application.
2. We understand that the SEA Games USA reserves the right to reject any application/registration at its sole discretion.
3. We understand that our application/registration is subject to approval by the SEA Games USA and/or their appointed competition officials; and our application/registration is not valid until it is received and approved by the SEA Games USA.
4. We give permission to the SEA Games USA to release our bios, photos, and videos of our performances before, during, and after the competition in any marketing and promotional manner.
5. We understand and assume all risk of injuries arising from the intense competition; and we further agree to assume all liabilities arising from our participation in the competition. We agree not to hold the SEA Games USA liable for any injury, loss of property, or damage due to our participation in this competition.
6. We understand that the SEA Games USA requires all teams to wear appropriate uniforms and may require identification of all competitors, and we agree to supply valid identification for all of our teammates.
7. We understand and agree that the SEA Games USA has a strict "no weapons and drugs" policy; no team member will bring or have in their possession, weapons and/or drugs of any kind while on the premises of the Gibson Ranch Park and/or during any of the competitions.
8. We understand and agree that any violation of these terms and conditions by any member of our team will result in appropriate actions being taken against our team including but not limited to; disqualification and/or expulsion of our team from the competitions and/or the Gibson Ranch Park.

Regulation: Section Two

1. We understand that all performing competitions held by the SEA Games USA have a non-refundable \$100 application fee.
2. We further understand and agree that the SEA Games USA has the right to change or cancel any competition at its sole discretion.
3. We understand and agree that the stated prizes will only be awarded if all conditions set by the SEA Games USA have been met.

Regulation: Section Three

1. We agree to observe and follow all rules and regulations set by the SEA Games USA, its judges, referees, and other appointed officials.
2. We agree to respect all competitors, judges, SEA Games USA officials, and fans as well as property belonging to other people.
3. We agree to refrain from all inappropriate behavior including but not limited to: the use of profanity and/or other offensive/threatening language and gestures.
4. We understand that only registered teammates may participate in this competition; any unregistered replacements are not allowed.

Regulation: Section Four

1. We understand and agree that any teammates involved in any form of fighting or physical dispute, regardless of the cause, shall result in an automatic suspension of those teammates for the remainder of the competition; additionally they may be asked to leave the Gibson Ranch Park and be barred from participating in future competitions.
2. We understand and agree that any fights involving two or more of our teammates, regardless of the cause, will result in an automatic disqualification of our team from this competition.
3. We understand and agree that any family members or friends of a teammate engaging in fights with any opposing team members shall be reported and arrested by the appropriate authorities.
4. We understand and agree that any fighting resulting in personal injury and/or property damages shall be reported to the appropriate authority; criminal and civil penalties may be imposed.

Regulation: Section five

1. We understand and agree to be on time for our scheduled competition. If we are late fifteen minutes or more without prior notice, our team may be disqualified from the competition or forfeit that round; if the competition schedule permits, our team will have a chance to perform another round.
2. We understand and agree to respect and follow the decisions of the judges and/or referees. We further understand that the judges and/or referees' decisions are final and cannot be appealed.
