Hi Concerned Resident,

I see that you have already picked up on the FAA's game plan...they only talk about the positives, they focus on things like efficiency and cost-effectiveness both of which benefit the industry at the expense of the public, they present as little information as possible in the most technical terms possible, and they never, ever, contact people effected to explain the impact.

There is very little information about the flight paths and I don't expect to hear any more details on Wednesday. Here's the condensed explanation. In 2011 the FAA redesigned the "metroplex" (the airspace around Denver involving DIA and the general aviation airports). The result of that redesign put CHV underneath arrival paths and departure paths for both DIA and Centennial. Unfortunately that is done and there is little we can do do change it. Now they are proposing additional changes. Most of them are fairly minor. The biggest one, and the one which might impact us the most, is that they want to eliminate an arrival track into Centennial that current goes over DIA and arrives from the north east. All traffic arriving from the north east will have to use either other existing routes (some of which are over CHV) or a new proposed route which would take them north to Ft. Collins and then down the front rage to a point near Golden. At that point they would cut east to Centennial. This is one major area of frustration because the FAA will not say how the planes will get from Golden to Centennial. Assuming they take the most direct route, they will be over CHV. So planes that were arriving from the north east and not flying over our community now will be, in addition to all the planes we already have.

Furthermore, while they don't mention it, the elimination of the north east arrival into Centennial frees up DEN airspace to accommodate more traffic. As you have all recognized, by adding runways and gates this problem could quickly escalate.

On Wednesday they will talk about SIDS and STARS - standard instrument departures and standard instrument arrivals. What you see on the maps on their site are the SID and STAR points, but you don't see how they get from those points to the airports and at what altitudes. We have been pressuring them for that information - let's keep the pressure on.

We have never had silent protest signs at our meetings, but I wouldn't have a problem with that. I'll verify with the Roundtable chair as well.
