Risk Reduction Course Information:

The class includes 20 hours of alcohol and drug abuse education as required by Georgia Law. The curriculum is Prime for Life ® from Prevention Research Institute and is the only approved program allowed by Georgia law. The program assists clients to better understand alcoholism and drug addiction as a lifestyle related health problem and how to manage their risk of future problems.

The fees for the course are mandated by law and may not be changed:

- **Assessment fee:** \$ 100.00
- **Course fee:** \$ ~~255.00~~
- **TOTAL:** \$ 355.00

Payment of all required fees must be made **before** services can be rendered. The assessment must be completed **prior** to beginning the class. Assessment results are provided during class. All information you provide is confidential.

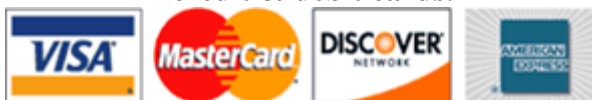
Clinical Evaluations:

Anyone convicted of two or more alcohol or drug offenses in five years will be required by the D.D.S. to complete an alcohol and drug abuse evaluation (sometimes called a clinical referral); which can only be done by a state approved clinical evaluator. We will provide you with a list of approved evaluators and can make arrangements for your evaluation at the location of your choice, including all of our offices. These are done by appointment only.

Level I Treatment:

Multiple offenders may be required to complete an addiction treatment program. We provide Level I (outpatient) treatment at each of our offices.

We accept cash, checks, money orders, and credit & debit cards.



Defensive Driving Course:

Traffic offenses that do **not** involve alcohol or drugs including reduction of points will require a Defensive Driving certificate. Please contact our office for a schedule if you need this course. **This course is ONLY offered in our Dublin location.**
