The Mid-East Crisis

Without question a large portion of the American people, if not the majority, is wondering why the United States is again meddling in the affairs of a foreign conflict. Further, it appears that the United States will have to support Kuwait's position with only token support from the so-called Allied forces of Europe. The other nations of the world seem to have the diplomatic acuity and statesmanship to leave the Arab states alone in their internal strifes. These people have always been at war with each other at the slightest provocation and our people would be blessed if Washington would heed what the Word of God says. *"He shall be a wild-ass of a man, his hand against everone, and everone's hand against him, defying all his kinsmen."* (Gen. 16:12 Moffatt translation)

This is not to say that we should not have anything to do with them. Quite the contrary. Their part in the great conflict that is just ahead of us will be monumental and they will be on our side of the issue. After all, some of them are our "uncles" because they are from the other sons of Shem. Some are our "half-brothers" from Ishmael. There is a great purpose for Ishmael. God didn't waste his time telling us about Ishmael just to fill space in the Bible. There is much more to him than just to teach us, as the Judeo-Christian churches do, that the story of Ishmael was to show that Abraham and Sara didn't have enough faith. But it is sufficient to say that we should leave them alone in their internal strifes. After all, we have internal strifes also and we do not appreciate anyone else jumping in and acting as referee or policeman.

The accepted reason for the United States preparing to invade Iraq and installing an economic blockade around that country is the invasion of Kuwait by the Iraqi armed forces. The average American person suspects that the invasion of Kuwait is not the real reason and they are correct in their suspicion.

There are several reasons for the United States' military position in the Mideast and one them is the "Balance of Power" concept. This is the technique the International Money Barons use to protect their banking interests. Many years ago when the money barons loaned money only to individuals they were able to control the borrower by confiscating his property, or collateral, if he defaulted. When the money barons became powerful enough to start loaning money to sovereign nations, another method had to be devised to control the borrower because they could not personally "invade" the country to retrieve their money. Their solution was to loan money to several, or all, countries with the stipulation that the International Money Barons could call upon one nation to attack another nation in the event of a default in the loan or any other situation where their banking interests were in jeopardy.

The United States of America was once the richest, most powerful nation upon the earth. The majority of its citizens were solvent and the "great American dream" of owning their own home was being realized. Now, we are in shambles. Once proud and economically solvent middle class citizens are sleeping in automobiles and on the grates of our large

cities. The country is the largest debtor nation in the world to these filthy, damnable maggots called the International Money Barons.

Thus, since we owe the most, we have to do the most to serve our masters. We now can see why the United States is the world's policeman. Why are we being the "policeman" in the Mideast in this matter? Because Saddam Hussein captured one of the richest banks in the world when he attacked Kuwait. The booty included 12.5 billion dollars worth of gold and other assests. The great "policeman" has to go over and teach this upstart Hussein a lesson that he can't mess with their banks.

Our boys, and now our girls, will be sacrificed on the tables of these money changers. Do you see why Jesus scourged them until the blood ran and then turned over their tables? The part that is the hardest to understand is why the American government, and yes, the majority of the American people, believe in and support this international banking system.

Every twenty-five to fifty years another major war is created to satisfy the needs of the money lending system. Why? Because there must be a means to assure a satisfactory growth in the Gross National Product (GNP). When money is loaned at usury (interest) the worth of the interest must be created. Say that there was only ten dollars worth of gold in the world and the owner of it loaned it to you with the stipulation that you pay back eleven dollars worth of gold. There is no possible way that this can be done. However, if you replace the gold with paper dollars, then the eleventh dollar in interest can be created by an increase in the work effort. That is the growth in the Gross National Product. The growth in the GNP goes to the International Banker. You can read all about this phenomena in the history of the world in Richard Hoskin's book *War Cycles-Peace Cycles*. The book can be obtained from Scriptures for America, P.O. When the growth in the GNP is not satisfactory to the money barons some small "brush fire" incident in the world is used to be fanned into a general conflict of sufficient intensity to bring the GNP in line with their needs. Wouldn't it be something if these evil, evil people declared one of their wars and nobody came? That would break the back of the money barons. This will happen some day. Why not now?

Who are these money barons? The Lesson In History in this issue will attempt to define them and to show that there has been a colossal battle between the two major groups of money lenders in the world. That battle is not yet over but is rapidly coming to a climax.

Why did Hussein attack Kuwait? He made a pre-emptive strike on Kuwait to totally annul the planned pre-emptive strike on Iraq by the Israelis. According to the statement made by a Mossad (the Israeli secret intelligence service) officer, the Jews had been planning and preparing for their own surprise strike on Iraqi airfields, missile sites and its chemical and nuclear facilities. United States intelligence had learned of the Israeli plans some months ago and was concerned that such a strike would cause serious problems in the Mideast. So when Hussein attacked Kuwait, the United States didn't object too much when the bankers directed us to have a conflict with Iraq because we saw it as the opportunity to seize the initiative in this volatile situation.

Israeli intelligence was likewise aware of Hussein's plan for a strike on Kuwait. Prime Minister Yitzhak Shamir offered to help by sending paratroopers into Saudi Arabia. After many secret discussions between Israel and the United States, the Bush administration gave the Zionists the ultimatum to "stay the hell out of the situation!" (the language is a quote and not mine.-ed.)

According to sources in the Arab world, Israel, as well as Europe, the United States is misreading Saddam Hussein of Iraq. Unless the United States gives Hussein a way out of this predicament, there is a tremendous risk of a major bloody war and the consensus is

that we do not have the capability to defeat Iraq on the ground in the Arabian desert. Our air power is vastly superior and we can destroy much of their country but unless the "queen of battle", the infantry, along with its artillery and tank support, actually take the ground, Iraq will not be defeated.

There are other points to be considered. Kuwait is basically of the same ethnic origin as Iraq. The Iraqis have tried to return Kuwait to its ethnic origin before. In 1967 and in 1981 there were attempts to seize the tiny country. They recognize that England seized the area from the Ottoman empire and made it a "protectorate" in 1914.

Hussein believes that Israel is simply a part of Western imperialism. He believes that the U.S. and the Western powers are supporting Israel's plans for expansion into Jordan. He believes that he is destined to lead the Arabs in a new victorious struggle over the imperialism of the West and particularly the Zionist imperialism.

By far the most serious implication in Bush's barging into Saudi Arabia in preparation for attacking Iraq is the unleashing of the long-awaited Islamic Jihad. It is suggested that you retrieve your November-December 1988 issue of the Intelligence Newsletter and re-read this very probable scenario. Up until now, the Arab world has been split in its political viewpoints. Some have been fundamental Islamics while some others have accepted the Baathist political belief of Arab Nationalist Socialism. Saddam Hussein is a follower of the Baathist politics. This action on the part of the United States has already drawn together these two groups into what can be called an Arab Pan-Nationalism. They are all Islamic and so it is a simple step to order the Jihad, or holy war, to commence. And all of this because the United States stuck its nose into a foreign affair that was none of its business.

Civil Disturbance In U.S.

Saddam Hussein publicly warned the United States that he would unleash a terror campaign in the United States if we didn't back out of the Mideast. It is believed that this effort is already underway.

Information has been received from several independent sources that there is a probability of a race riot or riots starting around the Labor Day weekend. Law enforcement agencies over a wide area have been alerted to this threat and they are preparing for it in a most serious way. They have issued new gas masks of a newer and more effective type which indicates that they expect some chemical gas to be used that their old type gas mask would not provide effective protection.

In some areas of the country, the police are now being given a large number of newly designed road signs. These signs are of high quality and of the same type as the current road signs showing curves, stops, caution, etc. The new signs are in different background colors of blue, green, etc. and simply show an arrow pointing straight ahead, left or right. The concensus is that these signs will be used to show detours around bridges and other road structures that would make the highway impassable if they were destroyed.

National Guard and Reserve units have been for sometime now receiving a large portion of their training in civil disturbance and riot control. On one occasion a young reservist stated that he had been issued the new style gas mask and that his training has been in

civil disturbance and riot control. When it was asked of him if he was being trained to fight against his own people, he stated simply, "yes." He then quickly added that he and his buddies didn't know whether they would be able to do it or not. These young men must know in their hearts that "blood is thicker than water."

Mexican Police In U.S.

A news release in the *Indianapolis Star*, 7/1/90, as read in the America Today magazine states that under a new agreement signed under the guise of stopping drugs, Mexican police will be allowed to operate in the United States as well as U.S. police in Mexico.

This is a totally untenable situation. Either we are a sovereign nation or we are not. Our people need to heed these types of warnings and it is predicted that there will be some dead Mexican police if this situation persists. There are many Americans in Texas, New Mexico, Arizona and California along the border that will not tolerate foreign nationals coming on their property and roughing them up.

There has already been incidents of this type of action. A rancher along the border in Southwest New Mexico was roughed up by Mexican police when they came across the border on to his own land and started to arrest him, all the while stating that they were looking for drugs. Apparently the rancher didn't have the intestinal fortitude, or whatever else, and stand up for his rights and defend his castle. He stated feebly something about not wanting to upset the fine relations with Mexico or violate the law. *"And I sought for a man among them, that should make up the hedge, and stand in the gap before me for the land, that I should not destroy it but I found none."* ([Ezk. 22:30](#))

Lesson In History Part 9

Because of the extraordinary importance of the Iraqi invasion of Kuwait and the impending dangers of a major war, we will jump ahead a little bit in the history of the World Revolutionary Movement (WRM). The American Revolution (as compared to our War for Independence) was but a part of the total World Revolutionary Movement. This has been pointed out in several of the previous lessons.

But there is a great battle taking place right now, the outcome of which will determine the destiny of European and American civilization as we know it. That battle has been raging for over a century but has gone on unnoticed because of certain tabus in the freedom of speech in the Western world. This great battle is depicted in the Word of God but only if we remove certain preconceived ideas taught us by the Judeo-Christian churches. For right now, we will simply say that it is the *"time of Jacob's troubles"* as found in [Jer. 30:7](#).

Students of history have known of this conflict and major change taking place in our society but, because of these great unspoken tabus, they would not teach of it in our colleges and universities. They could not discuss it in the political world of government. They would not discuss it in our churches. They recognized the inordinate, excessive and unrestrained power that these conspirators in this conflict possessed. To them, there was an unacceptable risk to their careers, their possessions and their very life and so they would not speak out.

As we now know, Manasseh Ben Israel and his colleagues made an agreement with Oliver Cromwell to provide the money if England would provide the nobility and manpower to form the great British Empire which was to rule the world. The world's system of colonial

rule was originated by that agreement there in England in the middle 1600's. Other nations followed the lead that was originated there in England. Thus, we had French colonies as well as Dutch, German, Portuguese and Spanish. All of these had the same elements. There were Jewish money lenders and European nobility working together to develop and maintain the colonial empires.

We cannot say that this system was all bad. There were many, many things that were done that vastly improved the living standards of the third world peoples. First, the world was discovered by our sea faring peoples. They found savage people everywhere they went. People who would eat each other and offer human sacrifices and other pagan and heathen practices. Food production, sanitation, health, education, destruction of pagan practices, etc. were taught these people and they are now far, far better off because of it. But we also know that there was much ruthlessness and abuse of power in the system.

These people were taught vocations and how to work as a team to construct roads and water works, etc. They were taught to produce a product which would be shipped all over the world in the ships provided by the colonizers. But, and this is a big but, they were exploited in that their wages were just enough for their basic needs, albeit a little better than it was when they were savages.

The system was not without other pitfalls also. The European nations suffered also. When the young men became of age, they went off to help colonize the world. Many, many of them never came back. Some died of diseases unknown to them in these foreign lands. They died in battle because the colonization process required many bloody wars. Many of the young men found wives among the other races in the colonies. They were a long way from home and lonely.

The reverse took place in their homeland too. Because so many of the young European white men were out fighting wars and colonizing the third world countries, the government brought men from those third world countries back to the European country. There were not enough men to go around for the number of women at home. So what was the next logical thing to happen? We have a tract titled "The Black mans gift to Portugal" that you may have free for the asking. It will very truthfully tell you of this problem.

The average person in England suffered greatly because of this colonization program. It was only the nobility that became wealthy along with the Jewish money lenders. One should ask why the national food dishes of England at that time was kidney pie and suet pudding and simple fish and chips. The food was bland with no condiments to speak of. The houses was very poorly heated with a low grade coal, almost peat moss. Everyone wore at least sweaters even in the house to keep warm. So the colonization process took its toll on the English people.

The Jewish moneylenders were mostly Sephardic by blood. This is the so-called Spanish Jew but more appropriately should be defined as coming from the exodus of Jews after Titus destroyed Jerusalem in A.D. 70. They are not to be confused with Israel because the ten Northern tribes of Israel had long since gone into captivity with king Sennacherib of Assyria in 721 B.C. This deportation is discussed in 2 Kings, chapters [16](#), [17](#) and [18](#). Further, the major portion of the tribe of Judah was deported just seven years later when Sennacherib returned to capture the majority of the tribe of Judah. This is found in [2 Kings 18:13](#).

There was only a very small remnant of Israelites in the fortified of Jerusalem by 700 B.C.

That small remnant continued to follow the corrupted ways of the Caananites and Edomites. Starting in the [7th Chapter of Jeremiah](#), he tells them of the coming capture by the Babylonians. Nebuchadrezzar, king of Babylon finished the capture in about 595 B.C.

Israel went into captivity in Assyria and from there into the Wilderness of Europe to worship their heathen gods just as God promised in the book of Hosea.

In the book *The Bible As History*, Werner Keller tells us that the small remnant that went into Babylon learned of the ways of commerce. They learned the art of money changing. There was the system of stocks and bonds in Babylon. At the Quay along the river, the prices for incoming and outgoing commodities were set each morning just like in the merchantile exchanges of today. The system of Usury (loaning money at interest) was taught them. They learned well from their teachers and went on to become the world's masters at the system of high finance. This book is a very revealing Treatise on the history of those few who went into captivity in Babylon. [1](#)

The book of [Luke, Chapter one](#) and verses 57 through 80 tells us why Jesus came. In [Matthew 15:24](#) we are told to whom he was to come. In [Matthew 10:6](#) Jesus instructed his disciples to do the same thing. When Jesus went into Jerusalem, the first thing he did was to scourge the money changers and to turn over their tables ([John 2:14-15](#)). You can be assured that Jesus was violently opposed to what was to happen over 1500 years later. Read all of these chapters and verses for yourself and you will see why this Lesson In History can be described as "*the time of Jacob's trouble.*"

As we continue with the history, we will learn of a phenomena that was totally unknown or misunderstood until very recently. It starts within two separate rites of the world's Freemasonry movement. As was discussed in earlier lessons, the Rosicrucians and then the English Freemasonry under the Scottish Rite became all powerful by the middle of the 18th century and played a large part in this "marriage" between the Sephardic Jewish money lenders and the English nobility.

They were extremely active wherever the British Empire colonized. It was the "glue" that held together Sephardic money, the nobility, the officers within the British military and the commercial trading companies.

Then, also in the 18th century, another rite in the Freemasonry movement came into prominence. It was the Grand Orient rite headquartered in Europe, principally in France and Germany. But as the name implies it is from the East.

Unknown until recently, these two rites represented the two systems of capitalism. There are two systems of capitalism and as we shall see, they have been in a death struggle all of these years and nobody, maybe not even they themselves, knew of it.

It can be said that the French Revolution of 1789 was the actual start of this conflict but some recognize it starting much later. Quoting from *This Age of Conflict*:

"Two world wars and their intervening wars, revolutions and crises are now generally recognized to be episodes in a single age of conflict which began in 1914 and has not yet run its course. It is an age that has brought to the world more change and tragedy than any other in recorded history. Yet, whatever may be its ultimate meaning and consequence, we can already think of it, and write of it, as a historic whole." [2](#)

By the middle of the 19th century, the British Empire started to wane. The people of England had been used over and over again and they were exhausted. A brilliant and wealthy young man by the name of Cecil Rhodes recognized this and wanted to return

England to its glory. It was Cecil Rhodes who founded the DeBeers South African diamond mining conglomerate. Rhodesia was named after him.

He intended to use the money he had obtained from his mining ventures for this purpose and he wrote this in his second Last Will and Testament: "to and for the establishment, promotion and development of a secret society, the true aim and object whereof shall be the extension of British rule throughout the world, the perfecting of a system of emigration from the United Kingdom and colonization by British subjects of all lands wherein the means of livelihood are attainable by energy, labor and enterprise and especially the occupation by British settlers of the entire continent of Africa, the Holy Land, the valley of the Euphrates, the islands of Cyprus and Candia (Crete), the whole of South America, the islands of the Pacific not hitherto possessed by Britain...the ultimate recovery of the United States of America as an integral part of the British empire...finally the foundation of so great a power as to hereafter render war impossible and promote the best interests of humanity."

From this not so humble start came the [Royal Institute of International Affairs](#) (RIIA), the [Council of Foreign Relations](#) (CFR), [The Trilateral Commission](#), the Institute of Pacific Relations (IPR), the Bilderbergers, etc.

The "Boston Brahmins," that powerful group of people who became known as the "Eastern Establishment" joined forces with Cecil Rhodes and all of them were in consort with the Shepardi money lenders.

Rhodes thought up the idea of a secret society in the same manner as Freemasonry to accomplish his plan. But he got the ideals for his program from John Ruskin, a lecturer at Oxford University. Ruskin said the following in an address at the University, "There is a destiny possible for us, the highest ever set before a nation, to be accepted or refused...Will you, youth of England, make your country again a royal throne of kings, a sceptered isle, for all the world a source of light, a center of peace, mistress of learning and of the arts, faithful guardian of principles...worshiped in her strange valor of goodwill toward all men..."

The ideals of Ruskin gave the followers of Rhodes a sense of nobility, purpose and honor to their cause. But Rhodes and his followers were unscrupulous in their actions. What else could be expected when men like the Boston Brahmins who made their money in the Chinese opium trade and other schemes of preying on the helpless joined forces with him? It was Rhodes who gave the world the infamous Boer War and introduced the idea of concentration camps.

These men were merrily moving around in their meeting rooms of darkness, thinking all along that the world was their oyster and soon they would own it, lock, stock and barrel. They were using merry old England and the British Empire as their horse that they would ride to world power. Again, the British people, along with we Americans were to eventually suffer because of this dream of conquest.

Then, out of the Grand Orient of Freemasonry came another money power that had dreams of grandeur and world power. This money power coming out of the Grand Orient was also oriented toward a single race of people ruling the world. This time it was to be a people who were far more race conscience than the people of the West. These people are the Askhenazi from Russia. These people were totally unknown by most of us until the book *The Thirteenth Tribe*, written by Arthur Koestler, was published. [3](#)

The name that is foremost in the minds of the Western people that represent this new system of capitalism is the Rothschild dynasty. To be sure, there are many other family names associated with this Eastern group. They also wanted secrecy to their operations.

Thus, the Illuminati was formed with Adam Weishaupt being directed to set the society in motion.

The reason that this great conflict now raging was not recognized is that the Rothschilds, and the other families, worked with and in the Bank of England, the "City" of London, Paris and New York. No one thought of this Eastern group being of a different persuasion and they carried their secret ambitions with them to a perfection.


There were powerful ancillary actions that they perpetrated throughout the world as a part of their master plan. The French Revolution is perhaps the most noted but probably not the most important. Starting in the 1870's they sent millions of their people to the United States from Russia. There was a two-fold reason for this. First, the Czars of Christian Imperialist Russia sensed what was happening and was beginning to harass them. Secondly, and perhaps more importantly, their desire was to move their seat of operations from the "City" of London to New York. They wanted to totally disassociate their operation from the idea of the British Empire being the center of the One World Government.

They immediately sent their sons and daughters to the American Universities, preparing them for positions of leadership. Soon, many of the legislators, judges, professors and leaders of high finance were from their families.

By World War I the die was cast. There was no turning back. Some American businessmen began to speak out but were totally annihilated. Foremost among these men was Henry Ford.

Henry Ford was against all finance capitalism as compared to free enterprise. Antony Sutton, in his works *Wall Street and the Rise of Hitler* writes this:

"By 1938 Henry Ford, in his public statements, had divided financiers into two classes, those who profited from war and used their influence to bring about war for profit, and the 'constructive' financiers. Among the latter group he now included the House of Morgan. During a 1928 New York Times interview, Ford averred that: 'Somebody once said that 60 families have directed the destinies of the nation. It might well be said that if somebody would focus the spotlight on 25 persons who handle the nations's finances, the world's real warmakers would be brought into bold relief.'

"The Times reporter asked Ford how he equated this assessment with his long-standing criticism of the House of Morgan, to which Ford replied: 'There is a constructive and a destructive Wall Street. The House of Morgan represents the constructive. I have known Mr. Morgan for many years. He backed and supported Thomas Edison who was also my good friend.' " [4](#)

So Henry Ford had to choose between the two systems, even though he wasn't in favor of either. For this, he was labeled "Anti-Semitic."

Another family who recognized the change taking place was the Lindberg family. Both the Lindberg father and son Charles spoke out on this phenomena and again they were labeled "Anti-Semitic" and destroyed.

The two competing aspirants for world power, the British Empire and its American counterpart, the Eastern Establishment known as WASPS, were competing with the Askhenazi financiers later to become known as Zionism.

Both systems of finance capitalism often utilized the same groups to further their needs. Thus, both financed Hitler as the antithesis to Russian Communism. Again, Antony Sutton did a masterful job in describing the part Wall Street played in the Russian Revolution in his book *Wall Street and the Bolshevik Revolution*. [5](#)

Both World Wars I and II were brought about for two reasons. First, the finance capitalism of the Zionists used wars totally for profit and second, Germany had to be destroyed because the English system needed Germany to complete its system. After all, Germany was a cousin.

Several books have been written on the subject of the destruction of Germany. One, *Germany Must Perish* written by Theodore Kauffman is extremely explicit in the desires and purpose of those who want to destroy Germany. It is said by some that the authors name is a nam de plume for Franklin D. Roosevelt. [6](#)

The final death knell of the British Empire system took place in the 1930's and if you will recall, the United States underwent a massive depression. It was during that depression, coinciding with the Weimar Republic and its inflationary depression in Germany, that the change in command took place.

One of the signs within the United States for the change took place around Columbia University. The Eastern Establishment elite always determined who was to be the presidents of the Ivy League colleges. J.P.Morgan and Co. always determined who the president of Columbia University was to be. J.P. Morgan was founded in 1861 as a partnership. They became simply another incorporated public company in 1940 and were absorbed by the Guaranty Trust Co. in 1959. When Ike Eisenhower was elected president of Columbia it signaled the end of an era.

Another book that should be read by all is *The Dispossessed Majority* by Wilmot Robertson in which he clearly shows the decline of the White, Anglo-Saxon, Protestant (WASP) in the areas of industry and finance. [8](#)

We are now in a position to understand the mechanisms that was used to replace the old British Empire system of world order with the new high finance capitalism. Doesn't it seem strange that the British Empire started dismantling his colonial system after World War II and all of the rest of the Western Nations colonies were likewise liquidated. If you will recall, there was hardly a discussion in any of the newspapers to editorialize on this most monumental turn of events. The decline and fall took place within a single generation, effectively beginning with Indian independence in 1947 and ending with the creation of Zimbabwe in 1980. Books have been written on the subject but, because of this magical tabu, only platitudes are offered. They hint at it but never, never discuss it.

Even Carrol Quigley in his 1310 page *History Of The World In Our Time* made such little reference to Zionism that the word isn't even in the 36 page index. [9](#)

You will recall that the colonial system used workers in the colonies all over the world as cheap labor to produce the goods that the elite could ship to consumers in other parts of the world. The Industrial Revolution played a great part in this because it provided the energy systems and machines with which to make the goods produced in the colonies. There are so many inventions that became a part of this. The cotton gin, the railroad, the steam engine, the steam boat, the telegraph and telephone, the sewing machine. This is to name only a very few of the machines that made the system work.

A part of the British Empire system was simply to mine or extract raw materials from the colonies and ship them to England and then the machines that produced the finished goods were in England. The old "sweat-shop" industries came from this system.

The finances for this capital system came from the owners themselves. Of course, they had accumulated that money through the generations from that marriage that took place in the time of Oliver Cromwell. It was a very tight system of high finance wherein only a few select families had the capital to venture into any big money systems.

Then, at the end of World War II there was a giant change in high finance capitalism. Money, for the sake of money, made money. The owners of the money would invest in any corporation that would make money. The games of leveraging and junk bonds with which to expand their capital became common. White collar crime became the order of the day.

To make this new system of corporate production work there had to be another factor. That new factor was the explosive expansion of technological advances. The needs of World War II made this possible. Electronics, hydraulics, computers, plastic materials are just a few of the technological advances that made this possible.

These technological advances in turn made it possible for consumerism. Things, things, and more things, whether we needed them or not. The Madison Avenue advertisement agencies made it sound and look like we had to have them. Everyone has to have more than one automobile, more than one television, a VCR, A Cam-corder and all of the other things that make for a modern world.

These inventions in themselves is not what is bad. The idea that labor is being exploited in this new system of high finance capitalism is what is bad.

The old days of the colonies with their evils have been replaced with a new system of colonies more evil than the first is what is wrong.

The new colonial system is that of the Multinational Corporations. The new high finance capitalists have purchased controlling interests in the large industrial companies, once owned by the Eastern Establishment and the British Empire, and have sent them into all of the third world countries. Again, the purpose is to exploit the labor by paying them slave wages. As an example, in Mexico, the average wage is around 25 cents per hour. That labor replaced American and European labor that could provide for a decent living for their families.
