

Lubavitch Day Camp Summer 2020 COVID-19 Guidelines

Dear Parents,

Our Mission at Lubavitch Day Camp is to ensure the safety and well-being of your child while providing them with a fun and fulfilling summer infused with a *chassidishe varmkiet*. During these trying and uncertain times it is imperative that we take extra precautions to secure the safety of all campers and staff. All of our guidelines are in accordance with CDC, New York State Health Department guidelines as well as guidance from local health professionals. Please review them carefully below.

The parent/ legal guardian of every camper will be required to read and sign the guidelines below.

ARRIVAL AND DISMISSAL:

1. Upon arrival to camp all campers will;
 - A. Be screened for temperature. If a child has a temperature of 100 or more, he will not be allowed to come to camp.
 - B. Provide parent certification that your child has not been in contact with someone who had or is suspected to have Covid -19.
 - C. Your child will be asked to wash his hands.
2. Parents will not be allowed to exit their vehicle when they drop off or pick up their children.
3. We will be asking for advance notice if a parent or guardian must drop off a camper late or pick them up early. The parent or guardian will be asked to wait in their car in a designated area and the camper will be brought to the car by a staff member.
4. When arriving at the camp, **please do not allow your child to leave the car**, until a staff member screens your child and has given the camper clearance to enter camp.

GROUP SIZE AND INTERACTION:

5. Group sizes will be limited to 10 in accordance with New York State Department of Health guidelines.
6. Groups will be having minimal contact with other groups. In short, every group acts as an independent “family” for the summer.
7. Any entertainment will only take place outside or in the gym in a large enough area for there to be the correct amount of social distancing between every group, and between the groups and the performer.

CAMP ACTIVITIES:

8. Off – site trips and swimming are currently on hold based on our specific camp situation, New York State Department of Health recommendations, as well as guidance from our local health professionals.

Regardless of the above restrictions, we are committed to giving your child an exciting and fun filled summer infused with *varme, chassidishe chayus*, which will leave your child with a lifetime of memories.

REFUNDS:

9. Once camp has begun, if *chas vshalom* a child cannot participate in camp due to Covid 19 related issues, because of but not limited to;

- A child contracts Covid 19.
- A child comes in contact with someone who has Covid 19.
- A child needs to quarantine due to the Health Department Guidelines.
- A bunk needs to quarantine.
- Day camps are deemed unsafe and closed by the Department of Health.

Lubavitch Day Camp will not refund any camp fees.

This is all written as a precautionary measure, and iyh will not happen.

Parents will be expected to fully cooperate with all the above guidelines and encourage their children to take them seriously.

We are fully aware that these guidelines might be modified during the summer season. We will notify you of any changes to these guidelines as we adopt them.

You will be required to sign a consent form on the registration portal, in which you agree to abide by any and all current and future safety rules put into place during the camp season.
