Minutes of the Board of Directors Meeting

Oakwood Clubhouse Ballroom

January 12, 2017 3:00 P.M.

The meeting was called to order at 3:00 by Mr. Giordano. Board members in attendance were Mr. Giordano, Mr. Corso, Mr. Hilby, Mr. Hillabolt, Mr. Washington, and Mr. Wolfe. Mr. Core was absent. Members in attendance were Mike Gloyd and Gary Alexander.

A motion to accept the December minutes was forwarded by Mr. Wolfe and seconded by Mr. Corso. The motion passed unanimously.

Mr. Wolfe reported that there was little financial activity in December other than the collection of team sponsorship fees from Core Photography and the purchase of the Core Photography team shirts. On a fiscal year-to-date basis, we have net income of \$3500 compared to budgeted income of \$1667. The positive variance is primarily related to banner revenue exceeding budget. This was due to more sponsors paying for three years in advance than was anticipated. Mr. Washington moved the report be accepted. Mr. Corso seconded the motion which passed unanimously.

Mr. Hilby reported the Association currently has 104 members with five opting for Open Play and ninety-nine full members. The Women's program has thirteen members. Registration forms and fees are still being collected from the women.

The current schedule appears to be working well although there are some longer gaps between play dates for some teams. These are necessary to avoid the same team playing back to back on a Thursday and Friday. The pattern has teams playing once during one week and twice the following week or vice versa. Mr. Hilby presented a schedule for a four team double elimination tournament for each division. He asked for Board feedback over the next few weeks.

Mr. Washington made a motion that beginning Monday January 30 a new format for Mondays will include batting practice and a skills session with the possibility of a game to follow if time and participants allow. On Saturdays the Open Play game will start at 9:00 with no pregame batting practice, this change will begin Saturday January 28. Mr. Hillabolt seconded. The motion passed unanimously.

Mr. Corso reported on some of the new rules for each division. The Board discussed the length of games particularly in the Sun Division. In an effort to shorten the length of games, starting Tuesday January 17 batters in the Sun Division will have a count of one ball and one strike with no foul to waste. The Board does not want to go to time limits so it's asking the players to be more purposeful when entering and leaving the field following an inning. There was discussion on runner interference at second base; it was agreed it needs to be called more often. Umpires should be notified of the situation. If runner interference would take place the umpire should warn both teams the next occurrence will result in the runner to first being ruled out. The Association needs to obtain an approved mask for pitchers. Some substitute players are balking at paying the full membership IronOaks HOA price as the resulting playing time would be minimal compared to the cost.

Mr. Corso shared the garage has been cleaned out. Items behind the garage are there for the taking. The landscaping supervisor says there is a problem with one of the timers causing the field to be too wet. Mr. Corso is working with them to rectify the problem.

Pat Wolfe has met with both Cottonwood and IronOaks regarding the annual banquet; the prices are similar at both venues. The Board is leaning toward IronOaks. Mr. Wolfe will reserve Tuesday March 28 as the banquet date. More details will be provided at the next meeting.

Due to Mr. Core's very busy schedule the Board is searching for a web-competent member to maintain the Association's web site.

Changes to the by-laws will be posted at the Field of Dreams fourteen days before the scheduled vote.

The next scheduled meeting of the Board of Directors of the Sun Lakes Senior Softball Association is Thursday February 9 at 3:00 in the Oakwood Library

The meeting was adjourned by Mr. Giordano at 5:20.

February 9, 2017 3:00 P.M.

The meeting was called to order at 3:00 by Mr. Core. Board members in attendance were Mr. Core, Mr. Corso, Mr. Hilby, Mr. Hillabolt, Mr. Washington, and Mr. Wolfe. Mr. Giordano was absent. Members in attendance were Mike Gloyd, Randy Rothenbuehler, Bob Hutchins, Ed Sowney, Ken Brenden, Bob Zawidzki, Denny Davidson, and John Seigla.

A motion to accept the January minutes was forwarded by Mr. Wolfe and seconded by Mr. Corso. The motion passed unanimously.

During the Treasurer's report Mr. Wolfe stated on a fiscal year-to-date basis we have a net income of \$5250 compared to budgeted income of \$1300 again due to prepayment of billboard sales. Mr. Washington moved to accept the report; Mr. Corso seconded the motion which passed unanimously.

Mr. Hilby reported the Association currently has 107 members with six opting for Open Play and 101 full members. The Women's program has twelve members bringing the Association total to 119 members.

The tournament brackets have been set and are posted on the chalkboard at the field. They have also been added to the minutes below.

Mr. Washington motioned and Mr. Hillabolt seconded that if Young Realty and Brenden Financial split Friday's games a coin toss will be used to determine the number one seed. The motion carried unanimously.

Mr. Hillabolt reported the numbers for the spring session. At this point there are 88 members requesting to play in the league but this number may fluctuate. The draft will be held Saturday February 18 at 10:00 in the Oakwood Clubhouse. The starting time of spring games will be 8:00 and 10:30. If there are only 84 players the Sun division will play with 10 men on the field.

Mr. Hilby shared the results of the Follow-up Split League Survey with the Board. Following discussion and input Mr. Washington motioned the Association continue the two division league for the spring session. Mr. Hilby seconded the motion which passed unanimously.

Mr. Corso reported there would be no rule changes to start the spring session but intentional walk numbers in the Sun Division will be examined at the next meeting to see if there is a problem and if so, determine a solution.

During his field update report Mr. Corso praised the job Kenny Brenden and Dave Rinaldo have been doing with field preparations. He also met with I/O HOA General Manager Trish Huff. She plans reintroduce the turf project at a spring Board of Directors meeting. The hope is the HOA will provide some support for the project. The HOA Board wants a ten year warranty; the turf company will do eight.

The annual banquet has been set for Monday March 27. Invitations will be sent out later in February. Pat Wolfe and to some degree Larry are deep into organization of the event.

Mr. Core reported the master roster has been added to the web site with password protection. TJ Tjernlund has been doing a great job with the league statistics.

The vote on altering the By-laws will begin Thursday February 16. Only Sun Lakes residents are eligible to vote. Mr. Core and Mr. Hilby will oversee the voting process.

Mr. Washington reported the Association has no issues with sponsorship of teams; all are in place and have paid their fee. He reminded managers to please record who jerseys are assigned to in order to better recover them following each session. A new supply of softballs is needed as we'll run out mid March. To avoid paying for shipping 10 dozen balls will be ordered.

The next scheduled meeting of the Board of Directors of the Sun Lakes Senior Softball Association is Thursday March 9 at 3:00 in the Oakwood Library

The meeting was adjourned by Mr. Core at 4:21.

March 9, 2017 3:00 P.M.

The meeting was called to order at 3:00 by Mr. Giordano. Board members in attendance were Mr. Giordano, Mr. Core, Mr. Corso, Mr. Hilby, Mr. Hillabolt, and Mr. Wolfe. Mr. Washington was absent. No other SLSSA members were in attendance.

A motion to accept the February minutes was forwarded by Mr. Core and seconded by Mr. Corso. The motion passed unanimously.

During the Treasurer's report Mr. Wolfe stated on a fiscal year-to-date basis we have a net income of \$5776 compared to budgeted income of \$1150 again due to prepayment in full of two more bill boards. Mr. Core moved to accept the report; Mr. Corso seconded the motion which passed unanimously.

Mr. Hilby reported the Association currently has 122 members with six opting for Open Play and 104 full members. The Women's program has twelve members which accounts for the total of 122.

The Spring tournament format will mirror the Winter tournament with two double elimination tournaments, one for each division.

Rules for the Spring League Tournament

- The half run rule will **not** be used.
- Tiebreaker/seeding for league play
  - The first criteria is based on head to head record
  - The second is winning percentage
  - The third is run differential between those two teams
  - The fourth is a coin flip.
- The International Tie Breaker will be utilized in extra inning games
  - The last person to bat in the previous inning starts on second base
  - There will be one out to start the each extra inning.
- Substitution runners
  - In an extra inning game all runners are once again eligible
  - Whether a player runs for an injured player or an uninjured player, he may not run again in the game as a courtesy runner.
- Substitutes for injured or missing players
  - Each ratings category will be split in half with only players from the second or lower half of each category eligible to substitute.
- There will only be one umpire per game.

Mr. Hillabolt reported a learning situation occurred at the draft as two players requesting to play in the Sun Division were not drafted and thus were placed in the Lakes Division draft causing more players than needed. Adjustments were made to accommodate all players. There is still continual drifting in and out of commitments from players in the days before the draft.

Mr. Corso led the discussion regarding rule changes and updates. Duplication of Senior Softball Rules and SLSSA rules as well as some outdated and unnecessary rules will be cleaned up during Rules Committee meetings this summer. Mr. Corso would like the Association's rules to be as close to the Senior Softball Rules as possible. The committee will also create a "Local Rules" document.

During his field update report Mr. Corso once again thanked Ken Brenden and Dave Rinaldo for doing such a great job of maintaining the field. The maintenance crew is planning on installing the proper pegs for 65' bases so the ladies team is compliant with their league regulations. This length could also be an option for the Lakes Division.

The Chandler Stars youth team will be using the Field of Dreams twice a week for practice. They will be on the field Mondays and Wednesdays at 4:30.

Food will be served on the second day of the Spring Tournament (Thursday April 13). The menu consists of hamburgers, chips, hotdogs, cookies, water, and soda. Awards and recognition will take place also.

The annual banquet has been set for Monday March 27 in the Oakwood Ballroom. Mr. Wolfe showed the Board a draft of the program. Check in and Happy Hour begins at 5:30 with dinner at 6:40. The program will begin at 8:00, music and dancing to follow until 10:00. Mr. Core will once again have a slide show of our members.

The new softballs for both men and women have been delivered.

The Board acted on the Spirit of Sun Lakes award and will complete the rest of the awards slate at the next meeting.

Due to the fact there was only one person interested in running for the Board there will be no election to fill the seat vacated by Mr. Wolfe. Jim Leckner will be seated at the April Board meeting. Congratulations Jim!

The next scheduled meeting of the Board of Directors of the Sun Lakes Senior Softball Association is Thursday April 6 at 3:00 in the Oakwood Library. This meeting has been moved up one week so Board members may properly address tournament needs.

April 6, 2017 3:00 P.M.

The meeting was called to order at 3:03 by Mr. Giordano. Board members in attendance were Mr. Giordano, Mr. Core, Mr. Corso, Mr. Hilby, Mr. Hillabolt, Mr. Leckner, Mr. Washington, and Mr. Wolfe. Members in attendance were Randy Rothenbuehler and Doug Friesen.

A motion to accept the March minutes was forwarded by Mr. Corso and seconded by Mr. Hillabolt. The motion passed unanimously.

During the Treasurer's Report Mr. Wolfe stated that on a fiscal year-to-date basis we have net income of \$6332 compared to a budgeted net income of \$1201. The positive variance is primarily due to banner advertising exceeding the budget by \$3478 and the unbudgeted payment of \$1975 from the HOA for infield maintenance. In addition, the cost of caps was \$591 less than the budgeted expense.

Mr. Jim Leckner was seated as a member of the Board. Mr. Hilby and Mr. Giordano were returned to the Board for another term. The SLSSA sends a heartfelt thank you to Mr. Wolfe for his service as a Board member. We also are grateful for his continued involvement with the SLSSA Board of Directors.

Officer elections determined Mr. Sam Giordano will remain as president, Mr. Corso will serve as vice-president, and Mr. Hilby will continue to carry out the duties of the secretary. Mr. Wolfe was elected as an outside, non-voting member of the Board in which he will complete the duties of the treasurer.

Mr. Hilby reported the Association currently has 123 members with seven opting for Open Play and 104 full members. The Women's program has twelve members which accounts for the total of 123.

The Spring tournament format will mirror the Winter tournament with two double elimination tournaments, one for each division.

Rules for the Spring League Tournament

- The half run rule will **not** be used.
- Tiebreaker/seeding for league play
  - The first criteria is based on head to head record
  - The second is winning percentage
  - The third is run differential between those two teams
  - The fourth is a coin flip.
- The International Tie Breaker will be utilized in extra inning games
  - The last person to **bat** in the previous inning starts on second base
  - There will be one out to start each extra inning.
  - A courtesy runner may only be used after the runner on second base reaches third base.
- Substitution runners
  - Whether a player runs for an injured player or an uninjured player, he may **not** run again in the game as a courtesy runner.

- In an extra inning game all runners are once again eligible
- There will only be one umpire per game.
- Pick-up rules for missing and injured players
  - These rules apply to both divisions
  - In the Sun Division the “one’s” and “two’s” categories are split in half
    - If a team is missing a high one, they **may** pick up anyone including a high “one”
    - If a team is missing a low “one”, they **must** pick a low “one” or a lower rated player
    - This concept also applies to the “two’s”
  - The “three’s” category has been left intact
  - The rule is the same for the Lakes Division only it designates high “three’s” and low “three’s” as well as high “four’s” and low “four’s”.

Mr. Hilby will create an online survey asking for the following feedback:

- Are you planning on playing next year, if so how many sessions, and in what division would like to play?
- Would you be interested in playing in a summer league at the Field of Dreams?
- What is your support level for adding a fourth play date (Monday) to the week for league play? This would assure everyone plays four games (2 doubleheaders) a week.

During his field update report Mr. Corso once again thanked Ken Brenden and Dave Rinaldo for doing such a great job of maintaining the field; the Board also sends along its thanks and appreciation for their efforts. A new infield drag has been purchased. Mr. Corso will once again approach the Iron/Oaks HOA Board regarding the artificial turf project.

Food will be served on the second day of the Spring Tournament (Thursday April 13). The menu consists of hamburgers, chips, hotdogs, cookies, water, and soda. Awards and recognition will take place after the 10:30 game that day. Mr. Core and Mr. Brenden will purchase the food.

The annual banquet ended with a \$17 profit due to the raffle which netted \$249.

Rather than holding full meetings this summer the Board plans to hold a series of workshops which are open to all members. These workshops will center on a different issue each meeting in order to bring about change, clarification, or improvement of the organization. Each workshop will have an agenda which will be posted on the web site and at the field. The first workshop will be held on Tuesday May 16 at 1:00 in the Oakwood Library.

The meeting was adjourned by Mr. Giordano at 4:28.

5. Add a fourth day? Yes – 28, Leaning yes, need more info – 23, Don't care – 7, Leaning no, need more info – 7, No - 5

Mr. Leckner motioned we start a summer league beginning in July. Mr. Corso seconded the motion. It carried unanimously. Mr. Hillabolt and Mr. Leckner will organize.

Beginning Thursday June 1 summer open play will begin at 7:00. Mr. Hilby will send a notice out via email and Mr. Core will post on the web site.

Mr. Corso updated the status of the field turf. The issue will go before the HOA Board during their June workshop. The prices and costs remain the same for the product and installation.

- How many managers will be needed for next year?
  - We have enough at this time.
- Other considerations
  - None

The meeting was called to order at 1:00 by Mr. Corso. Board members in attendance were Mr. Corso, Mr. Hilby, Mr. Hillabolt, Mr. Leckner, and Mr. Wolfe (Treasurer). Members in attendance were Tom Kasunic, Gary Alexander, Randy Rothenbuehler, Dave Rinaldo, and Doug Friesen.

A motion to accept the June minutes was forwarded by Mr. Core and seconded by Mr. Hillabolt. The motion passed unanimously.

During the Treasurer's Report Mr. Wolfe stated for the months of June and July revenue was \$475. Expenses were minimal at \$98. A motion to accept the financial report was made by Mr. Core and seconded by Mr. Hilby. The motion passed unanimously.

The 2017/18 budget focuses mainly on paying for the turf. Discussion centered on a onetime club membership fee of \$75 to replenish the coffers as the turf will deplete our current funds. No official action was taken; the budget will be discussed and approved in September.

Mr. Corso updated the status of the field turf. Greenfield (the sellers), the installers, and the turf expert have been communicating. The current soil on the field is an adequate base for laying down the turf. A minimal layer of sand will be needed to keep the field from contracting and expanding from temperature changes. A meeting with the installers will be scheduled for next week at the field.

Mr. Washington, in absentia, submitted information regarding softballs and uniforms. We currently have four dozen softballs, enough to get through until October when we will order ten dozen. He feels the league's uniforms are in good shape and recommends we not purchase jersey's this year. Mr. Giordano motioned we use the existing uniforms for the 2017/18 season. Mr. Leckner seconded. The motion carried unanimously.

Mr. Hillabolt updated the Board regarding the summer league. Players have been very happy with league so it has been extended through September. Non-roster substitutes have shown an interest in joining a team. There are some openings on the horizon so those members will be accommodated.

Fall session sign-ups will start Monday September 25 and end Saturday October 14. These deadlines as well as other sign-up information will be published on the web site and through an email blast.

Mr. Hillabolt and Mr. Corso will arrange rental of Snedigar fields while the Field of Dreams (FOD) is being over seeded.

Workshop #3: Safety Review

- Interference – the runner cannot interfere with a defender making a play. The base runner must avoid the defender. This applies to a defender fielding a ball or a defender attempting a throw to a base during a double play attempt. Runners are to veer out of the base path to avoid being struck by a thrown ball. Umpires have the discretion to call the batter automatically out if a runner interferes with the completion of a play.

- Obstruction – this happens at all bases but most frequently at first base. On a base hit, the first basemen should move in toward home plate to stay out of the runner's path while making the turn at first. Fielder must yield to the runner.
- Aggressive outfield play – An outfielder should call for a ball in play. Other outfielders should verbally acknowledge the call and peel off or back up the play. Communication is the key to avoiding collisions. Centerfielders have priority over all other fielders with left-center having priority over right-center. No one should be running full speed into fences in an attempt to catch a ball.

#### New Business

- Right field needs to be rolled. Due to over watering, ruts and holes have developed from mowing and being played on while the ground is soft. Mr. Martinez of the HOA groundskeepers will be contacted to rectify the problem.
- Members would like to see a recycling program put in place at FOD. The bin on the patio will now be used for aluminum, plastic, and paper. Current garbage cans in the dugouts will be used for recycling and smaller containers will be added for garbage.

The September board meeting has been set for Tuesday September 12 at 1:00 in the Oakwood Clubhouse Library.

Mr. Hillabolt updated the Board regarding the summer league. The league has been running smoothly and finishes up on Tuesday September 19, 2017.

Fall session sign-ups will start Monday September 25 and end Saturday October 14. These deadlines as well as other sign-up information will be published on the web site and through an email blast.

Mr. Hillabolt and Mr. Corso have arranged rental of Snedigar fields while the Field of Dreams (FOD) is being over seeded. Snedigar play will start on Tuesday September 26 and continue through Thursday October 19. Two fields have been rented for two hours each starting at 8:00 a.m.

The discussion then centered on non-resident age limits. Non-residents are now considered anyone living outside Iron/Oaks. With there being two leagues divided by talent levels it was felt lowering the age limit could help the club grow. Mr. Washington motioned that potential players living outside Iron/Oaks must be at least fifty-five years of age to play in the league. Mr. Corso seconded. The motion carried unanimously.

During the Treasurer's Report Mr. Wolfe stated for the month of September revenue was \$900. Expenses were minimal at \$74. September is the last month of the fiscal year. A motion to accept the financial report was made by Mr. Leckner and seconded by Mr. Hillabolt. The motion passed unanimously.

Four Board members attended the Iron/Oaks HOA workshop Wednesday afternoon. The committee on amenities presented their report. Pickleball and fitness center were the only issues. They are seeking to develop the current softball complex into pickleball courts, a dog park, sand volleyball courts, and a regular park. It will cost an estimated \$700,000 to make the changes and \$7100 for preliminary work. Mr. Giordano has volunteered to serve on the committee but has heard nothing from General Manager Trish Huff. SLSSA will develop strategies for combating this change.

Rule change proposals:

- Lakes Division:
  - Count rule: 1 ball & 1 strike with no fouls to waste; hitting the screen results in a dead ball but does not count as a strike. Mr. Core motioned to keep the count rule the same as last year (1 ball & 1 strike with one foul ball to waste). Mr. Leckner seconded. Passed unanimously.
  - Courtesy running: A player can run only once per inning rather than once per game. Mr. Core moved the courtesy running rule remain the same. Mr. Washington seconded. The motion passed unanimously.
  - Courtesy running: Mr. Core motioned we rescind the above courtesy running rule and implement there be no limits on courtesy runners. An individual may run only once per inning. Mr. Washington seconded. The motion passed unanimously.
- Sun Division:
  - Home run rule: Mr. Hillabolt motioned each team is allowed three home runs per game. After that, home runs are considered singles for that team. When the other team reaches its allowance of three home runs the rule is neither team may go more than one home run up on the other team. Mr. Washington seconded. Defeated 2-4 (Mr. Hillabolt and Mr. Washington for, Mr. Hilby, Mr. Leckner, Mr. Core, against).

- Walks: Mr. Leckner motioned that after a batter is walked once, in his next at-bats he cannot be walked unless he gets one strike. If he is walked he has the choice to accept the walk or bat until he gets a strike. Mr. Hilby seconded. Passed 4-1 (Hillabolt against, Washington, Core, Hilby, Leckner for).
- Courtesy running: Mr. Giordano motioned there be no limits on courtesy runners. An individual may run only once per inning. Mr. Core seconded. The motion passed 4-1. (Mr. Hillabolt against, Mr. Washington, Mr. Hilby, Mr. Core, Mr. Leckner for).

Mr. Washington reported all but one sponsor has paid, he's confident that payment will be made. We will wear the uniforms from last year as they are still in good shape. Caps will be scarlet and gray. He will order 10 dozen balls for session one. Mr. Giordano motioned the Association buy two batting tees and two nets for before and between games warm up. Mr. Washington seconded. The motion passed unanimously.

We currently have 46 players in the Sun Division draft and 42 in the Lakes Division draft. The two players not drafted in the Sun will be included in the Lakes Division draft. There will 44 players drafted in each league, 11 per team.

Ken Brenden discussed the draft and player pick up rules for 2017/18. In the Sun Division there are 8 number ones, 8 number twos, 12 number threes, and 12 number fours. There will be only three ratings categories in the Lakes Division. At the draft managers will pick a number to choose which draft slot they prefer. No pitcher or shortstop designations have been made.

The intentional walk rule was amended. A batter must walk on three consecutive balls to be eligible to opt out of a walk later in the game. Previously the rule read the batter only needed to be walked.

Mr. Corso shared concerns regarding the draft. One Sun Division team has three pitchers and one team has only one. Should players be drafted as their rating indicates rather than when they are drafted? Should we designate four pitchers and during the draft have their names pulled out of the hat? The Board will monitor the next draft more closely in order to achieve better balance.

- Meetings will continue with the group to develop more strategies.

A motion to accept the November minutes was forwarded by Mr. Hillabolt and seconded by Mr. Corso. The motion passed unanimously.

During the Treasurer's Report Mr. Wolfe stated for the month of November revenue was \$2505 as most banner sponsors are paying the entire three-year fee up front. Expenses were at \$499. It was noted the Iron/Oaks HOA is past due on payments for field work as well as expenses. When those payments are received the budget will be in line with budget expectations. A motion to accept the financial report was made by Mr. Leckner and seconded by Mr. Washington. The motion passed unanimously.

Mr. Hilby reported current membership at one hundred-sixteen; three members play recreational only and one hundred-one are full members. Twelve women have signed up.

Mr. Corso felt the rule changes for the Fall session worked well. He made a motion that the home run rule be changed to three up with ensuing homers counting as singles until the opposing team hits a home run. Mr. Giordano seconded. Following discussion the motion was withdrawn but home runs will be monitored to see if the proposed rule should come into effect. The Sun Division will be playing with twelve players on a team. If a team is missing a player to start a game that team will be assessed an out every time the missing player is to bat. Also no player will sit out more than two innings per doubleheader. Those two innings are recommended to be consecutive to save time.

The Sun Division draft for the Winter session was held today (Thursday 12/14) at 2:00 with the Lakes Division drafting on Friday 12/15 at 3:00. The Winter session begins Tuesday January 2. All SLSSA games and practices begin at 9:00 during the winter. Saturdays will be recreational games only with no batting practice. The Monday sessions are for batting and fielding practice.

The same schedule format used during the Fall session will be used in the Winter session with a week added for the end of the session tournament.

Mr. Giordano provided updates on the change of use proposal of the softball field. The *Sun Lakes Splash* ran a front page story about the start of the softball season. Another article will be published in the December edition presenting a history of softball in Sun Lakes along with the plans to remove the field. The SLSSA Board has a copy of the previous noise study regarding Pickleball and a sketch of the architect's layout of the park/Pickleball/bocce ball/putt putt course/horseshoe pits. A softball field was not included in the plans. Preparations are under way to garner signatures for a Change-Of-Use vote should the Iron/Oaks Board pursue the plan to remove the Field of Dreams.

Sixty-five foot bases have been installed for the women's games. Chalk will be ordered as we're running low. Also the pitching screen is broken and needs to be welded. The Board authorized the repair of the screen with a cost not to exceed \$200. Mr. Hillabolt will oversee this process.

Mr. Washington will order game softballs in January; we currently have enough for five weeks worth of play.

The Board reminds everyone of the SLSSA policy regarding harassment. If a member has a problem with another player there is a procedure to solving the problem through submitting a formal grievance to the Board.

The next board meeting has been set for Thursday, January 11 at 3:00 in the Oakwood Clubhouse Library.
