The Board discussed the raises for elected officials for the 2023-2026 term. A Resolution for salaries was presented. Motion was made by Schmidt, seconded by Batterman, to approve the salaries and to adopt the following resolution:

RESOLUTION #2022 – 03

WHEREAS, it is necessary for the Morrill County Board of Commissioners to set salaries for elected county officials of Morrill County for the ensuing term commencing in 2023;

THEREFORE, BE IT RESOLVED, by the Morrill County Board of Commissioners that salaries for elected officials of Morrill County for the ensuing term commencing in 2023 be set as follows:

The annual salary for the office of **COUNTY COMMISSIONER** be established at \$16,500.00 for the calendar years 2023, 2024, 2025 and 2026. provided that upon organization each year the chairperson of the Board received in addition to the said annual salary the annual sum of \$1,000.00.

The annual salary for the office of **COUNTY CLERK**, **COUNTY TREASURER AND COUNTY ASSESSOR** be established at \$55,094.15 for the calendar year 2023. That for each year thereafter a 1.5% increase be added to the previous year's salary, so that the amount paid for the calendar year 2024 be \$55,920.56 for the calendar year 2025 be \$56,759.37 and the calendar year 2026 be \$57,610.76. In addition to the salary, the **County Clerk** will receive an additional \$2,400.00 per year for managing the insurance fund.

The annual salary for the office of **COUNTY SHERIFF** be established at \$65,612.55 for the calendar year 2023. That for each year thereafter a 1.5% increase be added to the previous year's salary, so that the amount paid for the calendar year 2024 be \$66,596.74 for the calendar year 2025 be \$67,595.69, and the calendar year 2026 be \$68,609.63. In addition to the **County Sheriff's** salary an additional \$18,000 per year will be paid from the City of Bridgeport contract.

The annual salary for the office of **COUNTY ATTORNEY** be established at \$50,000.00 for the calendar years 2023. That for each year thereafter a 1.5% increase be added to the previous year's salary, so that the amount paid for the calendar year 2024 be \$50,750.00 for the calendar year 2025 be \$51,511.25 and for the calendar year 2026 be \$52,283,92.

The annual salary for the office of **COUNTY SURVEYOR** be established at \$1,000.00 for the calendar years 2023, 2024, 2025 & 2026.

BE IT FURTHER RESOLVED, that in addition to the Elected Officials salaries, the County Clerk, County Treasurer, County Assessor, County Sheriff, County Attorney and Clerk of the District Court, shall each receive a Premium (Hazard) Pay Allocation of \$15,000.00 to be exclusively funded via appropriations allocated to Morrill County through the American Recovery Plan Act (ARPA).

Said Premium Pay Allocation shall be made only to those elected officials (officeholders) who held his/her office in Morrill County throughout the COVID-19 emergency, which for purposes of this Resolution, shall be March 1, 2020 through September 1, 2021, and who continue to be the officeholder on or after February 1, 2023.

Re-Election of the current officeholder shall be a prerequisite to receiving the Premium Pay Allocation. For any officeholder who held his/her office for less than all of March 1, 2020 through September 1, 2021, the Premium Pay Allocation for that officeholder shall be a prorated amount correlating to the percentage of days he/she was in office from March 1, 2020 through September 1, 2021.

Additionally, the Premium Pay Allocation shall be contingent upon the Premium Pay Allocation shall be contingent upon Morrill County receiving and being able to allocate the funds, and contingent upon the Premium Pay Allocation conforming to the rules and regulations set forth with regard to ARPA funds expenditures.

BE IT FURTHER RESOLVED, that in addition to the above stated salary all elected officials shall receive the benefits of the County Retirement Plan.

BE IT FURTHER RESOLVED, barring any mandates from Federal or State governments, which would change contributions of employer or employee for health coverage, that in addition to the above stated salary, each of the before state elected officials shall receive whatever health plan that is in place for each of the employees and adopted by the Board of Commissioners, and that such alteration in deductible or change in the portion paid by the individual shall not constitute an increase or decrease in the herein adopted salary.
