The Division History Committee has been charged with the task of compiling the history of all the Chapters and we need your

help. We would like for each Chapter to appoint a committee or maybe one member to compile your Chapter's history starting with 1948, and submit it to the Division Committee by September 1, 2011. There is already a book that covers the Chapter histories from 1894 to 1948 but if your Chapter was chartered prior to 1948, you can still include that information as an important portion of your Chapter's story. Your Division Chairmen for this project are Jo Hill for East Tennessee, Nancy Todd for West Tennessee, and Nelma Crutcher for Middle Tennessee. You can contact them if you have a question.

Examples of what your history might include would be, when and where your Chapter was chartered, how your Chapter name was chosen, projects you have supported, members that served in a Division office or Chaired a Division committee. You might add if your Chapter hosted Conventions or Division meetings or any other annual events you sponsor... the list could be limitless. The main restriction is a word limit of 750 words.

This information can be found in many places including your Chapter's minutes or old Division minutes books which can be found in libraries and archives or in the possession of some members. You just have to dig to find them.

Each Chapter will be allowed one picture of either the Charter members or something that pertains to the Chapter. For example, my Chapter, Fort Donelson, might have a group picture at the Confederate monument at Fort Donelson since our Chapter is an outgrowth of the Division's Fort Donelson monument project in 1915. Jo Hill's Chapter might have a picture of a monument to A.P. Stewart or a chapter group picture with the monument. Nancy Todd's Chapter might include a picture of the Gayoso Hotel.

Your history will also include a list of the first Officers to serve the Chapter and the present Board of Officers but this can be supplied by the Committee so you do not have to research this if you don't already have it.

If your chapter has a member that has served as Division President, we will need a 500 word biographical sketch of her as a member and her term of office, and a

picture. If you have a member that served as Honorary President of Division or General, we will need a 250 word bio of her work in UDC also.

A few years ago we started a project that was close to this but it was not completed. We have in storage the reports that were submitted at that time and we will be sharing these with you as a "starter kit" for the Chapters that submitted a report at that time.

Our plan is to compile all of these into book form to record the history of our Division. Because a book of this kind has already been printed that covers the years 1894-1948, we need your histories to cover the years 1948-2012. So get to work on your history and get back to us as soon as possible.
