NSDT reserves the right to close or cancel a class, camp or production that doesn't meet the minimum enrollment NSDT deems necessary to cover expenditures. NSDT class age groupings are guidelines. NSDT retains the right to place students in classes at directors' and teachers' discretion.

NSDT retains the right to provide substitute teachers in the event of the absence of regularly scheduled teachers. Regular teacher and room assignments are subject to change without notice and room assignments are at the discretion of the directors and may not go according to current or past schedule.

Students will not be invoiced for tuition. Parents or Guardians are responsible for making payments at the correct times, and are subject to additional fees in the event tuition is not received on time. NSDT accepts exact cash, check and credit card payments; there is a \$25 fee for returned checks. NSDT has a NO REFUND POLICY. Classes, play productions, and camps will not be pro-rated and all make-up classes (if allowed) must be taken during the current session. If a child doesn't like their role in a production or class, there will be no refund.

Parents/Guardians are responsible for picking up students inside of GUMC, as well as newsletters, updates and any other studio information. Students are responsible for wearing proper dance attire (including dance shoes) and wearing appropriate clothing- if these rules are not followed students will be asked to leave rehearsal. This is to ensure safety and fairness.

The North Shore Dance & Theater provides educational opportunity without discrimination on the grounds of race, sexual orientation, color, creed or religion, gender, national origin or age.

I/We enroll our student(s), listed on the registration form. In recognition of the services North Shore Dance & Theater provides, I/We understand and agree to NSDT's guidelines listed above. Rehearsals: There is a possibility of two casts for the Willy Wonka production. If having one cast, rehearsals will be on Fridays from 5:30-7:00pm and Saturdays from 3-5pm. *Some cast members will be asked to come in on the following Mondays for small group and private coaching: January 27th, February 10th and February 24th.* If having two casts, the Candy Cast rehearses Fridays from 5-6:15pm and Saturdays from 2-4pm and the Chocolate Cast rehearses Fridays from 6:15-7:30pm and Saturdays from 4-6pm. Rehearsals will begin on Friday, January 10th.

Tech Rehearsals: Willy Wonka tech rehearsals will be held on February 29th from 3-6pm, March 1st from 3-6pm, March 2nd from 5-7:30pm and March 4th from 5-7:30pm, if having one cast. If having two casts, the Candy Cast will have tech rehearsals on February 29th from 3-6pm and March 2nd and 4th from 5-7:30pm. The Chocolate Cast will have tech rehearsals on March 1st from 3-6pm and March 3rd and 5th from 5-7:30pm. All tech rehearsals are mandatory.

Shows: Willy Wonka shows will be on March 6th at 7pm (call for cast members is at 5:30pm), March 7th at 7pm (call for cast members is at 5:30pm) and March 8th at 2pm (call for cast members is at 12:30pm), if having one cast. If having two casts, the Candy Cast will perform the following shows: March 6th at 7pm (call for cast members is at 5:30pm) and March 7th at 2pm (call for cast members is 12:30pm). The Chocolate Cast will perform the following shows: March 7th at 7pm (call for cast members is at 5:30pm) and March 8th at 2pm (call for cast members is 12:30pm).

Participation Rules

1. Tuition payments are due on the first rehearsal. The fee is \$430 (or \$410 if registered and paid in full by December 20th) which includes a script, link to rehearsal musical, shirt and downloadable link to the performance. you need a replacement script it is \$15 fee. All payments should be made payable to NSDT.
2. Cast members must participate in all their scheduled rehearses and classes. Absences due to illness or family emergency will be considered excused up to three times. Three absences can result in dismissal from the cast with no refund of participation fees. In the case of an absence, the actor/actress is to make arrangements to make up the missed material on his/her own time with a fellow cast member.
3. In the case of an absence, the cast member is to make arrangements to make up the missed material on his/her own time with a fellow cast member.
4. All cast members are to be dropped off on time and picked up on time from rehearsals. A parent or guardian must come in to sign the cast member(s) in and out.
5. Cast members are responsible for bringing their script, dance shoes, a water bottle, and a writing utensil. Wet gym shoes or boots will not be allowed on stage.
6. Cast members are to treat all participants and cast members with respect.
7. North Shore Dance & Theater follows the 3 strike rule of improper behavior: Strike One- Verbal warning to the participant and the parent, Strike Two- Written warning and meeting with parents, Strike Three- Dismissal from the play with no refund
8. All rehearsals are closed to parents and family members unless special arrangements have been made.
9. North Shore Dance & Theater and Glenview United Methodist Church is not responsible for any personal property during rehearsal.
10. No gum is allowed.
11. Electronic devices are only to be used when not on stage or rehearsing. Only appropriate games are allowed. No picturing taking or video recording of any kind is allowed.
12. Photography of this production is strictly prohibited. There will be a photo opportunity at the end of each show for family and friends to take pictures of the cast.
