New Document from OSERS

Thursday, December 7th, the Office of Special Education and Rehabilitative Services (OSERS) in the U. S. Department of Education released a <u>question and answer document</u> addressing the Supreme Court's March 22, 2017 unanimous decision in Endrew F. v. Douglas County School District <u>Re-1, 137 S.Ct. 988</u>.

This Q & A document contains additional guidance in the following areas:

- The meaning and application "de minimus" and its relationship to Free Appropriate Public Education (FAPE)
- The meanings of "reasonably calculated" and "progress appropriate in light of the child's circumstances"
- Actions for IEP teams for determining appropriately ambitious goals; implementing the Endrew F. standard for students with the most significant cognitive disabilities; actions to take for a child who is not progressing as expected; the use of positive behavioral interventions and supports; and placement decisions

2017 International Conference

The conference was held in Portland, OR and the theme of the conference was "Mountains of opportunity: Interdisciplinary Collaboration in the New Millenium". This theme highlighted the words of Henry Ford: "Coming together is a beginning. Keeping together is progress. Working together is success."

Conference Highlights

- 1155 people attended the 2017 Conference
- Though participants came from many backgrounds, professions, and experiences, they all shared the common mission of ensuring better outcomes for young children with disabilities and their families.
- The opening address was delivered by Janice Fialka, a parent and also a social worker who talked about the importance of partnerships between families and professionals. She is the author of "Still Dancing after All These Years". Janice also received the DEC Parent/Family Award which is given to a DEC member and parent who has made significant contributions through service to the field and community. This award is given to demonstrate the importance of recognizing parents and families who are making a difference in the field.
- The conference included two additional plenary sessions. One was an interview with Diane Bricker on the topic "What's Working, What's Not, and Where are We Headed". She discussed the history of collaboration in the field and how we move forward towards interdisciplinary collaboration that achieves quality outcomes for young children and their families. The other session was a panel discussion on the topic of "How Do We Engage in Collaborative Consultative services?" Panel members included members who are experts in their fields representing the areas of communication and language development, occupational therapy and sensory processing, physical therapy and the primary provider approach to services.
- There were many opportunities for networking and visiting the poster sessions as well as multiple sessions geared toward research, policy, practice, professional development and families
- There were also opportunities to meet with the DEC board members and provide input into the reauthorization of IDEA which will happen sometime in the next few years.

The majority of the attendees who completed the evaluation reported being familiar or very familiar with DEC Recommended Practices. Furthermore, attendees felt the sessions strengthened their understanding of the DEC RP's and the sessions were true to the spirit of the DEC RP's. Most attendees plan to use the DEC RPs for teaching or training. Participants remarked that overall session quality improves every year.

MN DEC Practitioner/Leader Award

The high quality of Early Childhood Special Education in Minnesota is due to the talented and dedicated staff leading programs and providing services to young children with disabilities and their families. In 2017 the Practitioner of the Year Award was given to Heidi Muhs and Jane Gibson for the wonderful work they did providing homebased services to young children and their families. The Leadership Award was presented to Shari Mensink the Special Services Coordinator in Owatonna for her outstanding work in leading the ECSE program. The work is hard and complex, each year MN DEC, takes the opportunity to recognize an outstanding leader and an outstanding practitioner. There are many leaders and practitioners in the state who demonstrate these characteristics, however each year the number of people nominated has been small, though of exceptional quality. This year the nominating process has been simplified, the application has been revised, and can be completed on line.

MN DEC encourages nominations of any early childhood professional: ECSE, ECFE, Head Start or preschool teacher or administrator, childcare provider/director or other professional, who has made a difference in the lives of young children with special needs and their families and/or in the lives of their colleagues through the following:

- Performed their job in an exemplary manner
- Have made significant contributions or provided leadership that has improved or will improve the lives of young children with special needs and their families
-) Demonstrated through their work evidence of knowledge and skills consistent with recommended practices in the field
- Demonstrated high ethical and professional standards.

2017-2018 Mini-grant Recipients

At the two annual conferences (Leadership and Practitioners) sponsored by MN DEC, each region donates a basket to raffle, the proceeds from the raffle are used to fund "Mini-grants". These action research projects are targeted to enhance learning for children and/or families. The 2017-2018 Mini-grants were awarded to teams from Stillwater, Rochester and Mankato. Still water and Rochester focused on expanding the use of sensory material in preschool inclusion settings, increasing availability of sensory tools, collecting data regarding the effectiveness of different sensory tools and increasing student engagement and self-regulation. Mankato's research focused on expanding the teaching of Stem Skills, creating teaching strategies and lessons aligned with Creative Curriculum and training staff to implement the lessons.

As the end of the year approaches, teams often have wonderful ideas about ways to enhance their practice which may be more costly than districts can fund. Mini grants are a great way to turn these ideas into practices and to be able to provide funding.
