Program Success Story

"A mother enrolled in our program had her parental rights temporarily terminated, as a result of drug use. Though mom was incarcerated for a couple of months, she expressed her interest in continuing services. Staff continued visits with mom at the county jail and coordinated with the DHS appointed caregiver to continue providing visits for the child. As a result of continued services, potential delays were identified and a successful referral was made to both AEA and the Blank Children's Hospital Developmental Clinic."
