CDBG Special Grant Funding

Mayor Lentz discussed in length the CDBG Special Grant Funding Round, and the process. This is a onetime funding round for special projects that aren't normally funded through the program. They have 12 million dollars total to disburse to the applicants. The maximum grant amount to apply for is \$350,000.00, and the minimum grant amount to apply for is \$100,000.00 The deadline for the application is June 1, 2015. Motion by Commissioner Edwards for the grant writer to proceed with the application process, and to take the costs for preparation out of the electric fund. Seconded by Commissioner Krug. All aye.
