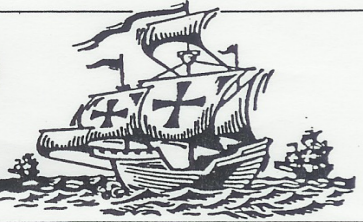

What is the St. Augustine Rainbow Camp and how do North Olmsted Knights support it?

Augustine Rainbow Camp is a five-week program from Monday, June 29<sup>th</sup> thru Friday, July 31<sup>st</sup>, 2009, serving young people 5 to 16 years old from Cleveland's Tremont neighborhood as well as from Greater Cleveland who are deaf, hard of hearing or blind. Children with mild or moderate cognitive disabilities also are served.

It is operated under the auspices of St. Augustine Church in Cleveland's Tremont neighborhood in conjunction with the diocesan office of Disability Ministries for the Deaf, Hard of Hearing, Blind and Mentally Ill of Catholic Charities Services. Activities take place at nearby OLA/St. Joseph Center. Sports and recreation events are held on the spacious lawns of Cleveland's Lincoln Park, across West 14<sup>th</sup> Street.

Children participate in activities planned around a weekly theme, such as the circus, the Olympics or friendship. The focus is togetherness and positive self image.

Activities include arts and crafts, sports, recreation, sign language classes and tutoring through the use of computers. Special events and field trips also are planned.
