On a motion by Kurt Thelen, seconded by Sandy Zierden and carried the minutes from April 4, 2022 were approved.

On a motion by Sandy Zierden, seconded by Kurt Thelen and carried the minutes from April 4, 2022 Equalization Meeting were approved.

Fire Chief, Al Fiedler was present. 3 Medical calls and 1 Fire call. Will bill out for the fire call. A fundraiser the department are looking at doing is putting together a calendar. Looking for advertisers. Calendars will be given to each resident in town. Will have a fire prevention message. Can customize calendar with dates and important events. Would the city want to add to it? Bills - Freeport Screen printing, Stearns county chiefs meeting meals, Battery for monitor, and Ridgewater College.

Waste/Water Operator, Tom Valerius was present. Waste Water – Samples taken. PCA are watching wells and monitoring. With reissue of permit looking at monitoring more items. Tom plans to run the ponds like last summer. Ponds are looking good, ice is all off. Tom would like to see the life stations gone through and services. Bill – Drive time.

New Munich Jaycees—Donation was given to the city for the park and veterans memorial. Also asked about having the Flea Markets this summer again. Asked about using city park or the city hall parking lot and council thought the city hall parking lot would be better. Kurt Thelen made a motion to approve having the Flea Market again at the city hall parking lot, Seconded by Ron Doll, motion carried.

Building Permits—Tree of Life-Reapplying for permit from last year. Missed the deadline for an extension. Fence on north side around north deck and NW patio. Worms Lumber-Concrete slab 25x40 on north side of office. Returned concrete to be used for cement pad at Ready Mix plant 40x40. Samantha Herding-Remove deck and door on south side of shed, add fence to enclose back yard, will be made from wood and plastic fence about 120' total, add sidewalk 3x140, replace double doors with single door on shed. Amanda Downes-Moving house onto lot, 42x28 and foundation, add 24x24 garage, patio 12x16 on east side of house. Joelle Niebergal-8x14 cement slab for chain link fence and dog house, SW corner of lot. Setback of 10' from west lot line and 10% of property width on South Side. Motion was made by Sandy Zierden to approve the building permits, seconded by Elmer Boecker, motion carried.

Immaculate Conception Church-Build a 38x63 gathering space onto the west side of church. Do they need a variance will email Susan on this one to find out the better option or a variance or to rezone it commercial.
