Old Business: Graser reported on Broadband updates. Gogebic County is applying for grants to help with the cost of the towers. There is a meeting at NMU in Marquette on Wednesday, concerning installing fibers in the Western UP.

The revised COVID preparedness plan was tabled due to possible new revisions needed.

New Business: A motion was made by Lyons supported by Graser to authorize the signing of the 2021 tax rate request. Motion carried.

A motion was made by Segalin supported by Justinak to adopt Resolution 2021-002- Gogebic County Hazard Mitigation Plan. Motion carried on a roll call vote.

A motion was made by Simmons supported by Lyons to increase the seasonal employee wage from \$10 to \$12 per hour- Erik Tervonen has worked for 4 years as the Township's the seasonal worker. Kangas states he has a great work ethic. Motion carried on a roll call vote.

Segalin is asking for authorization to pay \$3,645.93 for a bill for the Fire Dept. vehicle repair done by Big Fire Apparatus. A motion was made by Lyons supported by Aili-Angus to authorize such payment. Motion carried on a roll call vote.

A motion was made by Lyons supported by Aili-Angus to table the Resolution 2021-003- Board Meeting time change- from 6pm to possible 4-4:30 pm meeting time, until the next meeting. The board would like to see if any citizens have trouble attending at the earlier time.

Supervisor: Kangas checked with the Insurance company concerning any problem with the Fire Dept filling of swimming pools, he stated the insurance agent said there is no problem. The Timber sale extension was signed by both parties. Park and Rec. Committee met-discussed some projects needing to be done. Don Cvengros and another citizen would like to be on the committee as well. Any citizen wishing to be on the committee is encouraged to call the office. The fire numbers are slow going at this point- MISS DIG is still limiting the amount of locates done in a day, the maintenance men are busy with burials and mowing. The Fire Dept. will be asked to help with installing the fire numbers.

Treasurer: Attended a Broadband mtg, PAUD mtg., working on the tax roll, reports that the FD received the \$3,000 grant and has ordered the new SCBAs. The fire dept. also requests new emergency lights for the hall.

Clerk: The summer has been busy with burials so far. MTA picnic is scheduled to be held at the Ramsay Park. The FD refrigerator has stopped working so they will be encouraged to seek out a new/used one. There is an unused refrigerator in the hall basement, which they can have.

Trustees:

Lyons: Asked if the solar stop sign- Vanderhagen/ Airport had been ordered or replaced yet.

Simmons: Attended a Gogebic Range Water Authority meeting, reports that he attended the Waste Water union negotiations, requested a bigger LED sign be put out front and to let the Fire Department use this smaller one.
