North Shore Edge Wrestling Club offered through New Trier Extension is open to all kids in grades K-8. This program will teach wrestling fundamentals and instill values of hard work, self- discipline, and the importance of goal setting. The season will begin **November 7** and end in March. Practices will be held 2-3 times per week for 1.5 hours each on Tuesdays, Wednesdays\* and Thursdays. \*Wednesdays reserved for advanced wrestlers only. The team will compete in 10 optional tournaments and wrestle against other clubs in head-to-head dual meets at local high schools. Tournaments will be on Sundays and will require extra entry fees and a USA Card. No prior experience in the sport is required to participate. At the conclusion of the season, wrestlers will have the option to compete in the 2018 IKWF State Tournaments Series.

## **WAIVER**

## New Trier Extension/ North Shore Edge Waiver, Hold Harmless, and Indemnification Terms

I recognize and acknowledge that there are certain risks of physical injury to recipients of instruction and participation in wrestling club practices, open mats and or competitions, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward may sustain as a result of said participation. I understand that no health examination will be conducted by the North Shore Edge Wrestling Club or New Trier Extension to determine the wrestlerge fitness to participate in the Club.

I release and discharge New Trier Township High School District No. 203, the New Trier Extension Program, , the *North Shore Edge Wrestling Club* and all coaches, assistants, volunteers, officials, agents and employees including the Board of Education, its members, employees, agents, and volunteers (õNew Trier High Schoolö) from any and all claims from injuries, including death, damages, or losses which I or my child/ward may have or which may accrue as a result of receiving instruction and or participation in the club practices and or competitions.

I do hereby fully release and forever discharge *New Trier High School*, the *North Shore Edge Wrestling Club*, and all coaches, Marc Tadelman, assistants, volunteers, officials, agents and employees from any and all claims for injuries, damages or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with or in any way associated my child@s receiving instruction and or participation in the club practices and or competitions.

I further agree to indemnify, hold harmless, and defend New Trier High School from any and all claims resulting from injuries, including death, damages, and losses that I or my child/ward sustain arising out of, connected with, or in any way associated with the activities of the North Shore Edge Wrestling Program.

It is my express intent that this waiver and release shall bind the members of my family, spouse, heirs, assigns, and personal representatives and shall be deemed as a release, waiver, discharge, and covenant not to sue New Trier High School.

In the event of an emergency, I authorize New Trier High School to secure from any licensed hospital, physician, and/or medical personnel any treatment deemed necessary for my or my child/wardø immediate care and agree that I or my child/wardø will be responsible for payment of any and all medical services rendered.

I have read and understand the registration form, including the warning of risk, assumption of risk and waiver and release of all claims.

If any term, covenant, condition, or provision of this registration form is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remainder of the provisions shall remain in full force and effect and shall in no way be affected, impaired, or invalidated.
