## REGISTERED NURSE (RN) JOB DESCRIPTION

### I. RESPONSIBLE TO

- A. The nursing supervisor or director of nurses of a specific unit when referred by California Medical Caregiver Services as a staff relief or private duty to client facility
- B. California Medical Caregiver Services director of nurses

### II. GENERAL JOB DESCRIPTION

An RN referred by California Medical Caregiver Services provides supplemental staff relief and/or private care to assigned patients in client facilities, acute or otherwise. As such, he/she performs general nursing care and treatment to the ill injured which requires substantial specialized knowledge, judgment and nursing skills based upon principles of health care. He/she will make decisions based on education, prescribed guidelines and nursing experience.

### III. SPECIFIC JOB FUNCTIONS

Application of nursing procedure include, but are not limited to the following:

1. Assessment, planning and implementation of health care needs;
2. Observation, evaluation and recording of patient's condition, reactions and notifying the head nurse of any significant changes or unusual occurrences;
3. Administration of prescribed medications and treatments in accordance with approved nursing techniques;
4. Preparation of equipment and assist physicians during treatments and examination of patients;
5. Assist with patient's rehabilitation by meeting their physical, emotional and spiritual needs;
6. Take and record vital signs;
7. Provide comfort measures (i.e. administer oxygen, change dressing, insert and irrigate urinary catheter)
8. Receive, transcribe and carry out doctor's orders;
9. Obtain specimens;
10. Admit and discharge patients;
11. Receive and give reports;
12. Provide post-mortem care;
13. Hang intravenous fluids, piggy backs and blood;
14. Order drugs, solutions, equipment and maintain records of narcotics

### IV. SPECIALTIES

An RN who has acquired special skills and competency through additional education and training may be assigned to special areas such as: intensive care, coronary care, step-down units, emergency, operating, psychiatry, pediatrics, recovery, labor and delivery rooms as charge nurse and as team leader.

### V. RESPONSIBILITIES

1. Accept assignments they are qualified for ;
2. Perform competently in areas assigned;
3. Comply with:
  - a. Institution's policies and procedures
  - b. State regulatory acts; and
  - c. Personnel guidelines and dress codes set by the clients and California Medical Caregiver Services
4. Provide total patient care safely and competitively within the job description and defined functions;
5. Give prompt and effective care treatment per physician's order;
6. Chart accurately and accordingly to client guidelines;

7. Function under the guidelines of Title 22 at all times;
8. Assist California Medical Caregiver Services in determining skills and specialties by providing necessary information and documentation;
9. Be prompt and notify California Medical Caregiver Services of inability to accept assignments due to sickness or an emergency no less than (2) hours before reporting time;
10. Assist California Medical Caregiver Services in determining skills and specialties by providing necessary information and documentation;
11. Inform California Medical Caregiver Services of availability
12. Attend orientation and in-service programs
13. Keep communication lines open with direct supervisors in areas assigned and California Medical Caregiver Services by informing them of problems and other concerns affecting their efficiency and performance
14. Maintain a pleasant and caring attitude at all times
15. Provide California Medical Caregiver Services immediately of any changes including address and telephone number

#### **IV. EVALUATION**

Performance evaluations are conducted ninety (90) days after initial assignment and annually thereafter by the director of nursing services. This evaluation is done with the input from others in supervisory and administrative capacities.
