# GUEST SPEAKER: CANDIDATE FOR MAYOR CONGRESSWOMAN KAREN BASS

The speaker at our January 19, 2022 Meeting will be Congresswoman and Mayoral Candidate Karen Bass. She has been a member of the United States Congress since 2011, currently serving her sixth term, and previously served in the California State Assembly. She was the first-ever African-American woman in U.S. history to serve as Speaker of any state legislature. During her time as Speaker, California endured one of

the worst economic crisis since the Great Depression. As Speaker, she had to lead the assembly through the financial emergency by passing legislation to help Californians through the crisis. Due to her leadership, she was one of four legislators to be awarded the John F. Kennedy Profile in Courage Award.

Congresswoman Bass currently serves on the House Foreign Affairs Committee and assists with Global Health and Human Rights issues including COVID-19. She also serves on the Judiciary Committee. Her work includes criminal justice and prison reform and passing the Equality Act of 2020 to provide anti-discrimination protections for LGBTW people with employment and housing.

# A NEW YEAR - BUT THE SAME OLD METRO WANTS PUBLIC INPUT, BUT TELLS PUBLIC NOTHING!

The Sepulveda Transit Corridor Project is moving forward but Metro wants to keep you in the dark. Metro held their first public scoping meeting on December 7th. It was shameful. They want public comment on their six alternatives but withhold meaningful information. It's all a sham to make Metro look interested. They even said they would not answer questions.

A day before Metro's scoping meeting, SOHA sent them ten critical questions. How and when will concepts be refined? How will the public-private partnerships work? What are latest technical details? How much does each alternative cost? What is Metro's available budget? These are simple questions and Metro should have answers at their fingertips. We asked for answers in a week. We never heard back from Metro. We never do.

Without details, no one could support any of Metro's six alternatives. But SOHA does oppose one of them, the ridiculous Alternative 4 with elevated trains operating above Sepulveda Blvd in the Valley. SOHA told Metro this alternative will destroy Sherman Oaks. Yet Metro continues to study it. Why? Because they don't listen!

Here are SOHA's thoughts on Metro's six alternatives. None are acceptable yet and one is totally unacceptable. Metro's last scoping meeting is January 22nd. SOHA will be telling you how to make comments.



#### **ALTERNATIVE 1 - Monorail along 405 with Electric Bus Connection to UCLA**

ACCEPTABLE - ONLY IF route realigned to 405 median (versus east shoulder) in Valley

AFFORDABLE - Possibly buildable with currently available Metro budget

**SHORTEST SCHEDULE -** Quickest to build with no tunneling

#### **ALTERNATIVE 2 - Monorail along 405 with Automated People Mover Connection to UCLA**

ACCEPTABLE - ONLY IF route realigned to 405 median (versus east shoulder) in Valley

AFFORDABLE - Possibly buildable with currently available Metro budget

SHORTEST SCHEDULE - Quickest to build with no tunneling

#### ALTERNATIVE 3 - Monorail along 405 in Tunnel Under UCLA

ACCEPTABLE - ONLY IF route realigned to 405 median in Valley and no tunneling under Bel Air

**UNAFFORDABLE -** At least one billion dollars more than available Metro budget

**LONGER SCHEDULE -** Three-mile tunnel under UCLA adds at least two years

#### ALTERNATIVE 4 - Heavy Rail Subway on Westside but Elevated in Valley on Sepulveda Blvd

**UNACCEPTABLE -** Ridiculous elevated trains in Valley - TERMINATE THIS CONCEPT NOW

**UNAFFORDABLE -** At least four billion dollars more than available Metro budget

LONGER SCHEDULE - Nine-mile tunnel under Westside/Sepulveda Pass adds at least four years

#### ALTERNATIVE 5 - Heavy Rail Subway on Westside and under Sepulveda Blvd in Valley

ACCEPTABLE - ONLY IF subway route through Sepulveda Pass realigned under 405 freeway

**UNAFFORDABLE -** At least seven billion dollars more than available Metro budget

**LONGEST SCHEDULE -** Fourteen-mile tunnel adds at least five years

#### ALTERNATIVE 6 - Heavy Rail Subway on Westside and under Van Nuys Blvd in Valley

ACCEPTABLE - ONLY IF subway route through Sepulveda Pass realigned under Beverly Glen Blvd

**UNAFFORDABLE -** At least seven billion dollars more than available Metro budget

LONGEST SCHEDULE - Thirteen-mile tunnel adds at least five years


# **2022 REDISTRICTING MAPS**


Three separate Redistricting Commissions redistricted our Los Angeles City Council, Los Angeles County Supervisorial, Federal Congressional, State Senate, and State Assembly Districts in 2021. Our Sherman Oaks Community is whole in each of our five new Districts.

We retain City Councilwoman Nithya Raman. The new district takes effect on January 1, 2022.





Our County Supervisor, Sheila Kuehl is not running for reelection in 2022. Our new Supervisorial District 3 takes effect at the beginning of 2023, when we've elected a new supervisor. Our Congressman, Brad Sherman, will run for reelection in new District 32 in 2022 because he retains about 80 percent of the District. The new district takes effect at the beginning of 2023.





Our current State Senator, Bob Hertzberg, is termed out in 2022. Our new Senate District 27 takes effect at the beginning of 2023. Senator Henry Stern currently holds District 27, but is running for Supervisorial District 3. If he wins, we must elect a new Senator. Our current State Assemblyman, Adrin Nazarian, will run in new District 44. Rumor has it Assemblywoman Laura Friedman will also run in District 44. Our new District takes effect at the beginning of 2023 after the 2022 elections.





# **ANOTHER LEGISLATIVE YEAR**

The legislative committee of SOHA hopes the New Year inspires our state legislators to introduce good housing bills that will address our affordable housing problem, make communities healthier and better and leave single family neighborhoods intact. At the end of 2022, redistricting might change our state legislative districts. We will inform all of you of any changes to our representation.

Regarding SB 9, our committee worked last year with Councilman Paul Koretz to introduce a motion that would put in place guidelines for implementing SB 9 to protect our communities from the more destructive elements of this terrible bill. SB 9 allows some local control on certain provisions of the bill as long as a city officially acts on them. The motion was introduced and moved by Councilman Bob Blumenfield and Councilman Koretz and seconded by our Councilwoman Nithya Raman. The motion was then sent to the Planning and Land Use Committee where it was waived out of committee by Councilman Harris Dawson, but with only a few days left in the session it failed to be sent for a full Council vote by Council President, Nury Martinez. We have asked her office to agendize this motion immediately upon the Council's return. It is very important for the city to vote on this motion. Until this motion is approved by the City Council, our city has no control over enforcing objective design and zoning standards on SB9 projects in single-family neighborhoods. Many cities throughout California have already passed Ordinances addressing the implementation of SB 9, Los Angeles should have been among them, passing something before the end of 2021.

It is important for all of us to keep alert to what is going on in Sacramento because every year we lose more and more individual rights. Currently with SB 9 and SB 10 we have no voice in what gets built in our neighborhoods. There is no public input or notification. With the reality of climate change, these new laws do not allow for California Environmental Review. This can mean the loss of our trees, as backyards are filled with more housing. Also, none of the bills coming out of Sacramento even address affordable housing. We see a better solution for adding more housing, by building in our underutilized commercial corridors, rather than devastating our single-family neighborhoods.

Another important note: The Voter Initiative, that seeks to amend the State Constitution granting land use authority back to individual cities and not to Sacramento, has until the end of April to collect 1.3 million signatures. It is off to a great start, and if you are interested in getting your neighbors and friends to sign on to this petition, please go to their website ourneighborhoodvoices.com. Her personal interests include extensive international travel and being blessed with three of the world's most wonderful canine companions, all rescues. She enjoys living in Fashion Square, loves our community and appreciates all who help keep Sherman Oaks a wonderful place to live.
