Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at LKSAGE@aol.com or by phone (503) 840-4303 (cell).

SITE INFO: This trial will be held in two rings indoors on packed dirt. There will be crating on the elevated spectator area around the competition. Crating space is somewhat limited, so we ask that you please conserve on space so that everyone who needs crating will be able to find a spot. Please bring chairs, crates, water and clean up tools for your dogs. **You may set up your crating space Thursday afternoon beginning at 4 pm.**

Please DO NOT crate along the railings or ring side. There is also covered crating outside along the building. Also a reminder that this agility trial is being held in conjunction with the Chintimini Kennel Club breed show. Note, **there is a \$5 parking fee for day parking all three days**. Chintimini Kennel Club has added another unloading area. If you are parking in the Day Parking, please unload at the main entrance to the Calapooia Arena which is on the east side of the building. They also ask that the RV and overnight folks unload through the RV entrance.

DIRECTIONS TO THE TRIAL SITE:

From the North, on I-5: Take EXIT 234A toward Fair/Expo/Knox Butte. Turn slight right onto Airport Road SE. Turn right onto Pacific Blvd. SE/OR-99E. Stay straight to go onto Knox Butte Road E. End at 3700 Knox Butte Road E on the right.

From the South, on I-5: Take EXIT 234 toward Fair/Expo/Knox Butte. Turn right onto Knox Butte Road E. End at 3700 Knox Butte Road E on the right.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

We will also use the white board for sign-ups. If you can, please volunteer for the class(es) that you can help with. CRAC will issue raffle tickets to each worker to be used in a DAILY workers raffle which will have many wonderful things and services. The workers raffle will be drawn each day in the early afternoon. <a href="mailto:Extra special items in the raffle will be drawn on Sunday after 1pm. There will be a special raffle draw which will occur daily for those volunteering as chute setters or leash runners. Prizes must be claimed by the conclusion of the trial on Sunday.

CONFLICTS: We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a "C" instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

MOVE-UPS: The deadline for move-ups is Monday, March 28, 2016 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

CLASS RUNNING ORDER: The Preliminary Running Order is contingent upon move-up entries not yet received.
