## March 5<sup>th</sup>, 2018

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Pat Nathe, Ron Doll and Bryan Kasten were present.

On a motion by Ron Doll, seconded by Pat Nathe and carried the minutes from February 5<sup>th</sup>, 2018 were approved.

Fire Chief, Allen Fiedler was present to inform the Council on one medical calls last month. With the cold weather, the suggestion was made that residents and businesses should be checking the water temps of their faucets, if needed the resident or business owner should let the water trickle. A letter will be sent out stating if you let your water trickle please call the City to let them know and bills will be adjusted.

Wastewater charges for seasonal watering will be a volume based on the average monthly water usage of January, February and March and this usage will be utilized to determine the charges for June, July and August wastewater charges.
