Minutes of December 4, 2017

The Huntington Township Trustees met in regular session at 7:00 PM at the Township Hall. The meeting was called to order with the pledge of Allegiance by Walter Rollin. Also present were: Jed Lamb, Robert Holmes, Dimitri Szynal, Tony Pluta, Dennis Finkel and Sheila Lanning.

Motion by Lamb with a second by Holmes to approve the minutes of the November 11 2017 regular scheduled meeting as written. Roll call: 3 yeas. *Motion* by Rollin with a second by Lamb to approve the November financial reports showing year to date revenue of \$472,347.37 year to date expenditures of \$410,981.64 and bank balance of \$277,473.90. Roll call: 3 yeas. Warrants (8044-8069) and charges totaling \$8,384.63 were examined and approved for payment.

Rollin reported: Zoning Commission member Denzil StClair should be asked if he wishes to remain on the Board. Finkel to ask Chairman Bob Budi to ask StClair. There is no December Zoning Commission meeting scheduled. Lanning to get list of Board member with terms ending December 31st. Township Hall furnace repair not permanently fixed, repairman eliminating possibilities. May be the heat exchanger. The oil burner furnace in the garage is getting temperamental. Picked up 30 day temporary tag for 2009 International. Memorandum title brought back with truck from dealer. Finkel put radio in International, fixed tarp and would like a toolbox. *Motion* by Rollin with a second by Lamb to authorize up to \$500.00 for the purchase of a tool box for the International truck. Roll call: 3 yeas. Baker Road repairs by County and State are done as far as they are concerned. Holmes received a few complaints, spot by driveway of corner house (Griggs and Baker), and there was a sewer grate partially covered. Holmes fixed the covered grate. Pluta stated there are 3 spots that were missed. Fire District talking about adding on bays to the building.

Jed reported: Rural Water Board meeting coming up. Received the requested salary information from Rural Water. They requested and were given salary information for Trustees and Fiscal Officer in return. There are some people on the Rural Water Board making \$5,000.00 plus a year. Vaccination clinics in December are posted on Facebook.

Holmes reported: Sherriff reports totaled 26 in November. Information about a burglary on Clark Road put on Facebook. Playground fence up by this Thursday. November Ambulance meeting minutes available. Road Closures posted on Facebook. John Sabo with Lorain County Health District called about the Landfill monthly monitoring reports. Lanning to contact Sabo, Rollin to contact Bill Brown with Fire District for reports. Wellington Mayor holds public talks at Bread-n-Brew, very interesting. Forty-Five people asked for help through the link program.

Fiscal Officer reported: Playground checklist given to Szynal. Emailed SWAC minutes to Trustees, per last Lorain County Township Association meeting the minutes were not getting sent out. Attendees to the Lorain County Township Association Christmas party have been registered. Received letter from Ohio Department of Taxation that the monthly remittance of employer withholding taxes will go to quarterly in January 2018. Records show balance due
