The purpose of the meeting was to hear public comments on the proposed 2024 budget. Hearing no comments or questions there was a *Motion* by Rollin with a second by Holmes to close the Public Hearing. Roll call: three yeas, public hearing closed at 6:54 PM.

Trustee Meeting of July 17, 2023

The Huntington Township Trustees met in regular scheduled session at 7:00 PM called to order with the pledge of Allegiance. Attendees: Robert Holmes, Jed Lamb, Walter Rollin, Sheila Lanning, Matt Combs, TJ Denes, Carl Strekely and Jennifer Pierce. *Motion* by Holmes with a second by Rollin to approve the minutes of July 5th, 2023 as written. Roll call: three yeas. Checks 10369-10376 and payments totaling \$22,923.41 were approved for payment. *Motion* by Holmes with a second by Rollin to authorize the 2024 Budget as presented with estimated Revenue of \$502,260.00 and estimated Expenditures of \$709,494.92. Roll call: three yeas.

COMMITTEE REPORTS:

WATER BOARD- Lamb: attended Board training and learned about harmful algae blooms and macro invertebrates.

LORCO- Lamb: unable to attend meeting 7/13/2023.

AMBULANCE- Holmes: first use of helipad went well, Huntington runs for June 5, year to date 46, runs for the District for June 113, year to date 714. Miles for District in June 3,213, year to date 22,451. Maintenance costs for June \$293.80, year to date \$17,390.74.

FIRE- Rollin- no word on radio grant, trying to get the radios.

OPWC & SWAC- Combs: Stewart Road culvert replacement cost sent to Don Romancak \$13,860.20. Working on getting estimate for another culvert on Stewart. County is helping with application for OPWC round #38 money. Lamb: received the Geauga Highway revised quote subtracting stone and adding MAC 3000.

CEMETERY- Rollin: Still working with TC Energy on Cemetery extension, will complete forms sent via email from US Crossings and agt_com. Looking into small grant available through the State. ROADS- Combs: finishing up Rochester Township than will patch in preparation for chip/seal. Carl Strekely: there is a hole adjacent to my property that needs patch. Lamb: the sign moved on Stewart Road was put back into original location. TJ Denes: thank you for putting the sign back, did you get OOPS when the sign was moved. Combs: no.
