Finals Races include two runs (one each in the Coliseum and Barn 6). Rider incentives (Juniors - 15& Under/Adult - 16-49/Senior - 50&Over) are sidepots for the Finals Races and the Youth (12&Under) race in Barn 8 are based on the rider's age as of Jan 1, 2017. Gold Card and Youth race will be run in Barn 8 and you will be drawn on the day that you are not competing in the Finals Races. Also, please indicate if a horse is being run in the Invitational ShootOut or BBR Futurity so that it can be drawn accordingly. Insurance Race (in Barn 6) is open to all World Finals entries.
