- 🍏 Email was sent out with minutes from May 28, 2020 meeting. They were approved via email and posted to the township web site.
- 🍏 Gina W. called meeting to order 7:00 pm:
 - ✂️ Gina W., John T., Rachel B., Bob B., and Jennifer W. present. Public: Keith and Jill Leslie present
- 🍏 Pledge of allegiance recited
- 🍏 Keith and Jill Leslie: Is the copy the Leslie's have of the residential site plan up to date and complete? Yes. Requesting more plans information.
- 🍏 Rachel: **Treasurer's report** as of June 24, 2020:
 - ✂️ Have \$209,633.39 total.
 - ✂️ Payments were \$13,031.11, Michigan Chloride for brining, \$2,823.97 and Rudert Insurance for 3,147.00 were largest bills.
 - ✂️ Bob motioned to accept and pay bills, John 2nd, roll call, passed
- 🍏 Bob: **Zoning report:**
 - ✂️ 2 Zoning apps: 1) a new residence on 1 mile, they gave a corrected site plan
2) 8585 Baseline – in repairing water damaged cabin porch they will add on to porch. Building department pointed them to get a zoning application.
- 🍏 John: **Planning Report:**
 - ✂️ Next planning meeting in July
- 🍏 Jennifer: **Clerk's Report**
 - ✂️ New election inspector requested to be considered, and also be considered for deputy clerk. John motioned to accept Tiia Hollingshaus on a 2 month trial basis, on an hourly wage, for deputy clerk, and to accept Tiia as an election inspector. Gina 2nd. Roll call, passed.

 - ✂️ Voting logistics. Discussed.
 - 🍏 State mailed absentee voter ballot applications sent out. One board member stated 3 were mailed from their household; yet only one, delivered by hand to clerk, has been received. The concerns are the mandated and forced to accept changes put in place, and that there are different cases of voter's not being mailed forms, not receiving forms, and returned forms not making it to the clerk's office. Since meeting, 10 envelopes have been received, including the noted missing applications. The dates on applications were from June 20 thru June 22. They were all received June 25th.
