Ample attendee parking is located on the west side of the grounds. Upon arrival vendors will enter through the Miller Road entrance.

Late applications will be accepted. However, acceptance into the show will be determined by availability.

This is an open air event. Vendors are responsible for providing their own tables and overhead covering. Canopies and overhead coverings must be weighted or secured in the event of wind gusts.

We reserve the right to make last minute changes if necessary.

**Upon Arrival:**

Your name badge and last minute information will be in your vendor packet when you arrive. Please wear your name badge during the show. You will also need your name tag to gain access from the vendor parking area during show hours.

**Setup time:**

Friday, October 11, 6:30 – 8:30 a.m.

**You must have your booth set up no later than 8:30 a.m. Friday morning.**

**Breakdown time:**

Breakdown starts immediately after the event on Sunday, October 13, 2:00 p.m.

**Security:**

Security will be provided overnight and during the show. Dealers are responsible for securing their spaces and West Valley Rock & Mineral Club is not responsible for losses during the show.

**Cleanliness:** West Valley Rock & Mineral Club request that dealers be responsible for cleaning up their designated area.

**Parking Space:**
