## **Clinic Corner**

On behalf of the Clinics Committee, I want to thank Past Superintendent Bob McGeever for presenting our first clinic of the year, "Operations as a Pull System using JMRI OperationsPro". As many of you are aware, the JMRI (which an acronym for A Java Model Railroad Interface) software for model railroading, is free software developed by fellow modelers and members of the NMRA. If you are interested in obtaining this software, go to www.JMRI.org to learn more about the software and get free downloads of it. While I have personally used the Decoder Pro part of JMRI to aid me in programming DCC locomotives, I confess to having had limited knowledge of the remainder of JMRI. Bob's clinic clearly showed that there is a lot more available in this software. I encourage all of you to learn more about JMRI, and hopefully you will contact me about presenting a clinic on other parts of the JMRI package in the future.

I will be presenting a clinic titled "Kit-bashing Cornerstones" on October 4th to show some of the ways I have kit-bashed (i.e., built and modified) several of the popular HO Walthers Cornerstone Models for a customer/friend. He models the Wisconsin Central Railroad as it existed previously within our state. I know that many of you may have purchased structures in the Cornerstone series, and perhaps have yet to build them, so I hope this clinic will give you ideas for constructing and modifying these kits to suit the needs of your layout. While these models I built were done in HO, I hope that you will see that many of the things I will present can also be applied to the Cornerstone N scale models as well.

As I mentioned in last month's column, I already have an excellent clinic lined up for November by someone outside the SCWD. Steve Miazga, of the WISE Division, from Waukesha will be presenting on November 1st. Steve models in N scale, has had two excellent articles on his layout published in *Model Railroader* within the past year, is current Editor of the WISE Division's "Owl Car" newsletter and a member of their Board of Directors, and has allowed several SCWD members, including myself, to experience the fun of operating on his layout. While I don't want to give the exact title of Steve's clinic now, I know it is a new one and that is not specific to N scale. (I will reveal the title in the November column.) So I hope everyone will "zoom in" to enjoy Steve's clinic in November.

As I wrote last month, if you are interested in presenting a clinic or have someone to recommend, please contact Bill Clancy, Ken Hojnacki or, so we can start working on getting those clinics lined up for the rest of the 2020-2021 season. And we welcome any feedback or suggestions you may have to improve our clinics, following our October and subsequent meetings. See you virtually on October 4th!

Model Railroad Operation (frequently called OPS) is a fun and interesting role playing game where the players (operators) use model trains to simulate the movements of real trains and the actions of real railroad employees. Many of our SCWD members participate each month at multiple layouts to enjoy this fun and stimulating practice of critical thinking and problem solving in the context on railroad operations!

Last month, a group of SCWD members started a project to introduce more of our members to the enjoyment of, as our wives call it, playing trains. We have been engaged in operating sessions for as many as 20 years or more and would like to get more of you interested.

We are beginning by introducing interested members to the basics of operations by using a series of lessons revolving around a set of puzzles. You will learn the method of **solution notation** that will be used throughout the puzzles to come, to show your solution to each puzzle.

Join The 75+ SCWD members and members from other Midwest Regional Divisions who are participating in the SCWD listserv. You can expect 4 - 6 photos of railfan photos or model railroad photos per week on average, as well as SCWD announcements, and a monthly Mystery Photo contest. The listserv has been running this since April 2012 ( that will be 7 years this coming April), and it has been quite popular.

The listserv is a one-way email broadcast to you, not a social media type service. The emails are sent in bulk, but as a BCC: type email, so no one knows the identity or email addresses of the participants. Once a month, I send out a Mystery Photo, and then if you know the answer or do a little research , you send an email back to <u>scwdmemberlist@frontier.com</u>. About a week later, I post the answer and a list of the names of those who sent in answers that month. The answer often includes parts of the best correct answers received.

The meeting of the South Central Wisconsin Division Board of Directors was called to order at 7:39 pm by Superintendent Phil Hottmann. Phil Hottmann, Bob McGeever, Dr. Bill Clancy, Jim Feldman, Dave Dingman, Steve Preston, and Bill Mitchell were present. David Down was unable to join the meeting.

#### Minutes:

Motion by Dr. Clancy, second by Dingman, to approve the minutes of the July 13, 2020 meeting. Motion carried.

#### Paymaster Report & Update on the Concerns for the Annual February 2021 Model Railroad Show and Sale

Bob McGeever presented the 2019 - 2020 SCWD Annual Financial Summary Report for the fiscal year August 1 to July 31. The discussion was then focused on the 2020 - 2021 budget. The unknown factor for the 2020 - 2021 year is the annual February 2021 Madison Model Railroad Show and Sale. Vendor invitations have been sent out. Bob is determining if exhibitors are interested in participating in the show. The maintenance of the mailing list is an expense. A number of different budget options were discussed. The decision date to hold the February train show and sale is October 31, 2020. The proposed budget for 2020 - 2021 does not include the February train show. The budget will include the rail school, annual SCWD excursion, banquet, and picnic. If the train show is scheduled, the 2020 - 2021 annual budget will be revised. One cost that will be incurred this year will be for the maintenance of the facility becoming available for February and also monitoring the COVID-19 rules that are imposed on public gatherings in Dane County. Currently, the Exposition Center is still designated as an alternative hospital site in the event.

Motion by Dr. Clancy, second by Dingman, to approve the 2019 - 2020 Annual Financial Report, proposed 2020 - 2021 Budget that does not include the Madison Model Railroad Show and Sale, and the Paymaster's Report for the month ending July 31. Motion carried.

#### **Committee Reports:**

There were no committee reports for August. Our standing committees have been somewhat inactive due to the COVID-19 situation.

#### Old and New Business - Topics of Discussion:

**Virtual Meeting Agenda for September:** The September 13 Monthly Meeting of the SCWD will be a "ZOOM" meeting. At least one clinic and one virtual layout tour has been scheduled. Clinics and layout tours need to be scheduled for the rest of our monthly meetings. A clinic has been scheduled for the November meeting.

**Monthly Membership Meeting:** A "Virtual Meeting Survey" will be sent out to the membership to determine what types of clinics and layout tours would be of interest. Steve Brist will be contacted to determine how to include our past SCWD Youth Group members. A possible invitation may be sent "To the Parents of past SCWD Youth Group Members". National Model Railroad Association youth participation guidelines are still being formulated. Clinics and layout tours need to be scheduled for the rest of our monthly meetings. A clinic has been scheduled for the November meeting.

**Test Meeting included with August ZOOM "Happy Hour":** Instructions will be sent to the membership that will include how to use "ZOOM": how to download and the application to a personal device, how to open up the link to the meeting, how to turn on "Video" and "Microphone" if the device has video and microphone capabilities. This "Test Meeting" will be in conjunction with the Friday, August 28 virtual "Happy Hour" that will start at 5:00 pm. All members will be encouraged to participate in this "Test" and "Happy Hour" event so that joining the September 13 "Virtual" monthly should keep technical problems at minimum.

**Special Interest Groups - Operations:** Steve Lanphear has started sending out "Inglenook" switching puzzles to people who are interested in solving these switching puzzles. Steve sending out "Modelers Corner" updates that are sent to him by SCWD members. If a person wants to receive the "Inglenook" puzzles and/or "Modelers Corner" communications, that person should contact Steve directly. His contact information is in the RED BOOK.

**September 14 SCWD Board of Directors Meeting:** Invitations will be extended to Mike Vivion and Ken Hojnacki to join our September meeting. Other members of the SCWD may also join the meetings. Contact Phil Hottmann (in the RED BOOK) for an invitation.

#### Support of Small Businesses:

Our local hobby shops are being affected by the Dane County COVID-19 changing rules. Many of us are working on our layouts and do need supplies. Most hobby shops are now open with limited hours and occupancy limits. These hobby shops offer gift certificates or gift cards for later purchases. Call ahead for store hours and guidelines for each hobby shop.

#### Adjournment:

A motion was made by Preston, second by McGeever, to adjourn the meeting. Motion carried. The meeting was adjourned at 8:41 pm.

The auditors have come and gone; their report for 2019 was a "clean" audit, applauding the NMRA for excellent accounting and management procedures.

And right now your Board is in the process of discussion Layout Command Control issues with the OpenLCB team, the group who developed LCC.

So that's a quick potpourri of items of interest to members; it's been a busy summer despite the COVID-19 issues that have plagued us for months. We look forward to the day when we can gather together to run trains, learn, talk trains and revel in the fellowship we all treasure. Until then, stay safe!

#### Highlights of the July Annual Board of Directors Meeting

The Winter Board of Directors meeting was held virtually, using GoToMeeting software, in Atlanta, Georgia, on July 11, 2020. These are some highlights of the meeting.

Please note that this is an unofficial summary of what took place at the meeting. The official minutes, authored by NMRA Secretary Rick Coble, will be posted on the NMRA website, <u>www.nmra.org</u> shortly.

- Although COVID-19 delayed the annual audit report, it was completed in August and once again there were no problems identified.
- The St. Louis group who had organized this year's cancelled annual convention agreed to organize the 2022 annual convention. They take over for the Birmingham, England, convention which was cancelled due to major sporting events in that city.

- The NMRA Board confirmed that the 2023 convention will be held in Dallas, TX.
- At-Large Worldwide Director Jack Hamilton announced that there will be a series of virtual Region Leadership Seminars this Fall for representatives from each Region. Dates for the meetings are currently being selected by the Board and the Regions. Major issues and topics will be discussed. Region presidents have been asked to select representatives from their Region to attend. A newly penned "Region Presidents' Handbook will be distributed during the opening session and discussed in detail in later sessions.
- The Board accepted a motion to adjust the borders of the Niagara Frontier Region, transferring the following counties to the Northeastern Region: New York: Broome, Chemung, Cortland, Schuyler, Tioga and Tompkins. Pennsylvania: Bradford and Tioga.
- The Board voted to rescind a motion it approved last Winter to create a separate Membership Department. The Board felt the motion was in direct conflict with the existing organization structure.
- NMRA Canada Director John Bate agreed to take over the editorship of the *NMRA eBulletin* when Vice President/Special Projects Gerry Leone ends his term next July. The Board also voted to eliminate the Vice President/Special Projects position at that time.
- The Board voted to extend the deadline for National office nominations to October 31, and that the petition process will run until November 30. Electronic petitions will be allowed.
- The Board adopted a policy that for all online presentations sponsored by the NMRA, an intellectual properties agreement shall be executed by the presenter prior to their presentation.
- The Board approved a resolution thanking the NMRAx team, the 2020 Convention team, and the 2022 convention team for their efforts.






