OREGON AREA VOTING PROCEDURES

A motion is made:

- If it does not receive a second, it dies. After a second, debate is opened. If a registered voter calls for the question, a second will be required, or debate resumes.
- A question must be called in turn at the mic.
- If the question is seconded a 2/3 majority will end the debate, or debate resumes.
- If the question is not called, debate will go on until there is no one at the mic. Once debate ends, a sense of the group will be taken by a simple majority, to vote or table.

A motion is voted on:

- If it involves expenditure of area funds, the finance committee will be asked to report. It requires a 2/3 majority to pass.
- The losing side will be asked if they wish to speak to their position. The winning side will be asked if there is a motion to re-vote, and requires a second. A simple majority is required to re-vote.

A motion is reconsidered:

- Full debate, pro and con is resumed (please limit discussion to only new considerations).
- The question may again be called, seconded, and requires a 2/3 majority to end debate.
- A sense of the group may be taken by simple majority, to vote or table.
- If voted on, the motion must have a 2/3 majority to pass.

Debate has ended.

 Debate on a tabled motion will be resumed under old business at the next assembly, and the voting process will be the same as above.

Old Business

Item # 1 - Corrections Conference Travel

Submitted by: Oregon Area Corrections Chair

Motion:

 To fully fund a member of the Corrections Committee to the National Correction Conference. Funding not to exceed \$1500 annually.

Intent/Purpose:

 To allow the Corrections Committee to network and gain knowledge from other Correction Committee members in AA.

Current Practice:

Corrections Committee is not currently funded to attend any conferences.

Budgetary Impact:

 The budgetary impact will change every year depending on where the Conference is being held. The 2017 National Corrections is in St. Louis, MO. Registration, lodging, airfare and meals is estimated to be about \$1000 Motion read by Roberto F., Area Corrections chair.

Roberto F., Area Corrections Chair: Now, I'd like to make a clarification. Last assembly, when we were speaking with this motion, there was some confusion on whether we were asking for funds... more funds. And I want to clarify, we are not asking Oregon Area for more funds, we are just asking permission to use our available funds for this endeavor. I hope that answers some of the questions for you.

Perry, Area Access Chair: I had a question about the rotation of the meeting. It sounds like one year you're going to have the chair and the next year you're going to have the co-chair? Wouldn't that actually remove one person from going to this committee meeting? Because that rotation actually gets rid of the co-chair every other year.

Roberto F.: The idea is to allow, and at the start is where it's going to be different, but the idea is to allow the corrections committee, either the chair or the co-chair, to have two continual years of participation. So the only one that's not going to be doing two years in this case, would be me. I would go this year, next year the corrections co-chair would go, that same year.....I really have it all really well in my head....the idea is that someone in corrections will be going two years concurrently. So the third year the corrections co-chair would go, and then they would be the corrections chair, and then they would go, and then they would be the corrections chair, you see so there's some continuity in case there's things at the conference that get's left undone, then there's some continuity.

Joel, GSR Friday Night Young People's Group, District 19: My question is why this motion...it seems like this would fall under trusted servitude. Is there....

Roberto F.: That has been one of the debates. If this were something that we were doing that cost \$200, we feel that you trust us as your trusted servants, and you would allow us to do it. The amount, and the scope that we are going to be doing something outside of the regular things that we do, we wanted to offer transparency. We'd rather ask for permission than for forgivness.

Marissa, DCM District 12: This may be a little redundant, but I just wanted to be absolutely clear, so we're not asking for an increase in budget for attendance, but are we asking that there would be an increase in budget in the future, if there wasn't a surplus? Or would that have to be a separate motion? Roberto F.: Right now we have the monies, in the future I do not know. If that happens, we will approach the body again with a motion to maybe up our budget. But right now, we can do it.

Lauri, Alt-GSR Downtown AM Group, District 19: Just as a clarification to what Perry came up to the mic and said, the motion says to fully fund a member of the corrections committee to the national conference, it doesn't say chair or co-chair, it just says a member.

Rob B, GSR District 4: Fortunately, I server for a very cerebral group, they have a couple of questions, one was answered just a minute ago, but the first one here, is the national corrections conference AA approved.

Roberto F.: A little background about this, GSO approached a few of the correction committees in the United States because they felt that there might be a need for us to get together nationally to share our experience, strength, and hope. As a matter of fact, they laid the foundation and support to be able to do this. We in Oregon Area, Kirk especially, our past chair, has been involved in numerous conference calls that lasted hours to set the foundation for this national conference. Now it's becoming, it's here. You folks contributed \$200 last year to seed this at the beginning, then it will be self-supporting. We would not just like to attend it.

Dave, GSR District 21: This asks for \$1,500 annually, if they've got the money, and they're willing to spend the money out of the budget they have, I think this motion is just trash.

Brandon, District 26: I took this motion back to my group, and they had a lot of questions, a laundry list of questions, more information than I was able to give them. So I emailed Roberto and he emailed me back some really good answers to the questions. I took them to my home group and it completely turned the way that they were viewing this motions. The most important thing was initially it looked like the motion was asking for more money, but clearly they're just asking to use money they already have. At that point it was a no-brainer. I just want to thank Roberto for his response to my email.

Kathleen L., GSR Sicker Than Most, District 2: My question is, what is your current budget for this? **Roberto F.**: Actually, one of the questions I guess we could first ask, is for Shane to come up here and say do I have the money?

Shane C., Area Finance Chair: We have the money.

Roberto F.: And that means that we have the money in the committee. If you look at the report here, we have been, because we've gotten a little more efficient at what we're doing, we've had somewhat of a surplus in our budget. The math that I did, I'm sorry, I can't give you the exact numbers, but I figured that we could still do the conference, and still do the service work locally that we do to travel to districts to share this, and still be in budget. The number is, I have on Corrections, \$4,000.

Diane, GSR District 15: I wanted to say that this is a fabulous idea, almost a no-brainer. The money's already there, we've got willing servants, and corrections is extremely important, so on that note I'd like to call the question.

Jim F., Area Chair: You can't call the question because you spoke to the motion first.

Cindy, GSR Drifters by Sea, District 2: I would like to call the question.

Jim F.: There was somebody at the back mic before the question was called, so if you'd like to speak to the motion...

Esther, DCM District 22: I still have a question on the budgetary impact. If the funds are already in the budget and you're just asking to use existing funds, wouldn't that mean that there's no budgetary impact. So I'm questioning the writing on the motion because it states that there is a budgetary impact.

Roberto F.: You are right, there is no impact. What we were trying to say, is that every year, because of the location of where these conferences are going to be held, it's going to vary. But we, as a committee, said that no more than \$1,500 would be spent in this endeavor.

Seth, GSR District 15 called the question. Seconded by Johnny, District 1.

Vote taken on the motion, 2/3 majority achieved. Motion PASSES.

Minority Opinion

Paula, GSR District 19: I discussed this with my group and they said no.

Glen, DCM District 5: Point of order. We called the question but we didn't vote on whether to end discussion, correct?

Jim F.: Correct. We're going to vote to end debate. The question was called, we need to have a vote on whether to end debate.

Vote taken to end debate, 2/3 majority achieved. Debate Ends.

Vote taken on the motion, 2/3 majority achieved. Motion PASSES.

No minority opinion was shared, motion stands as PASSED.

New Business

Item #2 - Archives Rent

Submitted by James J., Area Archives Chair

Motion:

To Amend the Area 58 2017 Budget for Archives Rent

Intent/Purpose:

To raise the line item amount for the Archives Rent from \$3180 to \$3660 to pay the rent increase incurred in a new lease.

Current Practice:

Archives Chair would usually ask for the increase before the budget is presented to the body, however we did not know about the increase when the 2017 budget was approved.

Budgetary Impact:

This change will increase the Archives rent from 265.00 per month to 305.00 per month.

Motion seconded by Stan, District 7.

Marie, Alt DCM, District 21: Are you asking for an increase in your budget of \$3,500 a year to accommodate the increase in rent? Or are you trying to absorb that within your budget.

James J.: I'm not asking for an increase in the committee budget, I'm asking for an increase in the archives rent budget. I think if you go down a little farther on the budget, you'll see archives rent for \$3,180 and we need an increase to \$3,660.

Jim F.: This does have a budgetary impact, we'll ask finance if we have the money. **Shane C.**, **Area Finance Chair**: We have the money.

Motion determined by a majority to be urgent and/or administrative and will be voted on immediately.

Lisa K., GSR District 26: I was wondering how long you've been in the building or the room that you're in, where it's located and when the increase is happening.

James J.: The original budget of \$3,180 is the price we've paid for the last 10 years, with no increases. It's actually a 15% increase over a 10 year period. We did a comparison of other buildings in the area, the closest thing we could find was half the space, which was a storage building 10 feet by 30 feet, one light bulb in the middle of the building 14 feet in the air, a plugin outside we could run an extension cord to do a limited amount of work but basically storage only, we could not work in it on the basis we are now. I don't know whether that answers the total question...it's in St. Helens Oregon. We paid the \$915 out of our regular budget out of this quarter. I'm really hoping you pass this budget so we can make it through the whole year.

Shauna C., Alt DCM District 15: As a property manager in the Portland area, the rate you guys have is really low, it's a really nice building, I would say this is a very very reasonable request.

Vote taken on the motion, 2/3 majority achieved. Motion PASSES.

Item #3 - YPAA Presentations After District Reports

Submitted by Esther W., DCM District 22, as amended.

Motion:

To invite Young People in Alcoholics Anonymous (YPAA) Committees to give a report during the time set aside for District and Intergroup Reports at Area Assemblies.

Intent/Purpose:

To create and foster better linkages and Unity with Young People in Alcoholics Anonymous committees and the Oregon Area Service Structure.

(Note: YPAA Convention Committees would include ICYPAA, WACYPAA, OSYPAA and any others)

Current Practice:

The Oregon Area General Service committee does not invite reports from YPAA Convention Committees at Area Assemblies.

Budgetary Impact:

None

Seconded by Glenn, DCM District 5

Jeannie, **DCM District 1**: Do these groups already have a GSR or DCM, or are they just speaking as a whole. Do they have one person like the AA groups do. If they have that, wouldn't they be able to share that way?

Esther W.: Mabye but not necessarily. We asking that we allow the convention committees to give a report, if they wish to, at the time set aside for district and intergroup reports. Those aren't groups, those are the conventions. There may or may not be a YPAA group that has a GSR or DCM that gives a report, but that wouldn't necessarily be a convention report.

Whitney T., DCM District 23: I served as the General Service Liaison for WACYPAA 19 and I was allowed to give reports based on that conference, at the assemblies, time permitting. I think it would be great if there was an actual time allowance that was given to us, I always had to ask permission. I think that would be cool if there was some time for that.

Cindi C., GSR Drifters By The Sea, District 2: Are they asking for a change in our structure and guidelines, because I know that our structure and guidelines has a place for Area committee positions. I'm just asking if they are or not.

Jim F.: There could be one word or one addition, added to the guidelines. There could be one word that the chair would add to the guidelines, the next printing of the guidelines, which you will be receiving them in May.

Maggie S., GSR Girls Night Out, District 24: For those unfamiliar with YPAA committee structure, the best way to think of this is similar to a PNC, in that it's a one time convention that's happening in the Area, and they'd like the opportunity to make announcements in the Area. That might be the best way to think of it, as opposed to a district or GSR, it's more similar to a PNC chair making an announcement.

Tiffany G., DCM District 14: I commend the effort since the previous YPAA motion was shot down, this is a good effort to try and get YPAA connected with the Area. When PNC was happening in Oregon, we always allowed PNC to give a report, we set a time slot for them. I don't see why we wouldn't be able to do this for YPAA, considering that yesterday we had extra time left over during DCM and intergroup reports.

Kathleen, GSR District 19: There's been a lot of questions raised at my table whether this is really like other AA conventions and maybe Summerfest should give a report. I feel that this whole YPAA organization is unique in that it actually organizes AA young people in a way that other conventions that use AA people, and what have you, do not. And that there is a significant enough difference and enough of a need to tie young people more closely with the AA organization that I support this motion and I believe my group would also.

Johnny, GSR District 1: I know for a majority our groups in our areas, and the meetings I've been in, I'm really a big supporter of anything we can to do help support the young youth and get them aware of this. However the thing that made me concerned about this, who's going to be bringing the report and going to be giving it, and how is their anonymity being protected.

Kylie, GSR Host of Friends, District 6: I served on OSYPAA 1, we are in our fifth year, I'm also on the advisory council for OSYPAA. To my understanding, our committee especially, has a General Serivce Liaison, so they do come to Area, so we could speak for that.

Cindy, GSR District 26: I like the motion, but it brings up a larger question, we seem to be talking a lot about the YPAAs and representation. Why do they not just become a district so they are included in all of the regular activities that we have here. We have linguistics districts…it's just something to throw out there.

Teresa B., Area Newsletter Chair: To my recollection, we actually years ago took a sense of the group and already agreed that YPAA groups could have time at the mics at the district reports, that's already been approved by the sense of the group. Just like intergroup gets a report, I believe that PDAC [Portland Deaf Access Community] has asked for time for that. I chatted with some of my co-members, and one of the things that was suggested is that it's fallen out of practice for some reason. It maybe be included in the sample agenda that's passed out to host committees, so that it be brought back into practice.

Herb, GSR Broad Highway, District 30: I'm a bit fat and a little bit old. The future of AA is with our young people. I don't understand what this conversation is all about. They are the future of this organization. I don't know how to structure making their voice extremely heard, but we need to do that. I support this motion.

Gus P., Area Grapevine Chair: I'm going to speak in favor of this motion. The purpose of district reports and that whole session is to provide information. It's to allow those in attendance what's going on in our districts, what's happening in our central offices and intergroups, and what other important activities are going on and YPAA events are certainly part of that. As Teresa has already mentioned,

we've had that practice in the past, we just need to be reminded. I would hope that no one gets discouraged when we don't have time to do it because sometimes district reports don't go smoothly. But other times, we have plenty of time and we finish early. But I definitely think that the information should be shared with all of us so that you get an opportunity to find out what's going on and carry that information back to your groups. Thanks for listening.

Bob, GSR Albany Group One, District 21: I'd like to announce too that I'm a product of ICYPAA. In 1985 I went to my first ICYPAA in Denver, Colorado. And here we are 32 years latter. I think it's a wonderful organization. At my home group, when it comes to young people, we go out of our way. We allow them to create....we have three meetings a day times 21 meetings. We allow them to have their own format. And it is a little bit different. But it's absolutely thriving. If you ever saw the stats of the young people, as well as old people I guess, probably more young people, they're dying like flies out there on the fields of addictions. I would absolutely endorse allowing young people to have a voice at every Area meeting. And please allow them to send someone, let them make the decision on who to send.

Mike, GSR District 5: I was against this until I talked to Gus up here, so now I'm for this. I want to ask for clarification. There's a fair amount of YPAAs, so which one is going to be giving the report it if does get passed. We're not going to have all the YPAAs come up here and start giving reports, are we? I just want a clarification if I can.

Esther W.: Let them decided, as many as time allows. They could decide what reports they need to give.

Lisa W., Area Alt Treasurer: I want to make note to the fellowship, even if we run out of time at the reports, that all the reports that are going to be given that are submitted to the Secretary for the minutes, those reports would still be included in the minutes as well. So whether they got to speak at the mic or not, the fellowship would have access to that report through the minutes at the Oregon Area website.

Stan, GSR District 7: The way I understand what's being read, only the host committee would have the option to speak at District level. So unless they want to rewrite it, then only they could speak at it. **Esther W.**: Any convention committees, any YPAA convention committees, could come to the mic and speak. I was assuming it would be conventions that are....I don't know if there are 20 conventions going at once, I'm not completely familiar with YPAA, but I don't think they have 20 conventions going at any given time, so I wouldn't expect that there would be 20 reports up at the mic. I don't know if that answers the question, but it's YPAA convention committees, I would assume kind of current, what's happening then.

Stan: What I'm getting at, like SORYPA would have a way to speak, or EASYPA or PORCYPA. The way I understand it, only the host committee GSR Liaison, or whoever they have appointed, could speak. Not all YPAAs are host committees. A lot of YPAAs are just having local events for themselves, for their local Area.

Ron W., Area Alt Chair: I make out the agenda along with the host committee to approve it and to look it over. In the DCM/Intergroup reports, I'm sorry whether this motion is passed or not, on the next agendas YPAA will be included on that agenda under the District, DCM, and Intergroup reports. If we have time, all YPAAs will be able to give their report during that time. If we don't have time of course, they won't be able to. Districts, DCMs, and the Intergroups will come first, and the YPAAs will come after that. You can pass this or not, it doesn't matter to me really.

Nick, General Service Liaison for ORCYPAA, Oregon Conference of Young People in AA: I'm also a member of ORVYPAA, Rougue Valley Young People in AA, and we're staring up. I feel really passionate about this topic, and I love to hear the support from our elders about YPAA and being part of Area. I wanted to suggest that as YPAA we repeal this motion and work within ourselves to unite one member for Oregon to represent YPAA. As a member of ORVYPAA I believe that would be a wonderful unity opportunity for us to organize that. I think we should just step up to Area with a more organized

motion. I believe there is support for us to be allowed to speak here at every Area, and make sure there is time. I just think we should come here more organized. If you're interested in moving forward with this idea, you can find me at the ICYPAA meeting, which is this in the Jackson room at 12:30.

John E., GSR, called the question. Seconded by Cindy, District 2.

Vote taken to end debate, 2/3 majority achieved. Debate Ends.

Motion determined by a majority to be urgent and/or administrative and will be voted on immediately.

Vote taken on the motion, 2/3 majority achieved. Motion PASSES.

Minority Opinion

Whitney, DCM District 23: I am purely opposing on the language. It says "YPAA Committee Conventions". I'd like to take out the convention language because that would imply that you are hosting a conference. I want it to just say YPAA Committees, so even if you are not hosting a conference, you can make an announcement about any service workshops or events that you're throwing, and not just a conference. If it were to stay the way it was, that would disclude the ICYPAA bid committee, because they are bidding, they're not hosting. We want to be able to have all the YPAA committees be able to make an announcement if they want, not just if they're hosting a conference. That's a friendly amendment.

Brandon, **District 26**: I don't' have an opinion on this motion either way, but I would like the opportunity to take it back to my group because I know it's highly contested there. Thank you.

Gabriel: GSR Wood Village Men's Meeting, District 11: The fact that it's not...I personally don't feel it's an emergency motion that needs to be voted on right now, I would like to take it back to the group as administrative so they can also weigh in, but also so the motion makers and everyone can agree on some language. Because I feel like it's convoluted, and even though we just passed something, I don't feel like we actually know what was passed. And if you go through it, I think there's a lot more work that could be done with it. So I'd like the motion to be retracted and then for something else to be presented forward, so we can still discuss it with the groups.

Kathleen, GSR Sober Awakenings, District 19: I'm strongly in favor of the principle embodied in this motion. I voted against it because I think it is seriously flawed and I totally agree with the gentleman who said they need to work on it some more and present something more clear and more easy to understand to this body.

Mike, GSR, District 5: If this is already included, why do we even have a motion on this, I'm not sure I understand. I mean, is it not already in this? Yes or no?

Jim F.: It was brought as a motion and we heard the motion.

Mike: But what I'm saying is that the motion is null and void because it's already in there, so you vote on something that's already in place, correct?

Ron W., Area Alt Chair: Just to clarify, I really really meant what I said. On the next agendas coming out for the next assemblies, on the agenda where it says DCM, Intergroup reports, there'll be a slash that says YPAA committee reports too. So pass it or don't pass it, I don't really care, I'm in charge of the agenda, I'm going to put on there what I want. And that was my point.

Mike: Since this is a null and void situation anyway, beause he's going to put it on and he's going to have a say regardless. Am I correct? Yes!

Jim F.: Pardon the pun, we've gone through the motion, so we're going to vote on it.

Mike: Vote on a null and void motion. Ok. If it was a motion that was actually legit, I would like to take it back to my group and get the wording better. But if it's not a motion, I don't care, because it doesn't matter anyway.

Jim F.: Because the motion is on the floor, it cannot be null and void, we have to continue on through the motion.

Faye, GSR District 27: While I do support the vision behind this report, I do agree the word "convention" could be removed, and also to stipulate exactly how many representatives would be speaking on behalf of Young People in AA. And I really think that my group would like to discuss it.

Discussion ends.

Motion to revote seconded by Jeannie, DCM District 1.

Motion passes by simple majority, debate on the motion resumes.

Kristopher Y., District 13: Can we just get a point of clarity on the motion that is on the floor. If you'll just read it out so everyone knows what it is that we're voting on.

Esther W. re-read the motion.

Frieda, District 21: I think taking this back to the groups will only confuse them horribly. I'm really not in favor of taking it back to the groups. I wish we could just withdraw it and have them rewrite it. Or just go with what Ron said, is that they will be on the assembly thing. Bye.

Gabriel: I would request that Esther withdraw the motion.

Jim F.: Esther are you willing to withdraw the motion at this time? This is the time with withdraw, change it, or amend it...

Esther W.: No

Ed, GSR You Name it Group, District 26: The last two assemblies we were at, we discussed why Young People in Alcoholics Anonymous. We've discussed this at the business meetings at the You Name It Group, and the group conscience at my group is, since we've talked about it twice, any way that we can extend a hand to Young People in AA, we want to do it, so we are for this motion.

Trisa, District 6: I know we don't want to withdraw it, but it was already brought up to amend but we couldn't amend it at the time. What I'm asking is that we do amend it for two purposes. One is to create that single representative under all of these guys, and two to take out the word convention. It's a friendly amendment, I don't know if it will be accepted or not.

Esther W.: We would be willing to take out the word "convention". We don't want to restrict it to certain YPAAs. We would like them to be able to decide what is pertinent.

Teresa, Area Newsletter Chair: I need some clarity. Since this is already in practice, right now it's at a place where if it's time permitting. There's nothing in the motion that talks about whether it would remain time permitting or if they are asking for time on the agenda no matter what. Does that mean that they would go after district reports? Would it be at the expense of district reports? Would we extend the district reports to ensure they had time? That's the part that I'm confused about, because we already have this in place.

Lisa: My vote changed after hearing the minority opinion. What I'm understanding is that this is a practice that people who have been coming to Area assemblies for quite a while remember it being a practice that we fell out of possibly. Also, we're being told that this is going to happen and we are trying

to get back into that practice. I kind of feel like I'm not exactly sure what we're doing anymore. I really look forward to hearing from the YPAAs at our next assembly, thanks for adding that for the next time.

Gus P., Area Grapevine Chair: It is my understanding that at district and intergroup reports, as it's currently named, that we don't limit the number of districts reporting, that every district has an opportunity to make a report. We don't limit the number of intergroups or central offices. If you are here and you would like to deliver a report, and time is permitting, you make the report. I think the same courtesy and equal dignity should be afforded to the YPAAs and I would ask for a friendly amendment to take out the word convention.

Jim F.: We already did that.

Gus P.: Well I would ask again.

Jim F.: We will ask Glenn, who seconded the motion, if he is on board.

Glenn indicated his assent.

Jim F.: Teresa asked a question, is this time permitting or not...everything is time permitting.

Esther W.: Would you like me to speak to that or are you just answering that.

Jim F.: I think I just did.

Teresa B., Area Newsletter Chair: I did ask a question to the motion maker if this would be time permitting. I'm asking for a friendly amendment to time permitting. My concern is that this would be at the expense of district reports.

Esther indicated they would not be willing to accept the amendment.

Cindy, GSR District 2: The amendment on the floor is a motion and we have to follow that through the process before we can make another amendment, please.

It was explained to Cindy that Oregon Area uses a modified version of Roberts Rules that permit multiple amendments to a motion before a vote takes place.

Esther re-read the amended motion.

Tiffany G: I wanted to clarify, we're still in open debate, nobody called the question, we haven't voted yet, all the previous voting has been cancelled out. So technically if someone asks the motion maker to make another amendment it's still legal, yes? Gus is nodding yes.

John A., Area Treasurer: I just wanted to speak to the time permitting. I did take Teresa's point and I did ask Gus about the time permitting deal on the motion. Everything is time permitting. If we didn't get all the way through the district reports during that session, the session would be over. That session is set aside for districts to report first, and so any YPAA committees or intergroup reports would come after that. It just naturally would be time permitting. I too was concerned about not having time permitting in the motion. I felt as though it backed the Alternate Chair into a corner as far as how he was going to manage that session. I don't believe that now. But I do think that was a valid point about time permitting. And...when the mind goes blank turn off the sound, thank you.

Kathleen, GSR District 19: Adding the words time permitting changes the status of the ICYPAA relative to intergroup reports. What I feel I support is that they have equal status. In the real world, yes, time is a factor and it is always time permitting. But it is not unreasonable for the young people to say that their stuff is at least as important as intergroup reports.

Jim F.: I would just like to state that some of the confusion is that Oregon Area uses modified rules of Roberts Rules. We don't follow Roberts Rules right to the tee, so we have our own version of Roberts Rules. It's top secret too [laughter].

Ron, GSR District 21: I'd like to state down here at the service committee reports you have 3 minutes each. Is there a better placement to put that if they want to make a report? I see 5 minutes up top. If they have 5 minutes is that enough?

Jim F.: I'll just explain that to you, the [district] reports are on Saturday, [the 5 minutes] is for the business meeting.

Ron: I'm asking the question, if everything is going to be time allotted, will it be time allotted for them. The same amount of time for each one of these people to speak. 5 minutes, 10 minutes, 6 minutes. Will that be allotted? That way everybody knows how much time they can have. **Jim F.**: Yes.

Motion determined by a majority to be urgent and/or administrative and will be voted on immediately.

Vote taken on the motion, 2/3 majority achieved. **Motion PASSES, as amended.** IThere is no minority opinion after a second round of voting!

Item #4 - Purchase Computers and Other Equipment for Translation Committee

Submitted by Dorothé J., Area Translation Chair, as amended.

Motion:

To purchase 2 laptops for the chair and the co chair, both positions need laptops to do all the translations for Area 58. And each laptop needs MS Office software. And also need to purchase a cheap printer

Intent/Purpose:

The chair and co chair constantly receive reports to be translated, and if the chair cannot send the report to the co chair for revision or translation, these reports cannot get translated in a timely manner. We also have to print all translated reports to distribute to three districts and their DCM's

Current Practice:

We borrow laptops, we print at work, we are not self supporting in our efforts right now.

Each computer would cost less than 300, the printer costs 60 dollars and the software is available for 99 dollars per computer

Budgetary Impact:

Total 1.060 dollars.

Lisa, District 6 seconded the motion.

Mike, District 5: This is great. Because this is helping out other alcoholics. I truly support this. I'm chairman of IGR in our area, we gave the office \$1,000 just on one computer. Dorothé is not trying to spend a lot of money, she's trying to do everything as inexpensive as possible. In my heart and my idea, this is truly needed. If I had my choice, this would be administrative and urgent.

Eric, GSR District 19: I'm wondering if it's appropriate to add a friendly amendment of increasing it by \$200 to \$1,060 for ink.

Theron B., Area Website Chair: Just a point of information, the Area has a volume licensing agreement with Microsoft, so we get Microsoft Office for \$29 a seat. We can can take that into account. My suggestion would be to spend more on the computers and get an upgrade on a computer and spend the \$29 for Microsoft Office instead of \$100.

Angel, DCM District 35: I would like to support this motion. We think they do a lot of work and then we can bring more Spanish speaking people to the assemblies. We think it's necessary to have the equipment to do it. Today we had reports waiting on our table, which is a really great idea. To give the tools to the people who are doing our translations is what we want.

Dorothé J.: I'd like to accept the amendment [for the ink]. I think there are HP's for \$297. We're not going to do anything with these computers except use Microsoft Word and translate.

Jim F.: Do you want to increase the amount for the ink?

Dorothé J.: Well we can use the money we wanted to spend for the software on ink. But, ok, I'll increase it \$200.

Lisa, District 6, the seconder agreed with the amendment.

Jeff, GSR District 22: Presently I feel uncomfortable voting on this, due to the fact that I can only vote my own conscience. Because there is a budgetary impact and I represent my group, which is a broad demographic of individuals who definitely have their opinions, I would like to be able to possibly table this and bring it back to my group to see what they think, because this is the first time we've heard of this.

Noel, District 28: Our district has more than 60 groups and all the information we get is very important to pass on to all the groups. This is the first time we got everything translated at the assembly meeting before the business meeting and it's very important to us. It's very important that our community comes to the Area meetings. So it's very important for us that the computers get bought, thank you.

Tiffany, DCM District 14: I just wanted to say that generally when a committee asks for more money we deem it urgent and administrative. And in this situation, if we wait to take it back to the groups, then Dorothé and her co-chair would not be able to do what they did for the Spanish speaking districts as easily as they would be able to if we just pass the motion today and got them set on the track to be able to buy the laptops sooner rather than later.

Rose, GSR Rebellion Dogs, Planning Committee Chair for Nov 2017 assembly: This is definitely urgent and important. Gosh I feel emotional. District 28 is assisting us in planning this assembly and any help we can get...I go to their intergroup, and I'm welcomed there, and we have these challenges with communicating with each other. District 28 is so active and we need all the help we can get to understand each other and work together because they're a powerful group and I want to use as much of their energy and resources and caring to carry this message. To delay this will have an immediate impact on planning this assembly. We need it now is my opinion, thank you.

Lee, DCM District 20: I'm kind of embarrassed that the committee does not have this equipment right now. We're talking \$1,000 which is not a huge amount. I think its urgent, administrative, and let's git r done.

Trisa, District 6: If you were paying attention at the last assembly, this motion was put on our table. I've already taken it to our group. I know, it didn't get voted on, it didn't get to the body, but it was laid on the table for us. Because I've had it since the last [assembly], I've had that piece of paper.

Jim F.: At the time it was on the table, it was asked to be picked up and withdrawn. It never was a motion because it didn't come to the floor.

Trisa: I knew it was coming so I prepared. I was part of the deaf access committee in the beginning, before it all started, and we needed help right away to get our deaf people in here. We need the same for

our Spanish community, we need the same for our Young People. There's no discrimination of Alcoholics Anonymous.

Sandra, GSR Friday Night Roundtable, District 26: I just wanted to reiterate the point that the interpreters are not being able to use AA resources to get their necessary job done. Because of that, I consider this administrative and urgent. It's a thing we've committee ourselves to doing but we haven't allocated resources for it.

Mike, District 5 called the question.

Cindy, District 2 seconded.

Vote taken to end debate, 2/3 majority achieved. Debate Ends.

Motion determined by a majority to be urgent and/or administrative and will be voted on immediately.

Jim F.: We need to Finance if we have the money.

Shane C, Area Finance Chair: It was brought to my attention that we have \$20,889.14. According to my recollection, we have the money.

Vote taken on the motion, 2/3 majority achieved. Motion PASSES, as amended.

Jim F: I have an announcement, in Grants Pass, it's snowing, it's a white out.

Two motions were suspended until the next assembly. No debate or discussion on these motions should take place at the group level, since they have not yet been offered.

February 26, 2017

Hi, my name is Reilly and I'm an alcoholic. My home group is Wildlife, in District 13. My date of sobriety is August 7, 1966.

This year started with our annual Orientation. We had to make a change due to bad weather. Thanks to everyone who was able to make it.

There is always a lot of activity here leading up to the General Service Conference, but other things are also happening in AA in the world today. Here are just a few of them:

- Tell your District PI Committees that the PSA "Tengo Esparanza" has been translated into English and should be available soon.
- There were four Regional Forums in 2016. Several of you were able to join us in Hawaii for a
 weekend of interaction with AAWS, GSO, and Grapevine staff. I was fortunate enough to also attend
 the Southeast Regional Forum in Orlando Florida in December. Presentations by different Staff
 members and Trustees at each Forum make every Forum unique and rich with information about AA
 Service.
- I serve on the Conference Committee on Trustees. From time to time there are vacancies for non-trustee Committee members on the General Service Board. We are actively creating a large file of applicants that reflects the inclusiveness and diversity of AA itself. If you know of any qualified person who might want to serve Alcoholics Anonymous in this way, I'd be happy to give you a resume form.
- The Big Book has been translated into Rarotongan, making 70 languages available. Translations of AA material for First Nations and Native American communities are being inventoried to see what can be added
- We asked, and we received, a new service piece on "Safety in AA". It is available on aa.org under Service Material from the GSO.
- Service pieces are not like pamphlets that must go through the Conference process. They are
 collections of shared experience from AA groups and members, and can be updated more easily. If
 you have additional experience that can be helpful, go ahead and send it to GSO.
- A new Grapevine book "Making Amends" is in production.
- The Grapevine app is available for Android devices now.
- Here's an update on the Feasibility Study: You may recall that the outcome of the Study was "if nothing changes, then nothing changes". AA groups and members responded, as they always do. You guys turned it around! You responded to the \$7.14 on 7/14 Challenge with enthusiasm and contributed about \$12,000 to GSO from Oregon alone. You also signed up for recurring contributions online. Groups sent more money. Members subscribed to Grapevine. Contributions increased over ¾ of a million dollars by the end of the year.
- The General Service Board has asked me to convey to you their gratitude for everything you did in 2016 to turn things around. Remember that this is a long term solution. Please continue with all the actions you took that already helped.
- An Archives pamphlet on "Four Founding Moments" is in the works for 2018, in response to how we can use our archival material to share with members.
- The CPC/Treatment/Accessibilities Committee discussed how to better use technology at CPC exhibits at professional conferences.
- A letter to mental health professionals will be added to the Information for Professionals page at aa.org. This will be another AA Service Piece.

- The Corrections committee is looking at service materials with an eye toward making AA more attractive and inclusive to a broader membership.
- La Vina was right on budget this year, without much change. Remember that La Vina is a service, like Corrections or CPC. It has an income stream from subscriptions, but it isn't expected to be self supporting.
- The Board approved bringing back Special Forums, like Regional Forums, that focus on a particular issue or need within AA.
- The 2020 International Convention will record the AA meetings in American Sign Language and make them available for sale at the Convention.
- And, a survey is planned for later in the year to find out the best way to determine the need for plain language literature

I'll update you on these and other happenings as we go along.

Thank you for the great participation in the discussions yesterday.

I have a couple of notes about the Pre-Conference Workshops in your districts:

Remember to choose a note-taker who can follow the important points of your discussions. Last year almost everyone typed their notes or sent them in a file and that helped us a lot. Schedule your Workshops in plenty of time to get the notes to Vera by April 8th. Don't wait to send your notes on the deadline. Please send them as soon as possible after you have your discussions. Remember that detailed notes will really help me understand what your group's feelings are on the Agenda Items. This is your chance to have your voice heard at the Conference. I'm really looking forward to sharing your thoughts with the rest of the United States and Canada, so please tell me what your groups think.

It's time to start booking your dates to host a Delegate Report. It's a lot of fun to share the General Service Conference with as many groups as I can.

Next week we go to PRAASA in Sacramento California. I expect to hear some great sharing on the Conference topics in the presentations. Pacific Region Delegates have a reputation for being the best informed delegates at the Conference. It's true. You tell us what you think, and we listen and learn. Thank you for supporting service the way you do in Oregon Area!

The reminder email contains important information about how to send your report. For instance, sending a copy of your report to our translation chair Dorothe () and excluding last names from your report are both very helpful.

Another note, you may or may not have noticed that some people call me SJ instead of S............

Because of the uniqueness of my name, past Area Secretaries have obligingly used my initials rather than my full first name in the minutes. I mention this only because if you have a first name that you would prefer to have left out of the minutes, I would be happy to oblige you, just let me know. Also, if you

Q1 Treasurers Report February 26, 2017

Good morning Oregon Area,

My name is John, and I am an alcoholic. My sobriety date is July 13, 2000 and my home group is the Keys to the Kingdom Group Roseburg District 13.

First I would like you to know how humbled I am to have been elected as your Area Treasurer. I keep thinking they don't know who I am. I left the November Assembly feeling a little nervous and asking myself what have I gotten into. Those feelings lasted for a day or two before I was able to remind myself

that I am surrounded by friends that have done this job before me. Then it was time to reconcile the account. When I opened the bank statement and selected reconcile in Quicken what I saw again made think what have you gotten yourself into. Quicken had randomly unreconciled entries dating back to August. After looking at all of Lauri's reconcile reports I could see that they had be reconciled at one time but were no longer. After reading several forums of people who had had the same problem, I decided to use a lifeline. I drove to Eugene and knocked on Lauri's door. As always I was greeted with the smiling face of friend ready to help me. After we both stared at the computer for about a half an hour we came up with a plan. We crossed our fingers and executed it and it worked. After a woo hoo a high five and a hug I was on my way with a balanced checkbook. Once again it was demonstrated to me the important role that the people who go before us play. Thank you Lauri.

Now about the money. You have 2 different Financial Statements on your tables this morning, the FYE 2016 and the 2017 Q1 Financial Statement. Please find the one that says Oregon Area Financial Statement FYE at the top. This is the first report we will look at. By the way, FYE stands for Fiscal Year End.

Our fiscal year begins December 1st and ends November 30th. Therefore, this report includes all income and expenditures from December 1, 2015 thru November 30, 2016. Let's take a look; beginning at the upper right is the amount of money we started 2016 with, it's called our "Cash in Bank" it was \$15,949.90. To the left is the income section and the last line in that section shows we had a Grand Total Income in 2016 of \$85,535.63. When we add this to our Cash in Bank it gives us Total Funds for 2016 of \$101,485.53.

The next section down is our expenditures. Going left to right, the first column shows the 2016 budget, the next column shows the total spent year to date from each budget line, and the year end budget balance is shown in the next column. The two columns on the right show any return of funds made by your Area Service Committees and the final year end expenses.

Let's go back to the total spent YTD column. This column shows where your seventh tradition dollars were put to work last year. At the bottom of this column you will find the total of \$74,580.44. If we subtract this amount from the total funds for 2016 of \$101,485.53 we get the Cash in Bank on 11/30/16 of 26,905.09 shown in the box at the bottom right of this report.

Some of you may have noticed that the total funds we had available last year was higher than normal. I can tell you there are a couple of reasons for that. The first is that we started the year with an above average bank balance. The second is that we saw a 47% increase in net assembly proceeds. While we are grateful for the contributions we don't want to send the wrong message to the Area that your money isn't needed. Our funding rests wholly on group and individual contributions. Also we don't want to send the message to districts and groups that you must make a profit if you are going to host an assembly.

Knowing that the work we do depends on the voluntary contributions of groups and members I compared some of those numbers for you. Last year Officer and Committee expenses were up by 10%. Group contributions were up by 8%. This means that the cost of providing services to the groups grew 2% more than the increase of the money to pay for them. Obviously we are not at the point of begging for your money but I think it is good to keep in mind the importance of your voluntary contributions.

The second financial report is our 2017 Quarter 1 statement – please find those on your tables. This report is in pretty much the same format as the Fiscal Year End statement but it runs only from December 1st 2016 to February 23, 2017 the day before this assembly. Again, lets start in the upper right side; we started the 2017 Fiscal Year with a Cash in Bank of \$26,905.09. To the left is the 1st quarter income totaling \$18,465.04, which Lisa went over in detail in her report. If we add this to the \$26,905.09 Cash in Bank it gives us Total Funds of \$45,370.13.

The next section below is our expenditures; the first column is our 2017 budget, the column to the right labeled Q1 is our first quarter expense. These expenses consist of draws taken from Committees and Officers, Archives Rent, Area PO Box and our Area Orientation held in January.

These expenses for the 1st quarter of 2017 totaled \$7,243.95. This gives us a Q1 Ending Balance coming into this Assembly of \$38,126.18, shown in the last box on the right hand side labeled Ending Balance.

The very last section shows Outstanding Assembly Advances totaling \$3,700.00. These advances are given to Host committees as seed money.

As always we want our Area Treasury to be transparent, and we will keep you informed of our checkbook balance during the assembly. If you have any questions later on you may email or call me, my information is in the Area Roster and you can also find my email on the Area website under Finance, Treasurer.

This quarter I made 7 deposits totaling \$18,465.04. Group contributions accounted for \$17,236.32 or 93.3% of total deposits made. The remainder of our income this quarter came from two district contributions, two birthday contributions, seven personal contributions, and one generous contribution from the North Coast Annual Round Up. You can find more detailed information in the attached contribution report.

We have been accepting online contributions for more than a year now. Since we met in November, we have received thirteen contributions totaling \$1,029.08. We paid \$33.74 in fees leaving us with \$995.34 to transfer to our checking account – which is the largest quarterly transfer since Oregon Area started utilizing PayPal. This quarter, along with learning my new responsibilities and making twice per month trips to the bank, I've also worked on a spreadsheet for our online contributions that helps hide information that is not vital to our deposit information needs. I also attended the Area Orientation in Eugene and was able to get to know the Finance Committee and our Treasurer better (and be able to provide the much needed chocolate). Thanks Vera for your hard work putting the Orientation together twice, due to the inclement weather.

To keep costs down I have provided each district with two copies of this contribution report. DCMs, please feel free to make as many copies of this report as you need. Also know that it can be found in the minutes for this assembly that will be posted on the web at aa-oregon.org. If you have any questions or see changes that need to be made, please let me know. My contact information is on this report, in the roster and on the website. You can also chase me down at the break or after this meeting.

Grapevine

Hello Oregon Area! My name is Gus P and I am an alcoholic. I am currently serving you as your alcoholic Area Grapevine Committee Chairperson. My sobriety date is 12/1/93 and my Home Group is the Downtown AM Group in Eugene, where sobriety begins at 7 AM Monday through Saturday each week. Please join us whenever you are in Eugene.

This is the unabridged version of my long-form Grapevine report which will appear in the Area Minutes. This expanded report is offered because the 3-minute timed Assembly Business Meeting Report does not permit complete coverage of Grapevine topics.

This last quarter is the beginning of our 2017 Area business year, which started on December 1, 2016 and ends on November 30, 2017. Generally, our first quarter is a low activity quarter, and this is most likely due to the holiday season and winter weather conditions.

During this last quarter, I traveled to District 7, where I delivered a Grapevine presentation and was the speaker at the Friday night speaker meeting in Grants Pass. Thank you to Randy R for the gracious invitation to be of service and for an excellent meal and conversation. Thanks also goes out to District 7 DCM Crystal H for her service in the District.

Also during this last quarter, the Area Grapevine Committee met with Randy S, the Grapevine Chairperson for the Emerald Valley Intergroup (EVI), to arrange for a combined Area and Intergroup Grapevine presentation and writing workshop for the greater Eugene – Springfield metropolitan area. All indications are that this event will take place in Eugene sometime during the month of May. The Area Grapevine Committee has also been talking to representatives of District 15 to plan for a Grapevine presentation for the District in the not-too-distant future. My thanks go out to Amber N and Kira M of District 15 for reaching out to the Area Grapevine Committee for a presentation.

During the first quarter, I attended this year's Fall Men's Retreat in McKenzie Bridge, where I was privileged to serve as the retreat leader. This was my first time being a retreat leader, and I was nervous. Mercifully no one no one threw anything at me and some of the attendees were kind enough to tell me they enjoyed my presentation. The hidden blessing for me was that I went deep into the Big Book for preparing my Step presentation as retreat leader; and I had a great time providing that service. My thanks go out to Mark S for inviting me to be this year's retreat leader.

During this past quarter, the Tuesday Night Men's Workshop continued its work on the Steps using the Big Book Workbook. The 12 participants are taking this journey through the Steps using the Big Book as our main literature tool, and we are nearly finished with Step 12.

In December, Grapevine announced a price increase for most Grapevine items; the increase will add a \$0.50 increase to all books and most other content related items effective March 2017.

There is a new Grapevine Subscription App, from which you can now subscribe to the magazine. You can then access the magazine on your tablet or smartphone monthly (\$1.99 per issue or \$23.99 for a 12-month subscription). You can download your issue for offline viewing, archive past issues, get a sample audio story or selected video and email your favorite articles to friends.

The AA Grapevine "Grow Your Grapevine" Contest is about to conclude on February 28th. So far in the Contest, Area 32 Michigan Central is leading in the Contest with over 4300 Arbor Cards submitted; Area 34 Michigan Western is in second place with over 3300 cards. Area 58 Oregon has submitted 37 Arbor Cards, and is second place in the Pacific Region and 12th overall.

There were three issues printed since our last Assembly. The December issue's main theme was "Remote Communities and Holiday Stories". The January Grapevine had as its main theme "Emotion Sobriety"; and February issue focused on "Making Amends".

Martha G had knee surgery, and a week in Mexico, and then about a week in the Hospital with other health problems. She is a trooper, she has another surgery scheduled this year. We also have been translation reports all week for DCM"S, and Committee's as well as Offices at the Area Level.

Some of the reports we received followed our request and send us a copy of the report once it had been translated by translate.google.com, and made our job so much easier, we corrected when needed, and cycled it through the translation program one more time.

We searched for better translation audio equipment with less static, and all I found so far is one system that costs over 16k and another that would work maybe using cell phones, I am still investigation. I am also investigation Professional translators that the committee can hire for the Business Meeting on Sundays. My concerns are anonymity and knowledge of our particular "short hand". I found that no one was available on Sunday in Medford, and that they also required all the paperwork in advance. Medford translators were also more expensive than 100 per hour. We have 400 dollars in the budget per assembly or 1600 per year for this item.

I have started to print documents in Spanish for the DCM reports on Saturday, and they also received a paper copy of all the reports this morning, in Spanish.

We have a motion on the floor for Computers and software and a printer, for the committee also.

We have been busy, we have been better organized and have been able to translate more than one event at the same time.

I have a great team to work with, and I am grateful for that.
