<u>DECLARING 135 & 141 MAIN STREET PROPERTY NO LONGER NEEDED FOR MUNICIPAL</u> PURPOSES AND IS SURPLUS PROPERTY

WHEREAS, all Board members, having due notice of said meeting, and that pursuant to Article 7, §104 of the public Officers Law, said meeting was open to the general public and due and proper notice of the time and place whereof was given as required by law; and

WHEREAS, the Town Board of the Town of Randolph owns properties in the Town of Randolph, identified as SBL #70.072-2-13 and 70.072-2-12

WHEREAS, in accordance with Article 4, §62 (2) of the Town Law, the Town Board of the Town of Randolph has the power to take, purchase, hold, lease, sell and convey real property as the purposes of the Town my require; and

WHEREAS, said municipal property above is of no value to the Town of Randolph and is declared to be surplus municipal property and can be sold for fair and adequate consideration; and

WHEREAS, the Town of Randolph has been contacted by Reid Smith II expressing an interest in purchasing the property herein described, and

WHERAS, Reid Smith II has offered \$1 each for these properties along with all associated property transfer costs and the Town of Randolph believes this to be fair and adequate consideration.

NOW ON A MOTION OF Nate Root, which was duly seconded by Amber Frame, now therefore

BE IT RESOLVED, that the Town Board of Randolph that the properties identified as SBL# 70.072-2-13 and 70.072-2-12, is surplus municipal property and shall be sold to Reid Smith II for fair and adequate consideration of \$1.00 along with all associated property transfer costs.

RESOLVED, that this is subject to a permissive referendum and shall become effective in thirty (30) days after its adoption, or, thereafter, upon approval by the affirmative vote of a majority of the qualified electors of the Town voting on such propositions for its approval, if within thirty (30) days after its adoption there is filed with the Town Clerk a petition signed and acknowledged by electors in the Town in number equal to at least twenty per centum of such electors in the Town, as shown on the register of electors for the previous general Town election, protesting against such act or resolution and requesting that it be submitted to the electors of the Town for their approval or disapproval; and be it further

RESOLVED, by the Town Board of the Town of Randolph this resolution shall not take effect until thirty (30) days after its adoption, as stated above such sale is subject to permissive referendum; and be it further

RESOLVED, that the Town Clerk be and she hereby is directed to publish an abstract of this resolution in the official newspapers of the Town of Randolph within (10) days of the adoption of same.
