Constitution Day September 17



The Constitutional Convention took place from May 14 to September 17, 1787, in Philadelphia, Pennsylvania. The point of the event was to decide how America was going to be governed. Although the Convention had been officially called to revise the existing Articles of Confederation, many delegates had much bigger plans. Men like James Madison and Alexander Hamilton wanted to create a new government rather than fix the existing one. The delegates elected George Washington to preside over the Convention.

70 Delegates had been appointed by the original states to attend the Constitutional Convention, but only 55 were able to be there. Rhode Island was the only state to not send any delegates at all.

As history played out, the result of the Constitutional Convention was the United States Constitution, but it was not an easy path. The drafting process was grueling. They wanted the supreme law of the United States to be perfect.

The first two months of the Convention saw fierce debate over the 15 points of the "Virginia Plan" which had been proposed by Madison as an upgrade to the Articles of Confederation. Yet, the "Committee of the Whole" couldn't agree on anything. So, on July 24 of that year, the Committee of Detail was enacted to handle the drafting process.

The United States (U.S.) Constitution was adopted on September 17, 1787 with 39 signatures before being distributed to the States for ratification.

The Paoli Massacre September 21



British General Lord Howe ordered Lord Grey to ambush Brigadier General Anthony Wayne's regiment at Paoli PA on September 21 1777. Grey ordered his men to remove their flints and use their bayonets. 53 men were killed and over 100 wounded.





Robert L. (Jack) Berry receives an SAR Police Award and medal at the February 8 meeting.

Vice President Dennis DeAtley presented Jack Berry this prestigious award at the February 8 Meeting. After the Los Angeles FBI discovered that a number of southern California residents were involved in a

national jewelry theft burglary ring, Jack and two other special agents were assigned the case. Within six months, over a dozen individuals were identified. The thieves patterned themselves after the famous "Dinnertime Set" of the 1960's and 1970. The jewelry was sold to a father and son team of jewelers operating as fences out of the Diamond District in Manhattan, New York. The jewelers were aligned with and controlled by the Genovese organized crime family. For six weeks, Jack and a former member of the burglary ring travel together throughout the United States identifying burglarized homes in the wealthiest sections of seven states. After the Los Angeles U.S. Attorney's office determined that the best prosecution of a "Racketeering Influenced and Corrupt Organization" (RICO) case would be in Manhattan, New York, Jack was assigned to the New York Strike Force at the U.S. Attorney's office in Manhattan. The two other Los Angeles agents were removed from the investigation. Jack worked primarily alone in New York for over 16 months. The 3 1/2-year investigation resulted in 17 guilty pleas including the two New York jewelers and a made member of the Genovese organized crime family. Jack received a letter of commendation and a monetary incentive award from the director of the F.B.I. see police award continued page 3

They also met privately with Governor Janet Napolitano. Both bills passed governor.

Stephen was inducted on September 12 at the Hassayampa Inn. Steve was born in Birmingham, Alabama, the son of a WWII vet who stormed Omaha beach on June 6, 1944. He attended the University of Alabama, earning a BA in Theatre.

Steve worked 20 years with the Disney Company, opening EPCOT, Disney Hollywood Studios, Disneyland Paris, and Tokyo Disney SEA. As Executive Producer, he used his creative skills to lead teams of architects, designers, artists, and craftspeople to conceive and deliver groundbreaking new projects, including the Disneyland Paris - Buffalo Bill Wild West Arena project. Cowboys, Indians, and buffalo in Paris! Who knew? Working in collaboration with famed architect Frank Gehry, Steve oversaw design and construction of the \$80,000,000 performance arena and show. The show still entertains guests today, performed twice nightly

for the last 24 years. His latest project was as Executive Producer for the \$3.2 billion-dollar Disney SEA theme park project in Tokyo, Japan, earning him the med Entertainment Association Award for Excellence. Now retired, Steve loves living amongst the pines of Prescott, AZ.

Olin Eric Bakke

Olin was Born in Los Angeles 10/21/1970 and graduated High School in Los Angeles. He started cycling while in college. He competed in races domestically (across most States) and internationally (China, Australia, Costa Rica, Mexico, Poland) and moved from California to Pennsylvania as a result of cycling teams and racing and along the way – he met and raced a couple times with Lance Armstrong in 1998. After cycling, Olin returned to college and graduated in May 2002 with a B.S. in Information Technology.

In September 2005, Olin enlisted in the Navy and was sent to Recruit Training Command in Great Lakes, Illinois for an 8-week boot camp. Olin began his Naval career as a Seaman (E-3). During Christmas 2005, Olin attended accession training (A-school) to become an

information systems technician. During the 14-week A-school, Olin worked hard to graduate top-in-class awarding him his first promotion from Seaman to Petty Officer third class (PO3, E-4) and the option of selecting his first duty station. Olin selected shore duty and was assigned to the National Naval Medical Center (NNMC) in Bethesda Maryland (the President's Hospital). While serving at NNMC, Olin was selected for a 7-month deployment to Kuwait (Fall 2006-Spring 2007). Upon returning to NNMC, Olin took and passed the promotion exam earning him his second Navy promotion from PO3 to PO2, Petty Officer second class (E-5).

In January 2008, Olin was miraculously able to transfer from the U.S. Navy into the U.S. Public Health Service (PHS) resulting in an immediate promotion from Navy enlisted information systems technician second class (E-5) to USPHS Lieutenant (junior grade) LTJG (O-2).

His first duty station as a USPHS commissioned officer was with the Office of the Surgeon General, within the Office of the Secretary for the Department of Health and Human Services (Jan 2008 – June 2011). While working within the Office of the Surgeon General, Olin was promoted from LTJG to Lieutenant (LT). One of his most memorable experiences was his selection to participate in a deployment to Indonesia as part of a 2010 Pacific Partnership Public Health Team involved in the Medical Civil Action Program where he was assigned to the Military Sealift Command hospital ship USNS Mercy (T-AH 19).

In June 2011, Olin moved to the Substance Abuse and Mental Health Administration (SAMHSA) where he accepted responsibility for management of a \$50 Million-dollar contract. While at SAMHSA, he was promoted from LT to Lieutenant Commander (LCDR).

In June 2014, Olin moved the Food and Drug Administration (FDA) where he is currently stationed, working as a Senior Program Management Officer Consultant. In September 2007, Olin was again promoted and is now a Commander (CDR) which is an O-5, a rank equivalent to a Lieutenant Colonel in the Army, Air Force, or Marine Corps.

Olin is responsible for the acquisition of goods and services for the FDA. The government keeps quite busy spending large amounts of money and he does his best to tactfully ask the delicate questions like "and why do you want to buy that?" or "are you absolutely certain you need that?"

Senior Leadership may not always appreciate being asked to provide the requisite justification but thankfully, Olin has the support of a good Team Leader and Supervisor both of whom are fiscally responsible strategic thinkers.

To be part of the Sons of the American Revolution with my son Oliver gives me great pride.
