NOTE: Not all display spaces have electricity available – first come, first-served.

*All heavy-duty extension cords, lights, cables and 3-way plugs must be supplied by exhibitor. **Eventualities and the City of Middletown reserve the right to limit the number of cords, lights, cables and plugs used by individual vendors.***

All Food Vendors must provide their own Health Permit. A representative of the Metro Health Department will be on site to inspect.

The City of Middletown and/or Eventualities (Event Producer) reserves the right to reject any Exhibitor Application, items for sale or displays that do not meet the expectations and standards of the festival.

Food Vendor booths **MUST** remain open during all Festival hours – **NO** exceptions.

The following items and exhibits are prohibited: fortune tellers, tattoo artists, body piercing, sexually suggestive items or any type of gambling OR gambling device which requires licensing by the Kentucky Gaming Commission, casino games, pull tabs, etc. Free “register to win” is acceptable. **THERE SHALL BE NO GUNS OR TOY GUNS OF ANY KIND ALLOWED....there will be no exceptions!**

24-hour security will be provided beginning Friday, September 7, 2018 at 3:00 PM and ending Saturday, September 8, 2018 at 11:00 PM. The City of Middletown and/or Eventualities makes no guarantee and assumes no responsibility for loss, breakage, etc. Items should be removed at closing or packed away and sufficiently covered.

Limited automobile access to Main Street will be allowed Friday afternoon. All vehicles must be off the premises by 5:00 pm Friday – **NO EXCEPTIONS**. Vehicles will be allowed back on Main Street after 10:00 PM Saturday night or when the promoter deems foot traffic has adequately cleared. Any vendor moving a vehicle onto Main Street before this time will be banned from future festivals. _____ (Initial **REQUIRED**)

Vendor/Exhibitor Parking Permits and Display Space assignments will be distributed by Wednesday, August 29, 2018. Parking permit must be displayed and visible through vehicle front windshield area while attending festival.
