# Open Burning - Village Ord. 3-2-11

Burning trash/garbage is prohibited. Burning barrels are no longer allowed within the Village of Pardeeville. Spring burning of dry leaves and other non-offensive dry yard debris is only allowed from April 1st through May 31st. Burning of damp yard waste and unattended burning is also prohibited and is subject to a citation/forfeiture for violations. Outdoor cooking and campfires are allowed per Village Ordinance. See the Village Code of Ordinances or call the Village Hall if you have any questions.

## **Hydrant Flushing**

The Pardeeville Water Dept. will be flushing water mains during the weeks of May  $15^{th}-19^{th}$  and from October  $2^{nd}-6^{th}$ . This flushing will be done during the day from 8:00 AM to 4:00 PM in order to maximize the results of our flushing program. Some discoloration of the water might be noticed. The Utility recommends that residents run water from the cold water tap and flush toilets until the discoloration disappears.

## Private Wells

All private wells and sand points must comply with D.N.R. codes and Village ordinances and are required to have a valid permit, but all wells in basements are illegal and must be properly abandoned and inspected by the Village. Failure to comply will result in a citation. Call the Village Hall to renew your Private Well Operation Permit or to get information on a free permit to abandon your illegal basement well.

## **Discarded Household Items**

Advanced Disposal will not pick up large items (TVs, refrigerators, freezers, washers, dryers, sofas, chairs, mattresses, etc.) without prior arrangements and a fee. Call Advanced Disposal at 1-920-387-0987.

Or you can deliver the items to Columbia County Recycling/Solid Waste Processing Facility at W7465 Hwy. 16 in Wyocena for a fee. The phone number is 742-6651. Per Village Ordinances 8-4-8 and 9-3-6 these discarded items <u>CANNOT BE LEFT OUTSIDE!</u> <u>Violations are subject to a citation/forfeiture.</u> Please help to keep Pardeeville neat and clean.

#### Solicitor's Warning

Soon solicitors will be knocking at your doors. When they come, ask to see their Seller's Permit. Some groups are not required to have a permit such as the Boy and Girl Scouts, non-profit organizations, permanent merchants, and people selling agricultural products. If any solicitor acts suspicious or in an unprofessional manner, call the Village office and if possible try to get the color, make, and license plate number of their vehicle.

## **Brush Pick-Up**

Brush will be picked up at the curb during the following weeks:

April 10 June 12 August 14 October 9

- Pile brush at the curb.
- Small brush must be set out in an open container.
- Trim limbs per the Village Ordinance.
   Limbs larger than 4" in diameter will not be picked up.
- Brush must be set out at the curb by 7 a.m. on Monday of the scheduled pick-up week.
- Do not set out brush more than 5 days before the scheduled Monday.

### **Leaf Disposal**

Advanced Disposal will be picking up leaves ONCE this spring and ONCE this fall. The spring pickup is scheduled the week of May  $1^{\rm st}-5^{\rm th}$  and the fall pickup date is scheduled for November  $6^{\rm th}-10^{\rm th}$ . If you have any questions please call Advanced Disposal at 920-387-0987. Please follow these simple rules:

- Leaves must be set out at the curb before 7 a.m. Monday of the collection week.
- Do not set out bags of leaves more than 5 days before the scheduled Monday.
- Bags should be placed immediately behind the curb of the public street or alley for collection.
- Leaves must be set out in see-through bags only.
- No garden waste or grass clippings are allowed. Please compost!

Leaves and brush may also be hauled to the Village of Pardeeville property at the Wyocena Town Recycling site on East Bush Road. They are open Wed. from noon to 4:00 p.m. and Sat. from 9:00 a.m. to 3:00 p.m.

## **License Your Pet(s)**

April 1<sup>st</sup> is the deadline to license your dogs and cats. After April 1<sup>st</sup> there will be a late fee of \$5.00 per animal. Please remember to bring in proof of rabies vaccination from your veterinarian's office. Please Remember...

- Dogs must be leashed and not allowed to run free
- Use a "pooper scooper" when walking your dog.

## Permits, Ordinances, Setbacks

In the past few years there have been numerous violations concerning the following Village Ordinances:

- Failure to secure a proper building permit
- Violation of property lines, and front and rear setbacks
- Parking on unimproved surfaces
- Junk appliances, unlicensed and inoperable vehicles
- Fences

The Village Ordinance Book is posted on our web site. When in doubt, call the Village office.

Residents are reminded that permits must be obtained for most property improvements. Contact the Building Inspector, Jim Trebian of General Engineering at 608-697-7779 for an appointment or if you have questions. When planning your construction project, please allow a two-week time frame for appropriate permits, estimates, locates, etc.

### **Pools and Pool Fences**

Please see Village Ordinance 10-1-113 before installing a pool of any size. You can find the ordinance on our website or you can come in for a copy.

## Free Firewood and Wood Chips

Free firewood and wood chips may be available at the Village garage. Please stop down at the Village office to fill out a waiver prior to picking up any of these materials.

## Regulation of Length of Lawn and Grasses Village Ord. 6-1-8

Lawns, grasses and noxious weeds on lots or parcels of land which exceed eight (8) inches in length adversely affects the public health and safety of the public in that they tend to emit pollen, and constitute a fire hazard and a safety hazard in that debris can be hidden in the grass. For that reason, any lawn, grass or weed on a parcel of land which exceeds eight (8) inches in length is hereby declared to be a public nuisance. In any case where the owner or occupant fails to cut the lawn, grass or weeds, the Village may elect to cut the lawn, grass or weeds and shall charge the expense of doing so to the property owner.
