If you are like me, it seems like it has been months since we celebrated Christmas. The wonderful celebration of Christmas gives way to other things such as return to work, school, and ministry. But the weeks after Christmas are rich in their own right. We have celebrated what we call the three Epiphany events — the visit of the Magi, the baptism of Jesus by John, and the miracle at Cana . These are as Pope Francis has described them, "the three signs that the liturgy brings in these days in order to speak to us about the manifestation of God: God makes himself known." As we know, the story of the Magi coming from the East reminds us that the child born in Bethlehem was born for all peoples, and the baptism of Jesus is the revelation that he is the Father's "beloved Son." So, then, what do we learn from the miracle at Cana? What truth is revealed?

To answer this question, we have to take in a broader view of salvation history.

Throughout the Old Testament, we read of how God continually called straying women and men back into right-relationship with Himself. The Hebrew Scriptures are filled with signs and stories that reveal God's covenant-love — His relationship — with His Chosen People: the rainbow after the great flood (Genesis 9:1-17), Abraham's star-filled sky (Gn 15), the giving of the Law to Moses (Exodus 15 and 24), and the promises made to King David and his descendants (1 Samuel 7:12-13). Each of these stories remind us that while the People of Israel violated this relationship time and again, God's love and mercy remained constant.

But those signs and symbols of the Old Testament were only representations of God's love. On that first Christmas night everything changed. In Jesus — who is the Word-Made-Flesh — God "made his dwelling among us and we have seen his glory" (John 1:14) and the miracle at Cana was the first time that Jesus manifested his own transforming power and his glory. Cana marked a beginning and in the transformation of the water into wine we discover that Jesus wasn't simply another prophet or holy man. He was God's "Beloved" and he holds the power to transform — to recreate and renew —the hearts, minds, and souls of his followers.

In the coming weeks of Ordinary Time, we will hear the stories of how this transforming and saving work, begun in Cana, changed the lives of Jesus' disciples, as we're invited to reflect on how that transforming power continues to shape us today.

Will you be a servant of the Lord?

Romans 12: 3-8

By our Baptism we are made children of God. We were made to love and serve God and each other in all we do. Happy New Year may 2022 be a better year than 2021.

This marks an election year for our local courts in May. I am asking you now to think and pray about taking an office in your court. This is how we grow in our knowledge of Catholic Daughters, get to know members locally and across the state.

Now this may be a scary proposition, that's why we pray and ask the Lord if this is how he would like to see you serve him. Know that if you say yes to the Lord, the Holy Spirit will be there to guide you along with past officers, your State Representative and The Tools of the Trade.

At your March meeting you will be electing a Nominating Committee of 3 to 5 court members. No member can serve more than 2 consecutive terms on this committee. The 3 to 5 candidates with the most votes shall be elected with the others as alternates according to rank of votes. The one with the most votes is the chairman or the committee may select its own chairman.

What are the duties of the Nominating Committee?

- 1. They shall meet to consider possible candidates for all offices. Always checking with current officers willing to serve another term or another office
- 2. They shall call each candidate and ask if they are willing to serve.
- 3. They shall submit to the local Court Regent the name of one candidate for each office.
- 4. If there is a vacancy, they can report that office open-please try to fill all offices.
- 5. The chairman shall report the slate of officers to the Court at the April Meeting.

So, if the Nominating Committee calls you, consider it an honor as they believe you are worthy of leading your Court in one way or another!

Happy New Year,

I hope you all had a merry Christmas celebrating Jesus's birthday with family and friends. Now we are into a new year. The time goes by so fast! I pray that you all have a blessed

goes by so fast! I pray that you all have a blessed new year and experience the love of Jesus throughout your day!! Jesus is always there for us, loving us and surprising us with new experiences and joys. We just need to be open to Him and what He has for us. He surprised me by putting a man in my life. It was the last thing I ever expected to happen, but it did. We have fallen in love and I am getting married on the Feast of Our Lady of Fatima in May. Yes, I am very excited!

Well enough about that, I want to share with you about state dues. The state dues are set by the National office. The year is divided into two 6-month periods. Those 6-month periods run from April 1 through September 30 and October 1 through March 31. At the end of each 6-month period, we get a statement from the National Office as to how many members each court has. This is why it is very important to keep the National Office updated on your membership. When someone passes away or resigns from CDA you need to let the National Office and the State 2nd Vice Regent (me) know of the changes in your court, so you are not being charged dues for women who are no longer members. The National Office deadlines are September 30 and March 31 each year.

Usually, the National Office sends out the National Due statements in October and April and we (the state) wait a month or two later, before we send out our statements for the State dues. That is why there is so much time from the end of the 6-month period to when you get the dues statement from the State. All dues should be paid within 30 days of the statement date and they do not need approval from the court to be paid. When the Regent gets the dues statement, she should give it to the treasurer, so she can get it paid. By getting both the National and State dues paid on time, it allows your local court to be involved in the voting of National and State Conventions. I hope this helps you to understand about how the dues work and the importance of keeping the national and state offices know of any changes in your local memberships.

Elections

Elections will happen at your May Court meeting.

- 1. A notice via email/ regular mail shall go out to all members at least 10 days prior to the election meeting stating:
 - Date, Time and Place of Election
 - slate of officers as submitted by the Nominating Committee
- 2. Nominations will be taken from the floor for all offices prior to the election.
- 3. Elections will be by ballot unless there is only 1 nominee for office, then the Regent may take a voice vote.
- 4. Each officer shall assume the office to which she is elected with or without installation 30 days follow-ing election.

Installation

Local Court installations shall take place no later than the regular September meeting. Remember to invite your State Representative in plenty of time to get it on their calendars as they oversee 4 or more Courts.

Wow that is a lot of information! Wishing all the ND Courts a Blessed New Year and Full slates of officers come May. May we all work together to be the hands and feet of Jesus to others in our Courts and beyond.

The rest of the presentations were about other female Saints and what they could teach us through their experiences. Their lives and devotion to Our Lord were very inspirational. Connie suggested that we give the advice of the Saints instead of our own advice. She also encouraged us to pray several times a day, even five minutes at a time. I am still working on that.

I felt fortunate to attend this retreat. We, the ND State Officers, were asked to lead the Rosary on Saturday afternoon. I found this a particular blessing. The whole weekend was a wonderful time to spend together as CDA Sisters.
