Mayor Comerford gave an overview of the millage rate and there was no discussion.

- Vote: to approve tentative Estimates of Revenue and Expense for the Fiscal Year Commencing on the 1<sup>st</sup> Day of October 2020 and Ending on the 30<sup>th</sup> Day of September 2021 (Annual Budget). Vice Mayor Block made a motion to approve the Estimates of Revenue and Expenses for FY 20-21 and Annual Budget. Commissioner Keim seconded the motion. Motion passed 4-0.
- Announcement of Date, Time, and Place of 2<sup>nd</sup> and Final Budget/Tax Hearing for FY 2020/2021, Town of Jupiter Inlet Colony. September 28, 2020, 7:00 P.M., via Zoom Virtual Meeting (see instructions above)
