**DATE:** Saturday May 25<sup>th</sup>, 2019  
**TIME:** 6:00 a.m. - 12:00 p.m. *ALL PARTICIPANTS MUST REGISTER AT THE MCKENZIE PAVILLION BEFORE PARTICIPATING.* After registering, participants may begin at 6:00 a.m. Saturday from any location on the lake.

**ENTRY FEE:** \$65.00 per boat (2 person team), includes grilled hamburger plate. (\$8.00 per plate for non-participants.) Meals served starting at 12:30 p.m.

**ENTRY DEADLINE:** Tuesday, May 21<sup>ST</sup>, 2019 (\$20.00 late fee per boat after May 21<sup>st</sup> ).

**REGISTRATION:** 5:00 – 7:30 p.m. on Friday, May 24<sup>th</sup>, at the McKenzie Pavilion in the recreation area.

**PRIZES:**

- 1) (Magellan Shirts) for each member of the 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place teams, determined by the total weight of five live fish.
- 2) Trophy and \$100.00 for biggest bass. Trophy and \$50.00 for 2<sup>nd</sup> biggest bass.
- 3) Cash prize of \$50.00 for most fish weighed in per team.
- 4) \$25.00 awarded for the biggest bass of each hour.
- 5) Bryan Marine will pay an additional \$100.00 prize to the winning team if the fish were caught from a boat purchased from them.

**RULES:**

- 1) Only CCWC lot owners who have paid the current annual dues, and their permitted guests are eligible.
- 2) All boats must be properly registered with CCWC, and have a registration sticker along with the lot number on the boat.
- 3) All CCWC rules and regulations must be followed.
- 4) \*\* Weigh all Bass, the Five (5) biggest fish will be counted for total weight.
- 6) Fish **MUST BE ALIVE** at weigh in.
- 7) All fish must be taken with artificial lures.
- 8) Fish may be weighed in at any time during tournament hours.
- 9) Fish weighed in will be released back into the lake.
- 10) Ties for team prizes will be broken by weight of the biggest fish.
- 11) Tournament Director, or his appointee will make final decision in all matters.
- 12) Upon reading these rules I agree to abide by them.
- 13) Upon signing the entry form, I release CCWC and its members of any and all liabilities incurred to my property or me.
