COVID-19 Guidance for Places of Worship and Providers of Religious Services

Some of the Illinois Department of Health guidelines Last Updated: 7/21/2020

<u>Congregate outdoors</u> Where weather and facilities permit, it is safer for worship and other activity to occur outdoors rather than indoors. Some best practices include: Congregants who are living together sit together, at least 6 feet apart from other congregants and groups. Wear face coverings. Refrain from singing and group recitation, which significantly increases the risk of transmission of the virus by projecting respiratory droplets. Consider pre-recorded music or other alternatives. If continuing with singing and group recitation, increase social distance to at least 10 feet between groups and ensure face coverings are worn. Restrooms should be regularly sanitized and have sufficient soap and hand sanitizer. Follow applicable guidance below for in-person activities. Congregate in groups of less than 50 people indoors. For in-person indoor services, the safest choice is to limit the number of people during a given service. Consider holding multiple services for multiple small groups, limiting to 50 in-person services to special events (e.g., weddings, funerals, baptisms), or limiting in-person activities to private prayer and worship. Some best practices include:

- Congregants who are living together sit together, at least 6 feet apart from other groups.
- Wear face coverings.

• Especially indoors, refrain from singing and group recitation, which significantly increases the risk of transmission of the virus by projecting respiratory droplets. Consider pre-recorded music or other alternatives.

• If continuing with singing and group recitation, increase social distance to at least 10 feet between groups and ensure face coverings are worn.

• Restrooms should be regularly sanitized and have sufficient soap and hand sanitizer. Follow applicable guidance below for in-person activities.

Singing and group recitation

Strongly consider discontinuing singing (and post signage discouraging singing), group recitation, and other practices and performances where there is increased likelihood for transmission from contaminated exhaled droplets. Modify practices by calling for silent recitation, using prerecorded music, or having a single singer in a separate area with speaker transmission. If these practices cannot be discontinued, strictly limit the number people reciting or singing, ensure physical distancing significantly greater than 6 feet between people, and consider installing plexiglass to provide physical barriers between people, or opt to celebrate these practices outside with significant physical distancing and other precautions. Use microphones to discourage loud speaking and provide a barrier (plexiglass) for the speaker.

Food and beverages

Discontinue offering food and beverages. Do not hold potlucks or buffet-style meals or events that increase the risk of cross contamination. If food and beverages must be served, provide items in single-serve containers (disposable containers whenever possible), and ensure congregants or others who are living together are seated together and more than 6 feet apart from others. Employees or volunteers serving food should wash hands frequently and wear disposable gloves and face coverings.



CROP WALK 2020

This year the CROP WALK will not be organizing an actual walk gathering. The area CROP program will be raising funds for the Church World Services this fall. St. Mark's will be collecting monies until October 1st.

<u>What does CROP stand for?</u> When CROP began in 1947 (under the wing of Church World Service, which was founded in 1946), CROP was an acronym for the <u>Christian Rural Overseas Program</u>. Its primary mission was to help Midwest farm families to share their grain with hungry neighbors in post-World War II Europe and Asia.

Today, we've outgrown the acronym but we retain it as the historic name of the program. CROP Hunger Walks are interfaith hunger education and fundraising events sponsored by Church World Service and organized by CWS local offices across the U.S.

Where do CROP Hunger Walk funds go? CROP Hunger Walks help to support the overall ministry of Church World Service, especially grassroots, hunger-fighting development efforts around the world. In addition, each local CROP Hunger Walk can choose to return up to <u>25 percent of the funds it</u> raises to hunger-fighting programs in its own community. CROP Hunger Walks help to provide food and water, as well as resources that empower people to meet their own needs. From seeds and tools, to wells and water systems, to technical training and micro-enterprise loans, the key is people working together to identify their own development priorities, their strengths and their needs something CWS has learned through some 68 years of working in partnership around the world.

Council Highlights from the August Church Council Meeting

<u>Treasurer's Report</u>: A copy of the July financials minus the total asset summary were provided. Income for the month of July was \$6,133 with expenses \$6,758 creating deficit of \$625. Year to date deficit \$9,142. An audit committee is mandated by our church constitution. A recommendation of potential audit committee members was discussed. Individuals will be approached to serve on this committee. Discussion also ensued surrounding having our annual financials audited. The bank previously provided this service to the church, but no longer performs. An individual was recommended and will be approached to complete an audit. Teller requirements were also discussed.

<u>Pastor's Report and Worship Plans:</u> Pastor continues to phone and send notes. The Health and Safety task force met via Zoom. It was decided to have 3 outdoor worship services in the church parking lot every other week in August (2nd , 16th , and 30th). Lifeline pantry items are being collected. No plans to come indoors are being made at this time. The Task Force will advise at the end of the month.

<u>Hospitality and Global Mission:</u> The Hospitality and Mission teams continues periodic phone calls to connect with the church family.

<u>Education</u>: Confirmation classes ended on Zoom and all have passed with one in need of help. The class will have a review in January and we hope to plan confirmations. No plans for Sunday school or other education for September as we are waiting to see how things work out for our area schools.

<u>Polo Council of Churches</u>: A meeting was held at Open Bible Church July 28th . St. Mark's did not have representation. Monday night community meals have been cancelled for fall. The grab and Go bag program at the Methodist Church had low numbers. Second Hand Rose is open, but very slow. The CROP walk will not walk but will have an online donation campaign this fall.

<u>Fellowship</u>: The Roast Beef dinner carry out curbside fundraiser is currently on hold due to Covid 19 and will be reassessed at the next meeting.

<u>Property:</u> Thank you to cleaning volunteers; Sara for June, Lisa for July, Amanda for August, Cindy for September, and Merla for October.

<u>Old Business</u>: Lori Christen has accepted treasurer duties. A motion was made and approved to compensate Lori \$420 8/1/20- 7/31/21 for additional treasurer duties.

<u>New Business:</u> Church Building Coronavirus Recommendations: The council discussed expectations for church related activities and community clubs/organizations utilizing the church for meeting purposes. St. Mark's will follow the Illinois Governor's guidelines during the pandemic. Council approved to allow groups (church and community) to meet as long as they follow current governor's guidelines, failure to abide by guidelines results in loss of privilege. Synod Pledge: St. Mark's pledged \$5,000 mission support dollars to the Synod and we are currently \$1,820 behind with the pledge due to the pandemic disruption. The Rockford Synod office is closed, with staff and the bishop all working from home. No action was taken, council will keep it as a future meeting agenda item.

Polo Council of Churches July 28, 2020

President David Poole called the meeting to order at 7:00 p.m. Attending: Pastor Luke Schier, Ron Bardell, Marla Buskohl, Marilyn Schwartz, Mary Williams, Rita Jacks and Sharon Miller.

Devotions by Pastor Luke Schier were from Corinthians 14:26 regarding Reconnecting and Building up (edify). Minutes from the May 26, zoom meeting were approved by a motion from Ron Bardell, seconded by Sharon Miller.

Treasurer Report: General Fund balance is \$4710.77 which includes \$1052 of Community Garden grant money. West Branch COB paid dues in July. The Hungry Neighbor checking account has a balance of \$892.56 after \$200 was paid to Dollar General for the Polo Food Pantry. Sent by Tom Cline—Treasurer's report was approved.

Second Hand Rose: Sharon Miller reported that a \$2500 stimulus check was received and income was \$2219.00 from March 21-June 1. The building rent has been reduced per the landlord and hopefully business will pick up as the summer progresses.

Summer Bible School: no report

Community Garden: Thank you to COB and all volunteers that help make this a success. Yellow wax beans, tomatoes, green peppers and beets have been harvested and given to Kidz Café and Polo Food Pantry so far this summer.

Kidz Café: Marla Buskohl reported that the grab n go food program was used this year as a revised plan for distributing food to children and their families. The outside shelter building at FUMC was used and volunteers were available to give out pre-packaged food to approximately 350 people. Thank you to all volunteers and those that gave monetary donations.

Due to the Covid 19 virus, all Community meals, vesper services and Polo Rehab communion services have been postponed until further notice.

The PCCC Christmas Basket project will be run by Faith Discovery Church this year. PCCC is happy to welcome Rod Benavidez as the new Pastor at Brookville/Elkhorn churches.

Public Alert COVID-19 Use of Cloth Face Coverings to Help Slow the Spread of COVID-19

How to Wear Cloth Face Coverings

Cloth face coverings should-

- fit snugly but comfortably against the side of the face
- be secured with ties or ear loops
- Include multiple layers of fabric
- allow for breathing without restriction
- be able to be laundered and machine dried without damage or change to shape

CDC on Homemade Cloth Face Coverings

CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacles), **especially** in areas of significant community-based transmission.

CDC also advises the use of simple cloth face coverings to slow the spread of the virus and help people who may have the virus and do not know it from transmitting it to others. Cloth face coverings fashioned from household ltems or made at home from common materials at low cost can be used as an additional, voluntary public health measure.

Cloth face coverings should not be placed on young children under age 2, anyone who has trouble breathing, or is unconscious, incapacitated or otherwise unable to remove the cloth face covering without assistance.

The cloth face coverings recommended are not surgical masks or N-95 respirators. Those are critical supplies that must continue to be reserved for healthcare workers and other medical first responders, as recommended by current CDC guidance.

Should cloth face coverings be washed or otherwise cleaned regularly? How regularly?

Yes. They should be routinely washed depending on the frequency of use.

How does one safely sterilize/clean a cloth face covering? A washing machine should suffice in properly washing a cloth face covering.


How does one safely remove a used cloth face covering?

Individuals should be careful not to touch their eyes, nose, and mouth when removing their cloth face covering and wash hands immediately after removing.


