## Waiver & Signature

Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement ("Agreement") For and in consideration of The Active Suncoast Foundation, Inc allowing me, the undersigned, to participate in the Frosty 5K and its pre- and post-race activities (the "Event"), I hereby agree to and make the following contractual representations pursuant to this Agreement: I hereby represent that I am at least eighteen (18) years of age and have full legal authority to complete this event registration on behalf of myself and/or any other party I am registering (the "Registered Parties"). If I am registering a child under the age of 18 or an incapacitated adult, I represent and warrant that I am the parent or legal guardian of that party and have the legal authority to enter into this Agreement on their behalf and by proceeding with this event registration and participation in the event, agree that the terms of this Agreement shall apply equally to all Registered Parties. I represent and warrant that I am in good health; I am in proper physical condition to participate in the Event and I have not been advised otherwise by a medical practitioner. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event, that I am responsible for my own safety and well-being at all times and under all circumstances while at the Event site. I acknowledge that participating in the Event and/or its related activities involves an above-average risk of personal injury and dangers which include, without limitation, the potential for serious bodily injury, permanent disability, paralysis and loss of life; loss or damage to equipment/property; exposure to extreme conditions and circumstances; contact with other participants, spectators, volunteers, animals or other natural or man-made objects; dangers arising from adverse weather conditions; imperfect course conditions; land, water and surface hazards; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the Event Organizers; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks"). I understand that if I chose to use headphones or other audio devices, I assume all risks associated with their usage. I acknowledge animals (except service animals in performance of their duties) are not permitted on the race course. I understand that these Risks may be caused in whole or in part by my own actions or inactions, the actions or inactions of other participating in the Event, or the negligent acts or omissions of the Released Parties defined below, and I hereby expressly assume all such Risks and responsibility for any damages, liabilities, losses or expenses which I incur as a result of my participation in the Event. I, on behalf of myself, my personal representatives, heirs and assigns, hereby fully and forever Release, Waive and Covenant Not to Sue, and further agree to Indemnify, Defend and Hold Harmless the following parties: The Active Suncoast Foundation, Inc; Marine Corps League Gulf Coast Det #643; Sarasota County; Sponsors; Advertisers; and each of their respective parent, subsidiary and affiliated companies, officers, directors, partners, shareholders, members, agents, employees and volunteers and assigns, and all municipal agencies whose property and/or personnel are used (Individually and Collectively, the "Released Parties"), with respect to any liability, claim(s), demand(s), cause(s) of action, damages(s), loss or expense (including court costs, defense costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the Event, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties. I further agree that if, despite this Agreement, I, or anyone on my behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities which may be incurred as the result of such claim. I hereby grant permission for Released Parties to use of my name, biography and likeness in connection with the Event, and also any publicity, advertising and promotion for the Event and future editions of the Event.
