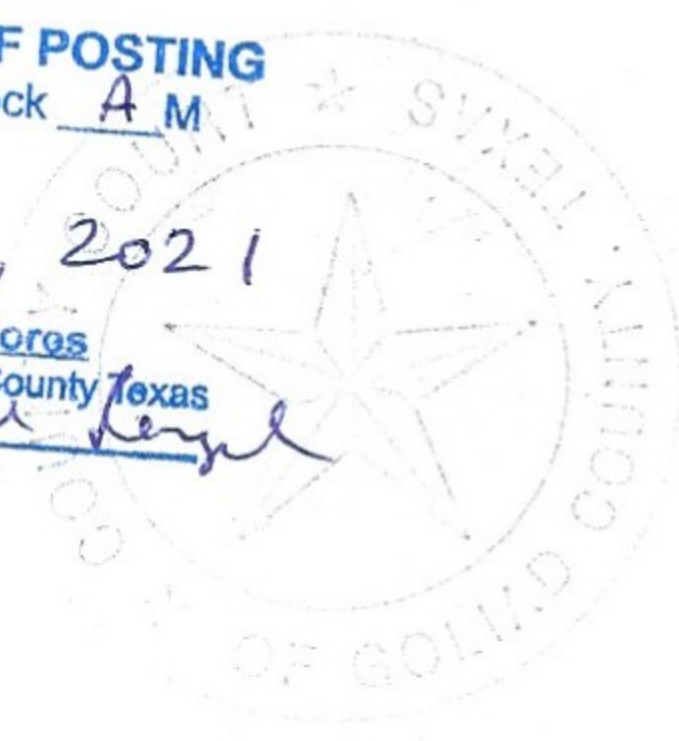

**Drilling and Operating Permit Hearing for Sahara Ranches**

Under Section 36.404 of the Texas Water Code, the Goliad County Groundwater Conservation District Board of Directors does hereby give notice of a public hearing to be held on Monday, June 21, 2021 at 5:00 p.m. at the Groundwater District Office, 118 S. Market St., in Goliad, Texas. The purpose of this hearing is to hear public comment on applications for an operating permit.

Permit No. 79-28-P-0107 for Sahara Ranches is located on 340 acres 14 miles west of Goliad on Fm 59 S. The use for this existing well would be for a sprinkler system on a 5-acre tract. The proposed 5 HP pump would be capable of producing 50 gpm and the requested amount of water is 2.15 ac/ft/yr. The proposed well will be replacing previously permitted well 79-28-P-0104 that will be plugged that was permitted for the same use.
