

First on the docket, is the **Belmar** parade, which is past history.







Graduating seniors have until Friday, April 17, 2015 at 5:00 PM to submit their applications and essays to qualify for one of two (2) scholarships offered by the New Jersey Vietnam Veterans' Memorial Foundation. The scholarships, each in the amount of \$2,500, will be awarded to high school seniors from New Jersey who plan to further their education either at a college or university or trade/technical school.

Winners will be notified in early May and will be awarded the scholarship on Monday, May 25, 2015 during the Memorial Day Ceremony held at the New Jersey Vietnam Veterans' Memorial.

To my brother and sister Vietnam veterans and friends of Chapter 12:

Many of you may know of my long involvement since about 1983 with the Chapel of Four Chaplains, now more commonly referred to as the Four Chaplains Foundation. The Foundation has encountered many hurdles over the past 7 – 8 years and is now moving forward under new, aggressive leadership, working from the historic base chapel aboard the historic Philadelphia Naval Shipyard. The Chairman of the Board is Captain Lou Cavaliere; US Navy (Ret.) and the Foundation's Executive Director is Mrs. Christine Beady of Philadelphia, who some of you may have met at various Chapel ceremonies over the past three years. The New Jersey State Council and Chapter 12, in conjunction with VVA Region II, have sponsored Chapel ceremonies at the US Coast Guard Base Chapel in Cape May, NJ; and, AVVA held several similar ceremonies there in the mid-2000s.

On Tuesday evening, 3 February 2015 (the 72<sup>nd</sup> anniversary of the sinking of the USAT Dorchester off Greenland), the Foundation held its 47<sup>th</sup> annual banquet to honor ordinary people for extraordinary acts of service. The attendance was a "sell-out" crowd, with many, many Vietnam veterans, most of whom are VVA members – especially many of our friends from Chapter 12 - as well as a few representatives of other veterans' organizations. Nearly all of the Chapters from New Jersey, and several from Pennsylvania, Maryland and Delaware, were in attendance. There were VVA members there I had not seen in at least ten years, particularly many old friends (and a few new ones) from Chapter 12.

One of the highlights was the presentation of the Foundation's Humanitarian Award to an old friend – Tom Minchin of Harrisburg, PA. It was an honor long overdue and righteously presented to Tom Minchin, a brother Marine.

And, two other awards were presented that evening – the Foundation's Gold Medallion. The Gold Medallion is presented for a lifetime of service to others, without regard for race, color, creed or ethnicity; and, which has had an international impact. It is considered the "highest" award that can be bestowed on an individual. One recipient was Ralph W. Galati of Wallingford, PA who had the "distinction" of spending fourteen months as a "guest" (POW) of the North Vietnamese in the infamous "Hanoi Hilton". Upon release from captivity, Ralph returned home, left the Air Force as a Captain and has "given back" over the past forty-plus years to all. He is currently the Director of Veteran Services at Saint Joseph's University in Philadelphia. He told some interesting stories while making his acceptance.

Oh, the other recipient: just an old Vietnam veteran from Chapter 12 named Paul Sutton, nominated by a brother Vietnam veteran by the name of Bob Baker from VVA Chapter 670 in Schulenburg, Texas. I won't bore you with what I had to say. I'm still "in shock" over having had received this significant honor.

Vietnam Veterans of America – principally Chapter 12 and the State Council - has been a leader in the Four Chaplains Foundation, of which all us should justifiably be proud. As we move forward into the 21<sup>st</sup> century, let's all pledge to keep the unique legacy of the Four Chaplains alive and well for the generations coming after us for at least next 172 years.

Dear Mr. Jones:

On behalf of the Military Order of the Purple Heart (MOPH), I wish to thank you for introducing H.R. 454 the "Military Retiree Survivor Comfort Act".

This legislation will authorize the surviving member, or other designated survivor, to retain the full month retired pay for the month in which a military retiree dies. It will relieve much of the stress that survivors are being forced to deal with such as an over payment, while having to deal with losing a loved one and the arrangements that must be made during their time of grief.

In 1996 Congress voted to allow survivors to retain the veterans last month pay for VA disability and pension payments. The military retiree survivors should have the same consideration.

MOPH supports this legislation and urges Congress to act on it.

# New Pentagon Chief 'Open to Reconsidering' Military Retirement System

KANDAHAR AIR FIELD, Afghanistan -- Secretary of Defense Ashton Carter said Sunday he is open to altering the military retirement system but would not want changes forced on current or former servicemembers.

A congressionally chartered Military Compensation and Retirement Modernization Commissionsubmitted proposals last month to lower personnel costs in the Defense Department. It recommended changes to entice troops to opt out of the current pension system, which gives substantial retirement pay to those who serve 20 years or more but none to those who serve less time. The panel suggested all troops be automatically given a savings plan account that would sock away 3 percent of pay along with a contribution from the military. The panel also recommended that Tricare health insurance be replaced with a range of private provider options.

When a servicemember asked Carter about potential changes at a troop talk at Kandahar Airfield in Afghanistan, Carter said: "I'm of course open to reconsidering the military retirement system. It's been around for a long time [and] it makes sense to take a look at it."

Saying he is studying the commission's report, he didn't comment on specific recommendations.

"What's critical here is that we have a system ... that will keep the all-volunteer force healthy in the future," he said

He said the retirement system should be attractive to potential recruits and give servicemembers appropriate incentives to either stay in the military or retire at a time that is best for them and DoD.

"That's the criterion that I will principally apply when considering these things," Carter said.

But he believes any mandated changes should only apply to those who join the military in the future.

"Any change we make [should] be one that those who are in service don't have to [accept] if they don't want to, because I don't want to breach our understanding with you at the time you joined. That's not fair," Carter said. "But we can make other alternatives available to those who may join in the future and also to those who are in now."



Veterans and some VA doctors say that the new "choice card" program, meant to reduce long patient wait times, is confusing and causing more stress. The choice card issued by the embattled Department of Veterans Affairs was meant to end long wait times for veterans after last summer's scandal revealed that those who fought for their country were dying while waiting for care. The card gives veterans who have been waiting more than 30 days for appointments or who live more than 40 miles from a VA facility the chance to see a private doctor.

But instead, some veterans say that when they attempted to use their card, the VA told them they had to live more than 40 "miles in a straight line, or as the crow flies," from their VA rather than Google maps miles, which makes the card harder to use. Several VA doctors e-mailed The Washington Post saying they themselves don't understand how to use the program

Another reader wrote in saying that her stepfather, Charles Schuster, who died in 2009, recently received a card in the mail, a symbol of an agency still seemingly in disarray. "Gave me a good laugh," she wrote.

So far, 27,000 veterans have made appointments for private care with their cards, the VA said last week. It's a fraction of the 9 million veterans who depend on the delay-plagued VA health-care system, the largest network of health centers and hospitals in the country.

"As far as I can tell, the choice card has created more confusion and aggravation than improving access to clinical care, though it did gain political points," said one VA primary care doctor, who says he's on the front lines of doing intakes. He spoke on the condition of anonymity because VA employees are not allowed to speak to the media without permission. But he said he and other doctors "are confused by the choice card system and don't understand how to implement it."

Another problem that veterans pointed to is that all veterans, whether eligible or not, get the card. Some are showing up in private emergency rooms and try to use the card only to find out it's not valid.

During a recent House hearing with VA Secretary Robert McDonald, Rep. Tim Huelskamp (R-Kan.) said the program needs to be totally revamped. The 40 mile "as-a-crow-flies" distance is a huge problem for his district, which has 63 rural counties and no VA hospital. Huelskamp co-sponsored a bill that would require the VA secretary to expand the Veterans Choice Act eligibility to better assist rural veterans by changing the 40-mile requirement to be based on actual driving distance instead of radius.

Additionally, the 40-mile criteria would apply directly to the type of care requested by the veteran — which means having a Community-Based Outpatient Clinic (CBOC) in the area would no longer prevent a veteran from choosing care at a local hospital if the local CBOC can't provide the necessary service.

He also reported that there are approximately 70 rural community hospitals in Kansas willing to fill that void, but under current VA restrictions, many veterans are unable to use those facilities.

"Refusing to allow these men and women to choose their local hospital and doctor and forcing them to drive huge distances in simply unacceptable – they deserve better," Huelskamp said.

He also said that when veterans were calling their hospitals for appointments, they were not asked for or advised to check whether they could use their cards.

Other political leaders and veterans advocacy groups are questioning how hard the VA is really selling the choice card.

The VA's release of the choice chard numbers is at the heart of a controversy over <u>President Obama's 2016 budget</u>, which asks for authority to reallocate funds from the temporary \$10 billion program that Congress established last year to help veterans struggling to obtain care at strapped VA clinics. VA officials say they want the "flexibility" to fund other projects, such as reducing the claims backlog.

House Veterans Affairs Committee Chairman Jeff Miller (R-Fla.) has roundly rejected the plan, calling it a "complete non-starter, which I will not support."

Pete Hegseth, CEO of the conservative advocacy group Concerned Veterans for America, has told the media that veterans get the run-around when they call the VA for permission to use the choice card.

"The VA is making a concerted attempt to undermine anything that looks like choice," he said.

Retired Lt. Col. Jack Martins, who has hearing loss from Vietnam, said that he couldn't use his card because, even though his nearest facility in Virginia is 60 miles away, that mileage is using Google Maps, not "mileage in a straight line."

"I called twice, just to verify this information. Makes you wonder why they sent out the mailing before fixing this problem," said Martins.

Former Army private Ian Albright receives VA benefits and medical care, and his father, Tim Albright, is helping him access his care. He said veterans are scared to use the choice card for various reasons, including too much paperwork, delays getting approval by VA physicians and fear of never being reimbursed.

"It all sounds like governmentese, for no one is going to approve payment of your care ahead of time. It's a bunch of booby traps and trap doors," he said. "There's nowhere you can go to get quick answers from the VA. And I see this as a life-and-death dilemma for vets and family members who really have no clue how the system works."

While he has nothing but praise for the staff and management of the VA Medical Center in Saginaw, Mich., where his son receives treatment, he wishes getting to that treatment was easier.

Albright worked for the federal government in Social Security for 34 years and offered a solution, which he e-mailed about and left a message on McDonald's cellphone.

The idea, he said, would involve issuing temporary Medicare cards to veterans who meet the "choice criteria." The benefits of this plan include "little or no paperwork for veterans and the VA would save additional administrative and personnel expense since the Medicare claim system is already in place."

"How are private doctors going to send these choice card bills in? You are talking about training tens of thousands of people, but if you use Medicare – everyone knows how to handle Medicare," he said. "All energy and efforts should be to provide immediate medical care to those in backlogs or on waiting lists."

Modern politicians have found a new level of success in cashing in on the Presidency, resulting in untold wealth.

Good old Harry Truman was correct when he observed, "My choices in life were either to be a piano player in a whore house or a politician. And to tell the truth, there's hardly any difference!
