

**TAX LEVY ORDINANCE**  
**ROAD DISTRICT**  
**ORDINANCE No. 2020-005**

An ordinance levying taxes for all town purposes for Collinsville Township Road District, Madison County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of Collinsville Township, Madison County, Illinois as follows:

SECTION 1: That the Highway Commissioner of Collinsville Road District on December 8, 2020 does hereby determine and declare that the sum of **One Million, One Hundred Fifty Nine Thousand, Five Hundred Fifty Four Dollars (\$1,159,554)** are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Road District as required by state or voted by the people in accordance with the law, for such purposes as:
