## Lincoln Park Swimming Association – Rules of Conduct

The Lincoln Park Swimming Association strives to provide a safe, family orientated environment for all pool members to enjoy. To ensure that this type of environment exists, pool members are advised of the following rules of conduct that all pool members or guests of members are required to follow when they are on the Lincoln Park Swimming Association property.

Pool members or guest of members are required to refrain from:

- Disruptive behavior including but not limited to the use of profanity, obscenity, excessive physical
  contact, inappropriate displays of affection or behaving in a way disruptive to the normal and orderly
  operation of the pool or pool grounds.
- Wearing bathing attire considered to be inappropriate for a family environment or use of the pool facilities. Proper bathing attire must be worn at all times.
- Verbal abuse or harassment of the pool manager, assistant pool manager, life guards or other pool members.
- Theft of Lincoln Park Swimming Association property, or property belonging to other pool members.
- Possession or use of tobacco by minors under the age of 18 on Lincoln Park Swimming Association property. Persons over the age of 18 may smoke at the designated area outside the main pool building. Smoking inside the fenced area of the pool and the pool entrance is prohibited.
- Destroying or defacing Lincoln Park Swimming Association property or property belonging to other pool members.
- Fighting (physical contact meant to do harm to a pool employee or other pool member).
- Being under the influence of, using, or possessing illegal drugs or drug paraphernalia on Lincoln Park Swimming Association property.
- Being under the influence of, using, or possessing alcoholic beverages on Lincoln Park Swimming Association property except for pool events as approved by the pool board.
- Entering Lincoln Park Swimming Association property when under a law enforcement restricted activity program such as wearing a tracking bracelet.

All members are required to present their membership card to enter the pool. Children under the age of 10 must be accompanied by a parent or guardian or a babysitter 14 years of age or older, who has been designated by the parents.

All members are required to review, acknowledge, and adhere to the Pool Opening Safety Plan per the CDC guidelines and the liability waiver.

Pool members who do not comply with the listed regulations will be asked to leave Lincoln Park Swimming Association property immediately. Where appropriate, in the sole discretion of the pool manager or assistant pool manager, law enforcement officers may be called to assist in resolving the problem.

If appropriate, individual incidents involving failure to comply with the listed regulations will be reviewed by the Lincoln Park Swimming Association Board. If deemed necessary, pool members involved in the incident may have their unused portion of seasonal dues returned to them, and they will no longer be members of the Lincoln Park Swimming Association.
