Nancy Thomas's early studies were at the Torpedo Factory, Alexandria, VA and The Corcoran School of Art, Washington, DC. Later she attended Northern VA Community College earning an Associate of Arts Degree. While in school, a travel study tour of Italy, prompted Thomas to take up watercolor. This became her choice of medium for 15 years. Upon moving to the Eastern Shore in 1994, she continued studying with Jeanne Ranney Smith at the Dorchester Art Center in Cambridge while also participating in portrait and life drawing at the Academy Art Museum.

Nancy has been an active member of the art community and a gallery owner of The White Squirrel Gallery, Queenstown and currently a Partner in The Artists' Gallery in Chestertown. She has participated in setting up and running the Local Color Show for 15 years. Thomas is a juried member of Baltimore Watercolor Society, the Washington Watercolor Association and The Working Artists Forum (past president). Thomas had a previous career in dance and has worked as a self-employed artist her entire adult life.

"Art at Home" KIFA Members' are also invited to bring in **one** 2D any medium piece and special award(s) will be given best representing the theme: from a still life indoors, to garden scene, view through your windows inside and out., etc. **There will be no extra charge**

Guidelines: All work must be original, created within the last three years, **not previously shown at KIFA** and must not infringe upon any copyright. Reproductions are not accepted. Sculptures must include their own base or fit on a KIFA pedestal. Sculpture artists must be prepared to assist in placing their work in the gallery. Maximum size including base is: 6' high x 3' wide and deep. **2-D works must be dry, suitably framed, wired and ready to hang.** No saw-tooth hangers. (Artwork not wired properly will not be accepted.) Maximum sized framed 40" x 40". All works on paper under glass, should have no exposed edges. We will accept sealed water media without glass.

KIFA reserves the right to reject works deemed unsuitable. All entered works must remain on display through the end of the show. Reasonable care will be taken to ensure the safety of your artwork. KIFA is not liable for loss or damage to artwork.

KIFA's commission on all sales is 30%. KIFA reserves the right to use images of the winning artwork for up to eighteen months.
