"The Chinese use two brush strokes to write the word 'crisis.' One brush stroke stands for danger; the other for opportunity. In a crisis, be aware of the danger-but recognize the opportunity." So said John Kennedy in a speech in Indianapolis in 1959.

As we view the president-elect's picks for cabinet positions, we are aware of the danger, and we know we are facing a crisis. Tom Price, nominated for Health and Human Services, has advocated changing Medicare from a defined benefit plan where coverage is guaranteed to a defined contribution plan, giving seniors a voucher/coupon for a set amount of money to purchase their own private insurance. That coverage may not be guaranteed. Andrew Puzder, a fast-food CEO, and choice for labor secretary, wrote a book critical of business regulations, the minimum wage, and labor unions. Betsy DeVos, a fellow billionaire, proposed by the president-elect for education, has promoted charter schools, private schools, and desires to privatize public education. These are but a few of the nominees that appear to be at odds with the cabinet positions to which they are being nominated.

Yet, as much of a danger that these picks reveal, there may be opportunity lurking. For instance, if Price proposes any moves to undermine Medicare or even social security under the guise of 'modernizing' the program, he may be met with an outcry from seniors and a subsequent introduction of real reforms by the opponents of such draconian measures. Those real reforms may not get traction yet, but they set the stage for a change in congressional control...and future real reforms. Moreover, the imminent repeal of the Affordable Care Act - ~Bill Spreter, 2<sup>nd</sup> VP and Vote/Cope Chair

will engender a great debate and stories of patients losing coverage, not to mention how it increased Medicare solvency by a decade.

Another opportunity is found in a labor secretary, Puzder, if confirmed, who may oppose any significant increase in the minimum wage, voice opposition to labor unions and open the door to unfettered business deregulation. The more vociferous and outspoken, the more opposition that secretary will encounter. Labor will organize to oppose such moves.

Finally, a privatizing firebrand such as Betsy DeVos may have her hands full with the opposition of our two major national unions as well as several million public school teachers whose experience in the classroom far outweighs her ideological opposition to the concept of a free public school system in America. The education secretary may indeed win many battles in her quest to free America from public schools, but the chaos that will ensue may backfire over time.

It's true that this outlook may be "pollyannish", but in this crisis, if we are aware of the danger, become outraged at the danger, organize, support our union and oppose radical changes in the ACA, Medicare, social security, labor rights, and our school system, we will seize the ' brush stroke' of opportunity to benefit our nation.

# From the President's Desk...

#### We've Been Had by ALEC!

ALEC (American Legislative Exchange Council) is a well-funded What is ALEC? organization, which operates outside of the political parties. ALEC is a "corporate bill mill," which groups conservative Republicans and corporate billionaires together to write legislation. Its existence was virtually unknown until 2010, when, by accident, a reporter happened to stumble upon a meeting of the group. ALEC meets in secret locations to draft legislation designed to limit the role of government, and hence direct more money into corporate pockets. The draft legislation is actually discussed/written at these meetings. The Republican Legislators then fan out to carry the drafts back to the respective state houses where they are introduced state by state. And frequently become (bad) law.

Why ARE We Bothering with ALEC? ALEC has molded American politics and public opinion and, in large part, engineered the Trump victory. Working for a decade with a razor-like focus on "a state by state strategy," note the restrictive voter access laws popping up, increased attacks on virtually every public institution from schools to Medicare, anti-environment and anticlimate attacks.... This is ALEC. ALEC is beholden to no one except the Koch Brothers and the Corporate Billionaires who use ALEC to further enrich themselves. The Koch Brothers, big investors in pipe lines and fossil fuels, have spawned the anti-environment legislation coming out of STATE houses, sponsored by state legislators who are ALEC members. Hydrofracking is one such contentious issue, a damaging process supported by the next President and ALEC.

How is ALEC Successful? ALEC is well funded by the infamous Koch Brothers. Additionally, corporations "pay big bucks to play," i.e. to get a seat at the table to draft/write legislation. Using their "state by state strategy", 31 of our states have Republican Governors, 18 Democratic and 1 independent. This has permitted Republican gerrymandering of these states, making it near impossible for Democrats to win LOCAL offices. That is where ALEC's focus has been. The Koch Brothers were not particularly thrilled with candidate Trump. (Pence, however is a known ALEC supporter.) Despite that, ALEC pressed hard in the recent election to fund the "down ballot" offices and the Democrats across the country took a bad beating!

What are ALEC's Goals? Repeal ACA (Obamacare), restrict voter access, scale back public pensions, destabilize unions, loosen environmental regulations, institute charter schools, and privatize Medicare and Social Security.
