This committee did an excellent job when we met in Salt Lake City the day of the annual meeting with the Bishop. I am excited to report that the Bishop stated we will receive our usual donation from the Diocese for our organization. He was very supportive of all that we do in our affiliates and our deaneries. The Bishop had many great suggestions for the convention next year, which paralleled the recommendations from the Woman of the Year committee. He was very animated in his discussion and continued to stress that we need to bring "fun" into our convention and our meetings, to celebrate being together in all that we do. I thanked the Bishop for travelling to Arlington, Virginia to attend the NCCW Convention and participate in the Mass and witness the installation of our own Pat Voorhes as NCCW President, and Amy Kennedy, as NCCW Secretary. I also thanked him for our September DCCW Convention and his participation at the Vigil Mass and the banquet for the Women of the Year. He has offered the use of the busses from the Madeleine School, to transport women to and from the hotel during the convention in April, in conjunction with the use of busses from Judge Memorial. Preparations are already in the works for speakers for April, when we will highlight our Service and our Spirituality Commissions. I am waiting for confirmation from the keynote speaker, whom I hope to be Dan Misleh, from the Catholic Climate Covenant based in Washington, D.C. Dan spoke at the WUCWO (World Union of Catholic Women's Organization) conference. That conference took place the day before our NCCW Convention in September of this year. He was amazing and so very interesting to listen to with his knowledge of global warming and our environment. Our theme for the convention will be "A Vision for the Future", which was the theme for the national convention. I hope to focus on the future of our world, our environment, and the vision we need to have for generations to come.

Our Immediate Past President, Casey Pond, has the duty of contacting and searching for people to fill the offices for DCCW next April. She is also blessed with the duty of finding a new San Francisco Province Director from our Salt Lake Diocese.
