**ANNOUNCEMENT**  
**Tribal Court Judge Peacekeeper**  
**On a Per-Hearing Basis**

**Purpose:** The Tribal Judge serves as the primary judicial authority of the Craig Tribal Association, responsible for overseeing and administering justice within the tribal court. The Judge is expected to adjudicate cases fairly, uphold the sovereignty of the tribe, and ensure the protection of individual rights and tribal laws.

**Key Responsibilities:**

1. Preside over civil, criminal, and family law cases brought before the tribal court.
2. Interpret and apply tribal laws, ordinances, and regulations in all cases.

9. Provide guidance and oversight to the Tribal Court Clerk and other court personnel.

2. Extensive knowledge of tribal, federal, and state law, particularly as they apply to tribal sovereignty and jurisdiction.
3. Experience serving the government in a legal capacity.
4. Strong ethical standards and commitment to justice, fairness, and integrity.
5. Excellent communication, analytical, and decision-making skills.
6. Ability to maintain confidentiality and handle sensitive matters with discretion.
